Cm. Gutierrez spoke on the importance to make a decision, since the developers are losing money while the item keeps getting tabled.

Mr. Selman expressed his concern regarding this item, he requested for council to table the item and bring back in the next city council meeting.

MPT Vidal Rodriguez stated that there was no reason to insult or belittle staff and their recommendation to approve the zone change.

Cm. Dr. Martinez asked Planning Director Orlando Navarro, if any traffic study was implemented before agreeing to recommend the zone change.

Orlando Navarro Planning Director stated that prior to supporting the recommendation of the zone change, Traffic director was asked several questions regarding the traffic issues within the area. According to Mr. Navarro, Traffic director stated that there were none traffic issues in that area.

XI. INTRODUCTORY ORDINANCES

- 3. Authorizing the Interim City Manager to execute a lease agreement renewal with Securitas Security Services USA, Inc., as a sole source as per a Customs and Border Protection approved security contract, for approximately 120 square feet of office space and an exclusive office entry lane for approximately 1,020 square feet at Juarez-Lincoln International Bridge (Bridge II). Lease term will be for one
 - (1) year commencing April 1, 2022, and ending on March 31, 2023. The monthly rent will be \$5,400.00. The lease may be terminated by either party with a thirty (30) day notice.

- 4. Authorizing the Interim City Manager to execute a land lease agreement between the City of Laredo ("Licensor") and U.S. Customs and Border Protection as ("Lessee"), for ground space at 202 N. Stone Ave, Laredo, Webb County, Texas, for the continued maintenance and operation of a communications tower site. Site is approximately 20 feet by 20 feet equaling 400 square feet in size and commonly known as the "Slaughter Park RVSS" tower site. Term of the lease is one (1) initial term of 12 months, commencing October 1, 2021 and ending September 30, 2022, with one (1) additional four (4) year renewal option and three (3) separate and successive five (5) year renewal options. The annual fee will increase from \$1.00 to \$12,000.00.
- 5. Authorizing the Interim City Manager to execute all necessary documents to purchase the "surface only" of a 39.123 acre of land, more or less, being all of a 109.609 acre tract recorded in Volume 1210, pages 464-469, official public record of Webb County, Texas, lying within Porciones 23 and 24, Webb County, Texas for the amount of \$1,500,000.00. The City of Laredo will do all the necessary due diligence for this property. Funding is from the 2017 Sewer Revenue Bond.
- 6. Authorizing the Interim City Manager to execute the renewal of a lease agreement with Webb County for its Head Start Program for the following parcels of land, at their current rate for a one (1) year term, as referenced below:

Leases will be renewed for a one (1) year term with an option to renew for an additional term of one (1) year at a new adjusted rate based on the Consumer Price Index (CPI), with the exception of "Jesus Garcia Head Start" properties which shall be a month-to-month lease.

7. An Ordinance of the City of Laredo, Texas, amending Chapter 2, Article II, Division 6 (pay administration), of the City of Laredo Code of Ordinances, specifically section 2.87(c)(12)(a), by providing an adjustment to the existing wage schedule to the spread between all grades; providing for a repealing clause; providing for a severability clause; and providing for an effective date. The annual estimated cost for the table schedule is \$1,550,869.00, and the current fiscal year estimated cost is \$954,381.00. Funding will be available in each corresponding City funds.

8. Orlando Navarro stated that if he would bring up the corrections made to district IV, it would only bring up more issues with other districts.

Cm. Torres requested to go over the corrections while using Google maps to obtain a better picture of the changes made.

Orlando Navarro presented the corrections made to district IV, as well as the changes made to all other districts.

Cm. Cigarroa expressed that she felt uncomfortable with all the changes that were made to her district, she stated that according to the City Charger the district should stay as compact as it was prior to the redistricting.

MPT called for public comments.

Esteban Rangel, resident of District II expressed his concern in regards to the new changes that were made to the district. Mr. Rangel stated that 90 percent of district II had been chopped off. Mr. Rangel questioned why district II was the only district being cut off with such a big portion.

Orlando Navarro stated that the changes made to district II were selected and approved by the Redistricting commission.

- 23. Consideration to award contract to vendor Convergint Technolgies LLC, for airport security systems and related customer support program for the Laredo International Airport for an amount of \$307,952.00. This service will be utilized on an annual basis for preventative maintenance on security systems using Omnia Partners cooperative pricing under contract No. R170502. The term for this contract shall be for a period of five (5) years beginning on the date of its execution and subject to future appropriations. Hubpoint has presented a strategic approach on promoting, researching, and developing, initiatives which will encourage and attract more air cargo activity for the Laredo International Airport. The term of the contract shall commence on the date of its execution and end on September 30, 2022. Funding for this contract is available in the Airport Fund.
- 25. Consideration to amend contract for professional services with RS&H, Inc., San Antonio, Texas, to include a fuel farm development project for an amount not to exceed \$27,000.00 for the Laredo International Airport. Professional services with RS&H Inc. were approved on May 7, 2018 for an amount not to exceed \$116,138.81 for preparation of a design analysis report for the construction of the Department of Homeland Security facilities to include a Border Federal Integrated Training Center and a U.S. Customs and Border Patrol Air and Marine Facility located at the Laredo International Airport. The addition of the fuel farm development will not impact the approved amount of \$116,138.81. The amount will remain the same, but \$27,000.00 of the funds will be allocated to the fuel farm development. Funding is available in the Airport Construction Fund.

Authorizing the Interim City Manager to approve a sub-lease between SBA Properties, LLC., as Lessee, and the U.S. Drug Enforcement Administration, as Sub-Lessee. The lease between the City of Laredo, as Lessor, and SBA Properties, LLC., as Lessee, was approved by Ordinance No. 2005-O-033 on May 2, 2005. Subleasing is allowed as per Section 36 of the agreement, with the Lessor's written consent; such consent shall not be unreasonably withheld. The position of the Deputy City Manager shall be held by qualified persons, appointed as provided by the Laredo City Charter and personnel policies. Qualifications, duties, and responsibilities of the Deputy City Manager shall be subject to the sole approval of the City Manager, Interim or Acting City Manager.

(a) <u>Assistant City Manager.</u> There is hereby created the office of Assistant City Manager. The office shall include at least two (2) Assistant City Managers who shall be appointed and removed at the sole discretion of the City Manager, Interim or Acting City Manager. The position of Assistant City Manager shall be subject to budgetary funding by the City Council as may occur prior to or subsequent to this section. There may be more than two (2) budgeted positions of Assistant City Manager as may be necessary to further city business and interests. The position of the Assistant City Manager shall be held by qualified persons, appointed as provided by the Laredo City Charter and personnel policies. Qualifications, duties, and responsibilities of the Assistant City Manager shall be subject to the sole approval of the City Manager, Interim or Acting City Manager.

ORDINANCE NO. 2022-

AN ORDINANCE OF THE CITY OF LAREDO, TEXAS, AMENDING AND REVISING CHAPTER 2, ARTICLE II, DIVISION 1, SECTION 2-19(a)(b) OF THE CODE OF ORDINANCES CONCERNING APPOINTMENT AND REMOVAL OF THE OFFICES OF DEPUTY CITY MANAGER AND ASSISTANT CITY MANAGER; PROVIDING FOR A CUMULATIVE CLAUSE; PROVIDING A

SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City of Laredo is a Home Rule City acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, Section 4.01 of the Laredo City Charter provides the City Council may by ordinance establish City departments, offices or agencies in addition to those created by the Charter and may prescribe the functions of all departments, offices and agencies; and **WHEREAS,** the City Council desires to clarify the appointment and removal of the offices of deputy city manager and assistant city manager.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS THAT:

Section I. The City of Laredo Code of Ordinances, Chapter 2, Article II, Division 2, Section 2-19(a)(b) "Deputy City Manager and Assistant City Manager" be amended and revised to read as follows:

Sec. 2-19. - Deputy City Manager and Assistant City Manager.

- (a) Deputy City Manager. There is hereby created the office of Deputy City Manager. The office shall include one (I) Deputy City Manager who shall be appointed and removed at the sole discretion of the City Manager or Interim or Acting City Manager. The office of Deputy City Manager shall be subject to budgetary funding by the city council as may occur prior to or subsequent to this section. There may be more than one (I) budgeted position of deputy city manager as may be necessary to further city business and interests. The position of the Deputy City Manager shall be held by qualified persons, appointed as provided by the Laredo City Charter and personnel policies. Qualifications, duties, and responsibilities of the Deputy City Manager shall be subject to the sole approval of the City Manager or Interim or Acting City Manager.
- (b) Assistant City Manager. There is hereby created the office of Assistant City Manager. The office shall include at least two (2) Assistant City Manager who shall be appointed and removed at the sole discretion of the City Manager, or Interim or Acting City Manager. The position of Assistant City Manager shall be subject to budgetary funding by the city council as may occur prior to or subsequent to this section. There may be more than two (2) budgeted positions of Assistant City Manager as may be necessary to further city business and interests. The position of the Assistant City Manager shall be held by qualified persons, appointed as provided by the Laredo City Charter and personnel policies. Qualifications, duties, and responsibilities of the Assistant City Manager shall be subject to the sole approval of the City Manager or Interim or Acting City Manager.

Section 2. This ordinance shall be cumulative of all provisions of ordinances of the City of Laredo, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

Section 3. It is hereby declared to be the intention of the City Council that the phrases,

clauses, sentences, paragraphs and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Section 4. The publishers of the City Code of Laredo, Texas are authorized to amend said code to reflect the changes adopted herein and to correct typographical errors and to index, format and number paragraphs to conform to the existing code.

Section 5. This Ordinance shall take effect immediately upon passage.
