45. Presentation by the police consulting firm, Murphy, Mayo and Associates concerning the status on the implementation of the Community Oriented Policing Services (COPS) Program with possible Executive Session as authorized by Texas Government Code Section 551.074 to discuss upper level management positions.

Mr. Patrick Murphy and Dr. Mayo read a progress report before the City Council.

(Note: No report was made available to the Office of the City Secretary for public inspection and availability.)

Cm. Casso said that according to the background communication Murphy and Mayo have been working with the city's Police Department to improve its morale and efficiency and it states in this report that a cornerstone of this plan has been the implementation of community oriented policing services. He added that this may be true, but he also believes that a cornerstone to this plan is the removal of the Chief of Police. That maybe they would have to go into executive session to discuss this because he has serious problems with this. It was his understanding that they were coming here to give the Chief of Police an evaluation of his performance based on his relationship with the top command and that maybe they should go into executive session to discuss upper management positions.

Mr. Murphy stated that they have worked with the Chief of Police, the Assistant Chief, the Patrol Captain and others in the department and they have received strong cooperation and support from all levels starting with the Chief of Police. They have had intensive debates about some of the recommendations and they do not expect the Chief or any of the top command to immediately accept community policing when they have been functioning under a different principle for so long. They are having questions raised about it, they did have debates and discussions and at times it requires thinking about the issues for a few days.

Mr. Murphy went over the areas that were raised at the beginning which were fair and equitable discipline and the issue of fairness on the assignments of overtime. He added that both issues have been addressed, a new disciplinary procedure is now on effect where a board hears the charges. Recommendations have been made for dealing with the assignments of overtime and the most equitable manner that

can be developed. The Chief has indicated that the procedure is in the process of being implemented. The issue of morale was raised and in his many year in police work he does not think there ever was a day that morale wasn't the highest or the lowest it had ever been, and that he thinks it is of the nature of a Police Department. The very nature of the work generates that, the enormous power and authority that every police officer has, the discretion that an officer operates with in making powerful decisions even to the point of the taking of a life, and working under those extreme pressures on his tour of duty. There will be times where there will be differences of opinion which also affect morale, but they are confident that as they are working with the department and improving disciplinary procedures and working with the police association he believes there is a positive spirit developing and is optimistic that whatever the problems were they are beginning to be corrected.

Cw. Moreno asked at what point are they to see some results.

Mr. Murphy replied that he thinks in thirty (30) days, that they will hear from the constituents in the neighborhoods. He added that it will take time, but that the officers will be visiting households, they will be attending community meetings or block clubs, and he thinks that in three months you will begin to see significant favorable reaction in the community and he firmly believes that within six months they will begin to see an impact on crime and orderliness in the neighborhood, and in solving some of the problems that might be conducive to crime.

Cw. Moreno asked who will monitor the progress and make recommended adjustments?

Mr. Murphy replied that they will be working with the project through June under the current contract and the Assistant Chief is in charge of it under the direction of the Chief of Police.

Cw. Moreno asked if they will get to see an organizational chart?

Mr. Vargas replied that they have already developed rosters, so they know which officers will be assigned on the concepts of community policing.

Cw. Moreno asked what recourse will exist if some of these persons are not able to do the job?

Mr. Murphy believes there was a probationary period of one year.

Cw. Moreno stated that they have asked the department to encourage officers to take college classes and she hears that

somehow staff will not work with their schedules in order for them to take college courses.

Mr. Murphy stated that this schedule will permit them to go to college, previously they rotated monthly and it was difficult for them to take the courses.

Cm. Casso asked what the average experience of the patrol officers is and wanted to hear from the President of the Police Association so that council could hear how the morale is out there, because he does not think its getting better. He added that he thinks they are dancing around the problem saying that the community policing is the answer to the problem, but that the problem is with leadership and that the top command is still split.

Mr. Murphy stated he has been at this business for over 50 years and has visited many police departments and that he was frankly deeply concerned that there was a police department in shambles like it was described to him. He admits that he went into that department expecting to find it. He added that police departments like other organizations are less than perfect, there is never a perfect department. It is not easy work from the youngest rookie to the chief and dealing with people's problems, dealing with danger, crime and disturbed people is very difficult work and is understandable to him that tensions do exist from time to time. Having gone into the department expecting to find very serious tensions and divisions, he must tell the council that he is impressed by the professionalism of people from top to bottom in the department from members of the association and its leadership through all of the ranks and branches of the department. It is not perfect, he can see that there are tension when the Police Chief has to deal with disciplinary problems or problem employees, it's not easy and not always do you make friends, being Police Chief is not a popularity contest. knows that this chief has had to deal with very serious personnel problems in the beginning of his tenure and he still has some of those problems and the best he can do is report his observations as objectively and honestly as he can, the department is far from perfect, but he is impressed by what he interprets to be a willingness to change and accept change. He is surprised at the level of willingness because he has met very strong resistance to community policing and other changes in many departments. The only thing he can offer is his own observation and to give council his honest opinion and assure them that they will continue to work with that attitude of calling the shots as they see them and offering the best they can.

Cm. Casso asked what is the average experience of the patrol officers that we have right now?

Mr. Murphy answered that between four (4) and five (5) years is the experience of a patrol officer.

#### X. COMMUNICATIONS

a. Mayor Ramirez congratulated the award winners and recognized all participants in the "Make A Difference Day" contest.

Joe Garza, Recreation Superintendent of Parks and Recreation, explained their efforts, stated there were 1,500 participants and recognized the youth groups with Certificates of Appreciation and presented three prize awards to the top activities.

b. Mrs. Marcia Jovel spoke on an incident she encountered on December, 1995 while she was attending a UISD Board Meeting at United South High School which she reported to the UISD Police. That same week she was called by more friends that gave her more details about the incident which she decided to bring to the Laredo Police Department. On January 23, 1996 she went to speak to Chief J.L. Martinez on this issue and since he was not present she spoke to Captain Hale. She gave him a full report on the incident and he said that he had no problem with her filing another report with the Laredo Police. He informed her that all UISD related incidents had to be filed with UISD Police. Upon her insistence that her family needed police protection in the event of any future threats he advised her to contact the District Attorney's Office which she has done so and is awaiting word from them. She said she needs their advise as what her rights are. Her house nor her family are in the jurisdiction of UISD therefore, she is requesting that the Laredo Police take care of her case immediately. Because of the nature of her position and involvement in the activities of "United for Education" she is involved in activities where she has received seven annoying calls, nevertheless, she is committed to education is committed to continue. She requested advise

and help, secondly she requested that he request be recorded so that if anything were to happen to any member of her family and her home due to negligence on the part of the City Police, she will press charges against the city police. She requested that Chief Martinez or the legal staff to continue the investigation by one of the staff members whose computer was broken into and who decided to file her complaint with the UISD Police who also filed another with the city police. She was informed that the Laredo Police was going to investigate this case and questioned if this case would be pursued by the city police and by whose authority and validity of the above action in the Laredo Police.

Mr. Vargas, City Manager, stated that it does appear to be a jurisdictional issue and from what he is able to gather a lack of confidence in that jurisdiction on her part to follow up on the issue. What they can do is consult with our City Attorney with regards to what the jurisdiction is and what it is that the city can or cannot do with regards to another political jurisdiction that does have a law enforcement agency and what our jurisdiction would be.

Police Chief J.L. Martinez stated that he had advised Mrs. Jovel that the only thing that we need was to notify Chief Wintheroth about the follow-up investigation in that particular case. He also explained to her about the jurisdiction that they have on all UISD schools, but that whatever crimes or harassment happen on her residence can be reported to the Laredo Police Department which they will investigate.

Fausto Sosa, City Attorney, stated that the City of Laredo has original jurisdiction within the boundaries of the City of Laredo including the LISD campuses, there is nothing that prohibits a police officer from being called to a shooting and to go there and assert his authority. Therefore, there is no question of jurisdiction, we do have jurisdiction, the problem here maybe the problem of who has better access to the information and being that the UISD have a police on campus, it is easier for them. It is just a matter of getting with the police chief, writing out a report and following the case through.

- c. Cm. Casso announced that the Texas Water Conservation Committee has requested that the South Texas Development Council organize a South Texas Water Conservation Task Force and Cm. Bruni is going to be the chairman of this task force and the main focus of this task force is going to be to plan water conservation on original basis. He encouraged everbody to attend. The first meeting will take place tomorrow at 10:00 in the morning at 1718 Calton.
- d. Mayor Ramirez recognized WBCA representatives and read the proclamation which designates Friday, February 23rd as

"Red, White and Blue Day" and called upon the community to observe this celebration by participating in the programs, ceremonies, and activities during the week of February 15 thru February 25th.

He also announced that they will be designating February, 1996 as School Board Month, this is state wide effort promoted by Governor Bush. He will be having a formal proclamation and appreciation ceremony February 6th, and extended an invitation for everyone to attend.

e. Mr. Mike Chavez and Mr. Hector Rodriquez representatives from the Union Pacific Railroad Company were before City Council to say that there are many crossings in Laredo and they do have a problem with them. They are constantly on call and they respond practically immediately. They have started a problem and are working with the City Planner so that they can continue to upgrade the crossings that exist. These crossings have existed for a while and the improvements that have been made upon them have been very slow. The have started the improvements north of Zaragoza Street replaced 100 feet of track which is the main line that goes to Mexico with new track panels and resurfaced the area with asphalt so that traffic can go more speedily through Zaragoza. He reported that they have proceeded through Scott Street which is a major truck route, they have refurbished the main line. The railroad is responsible for the track and the ties. They have also done Sanchez crossing and replaced the track panels for three of the tracks. This is an ongoing process up to Jefferson. He explained that it is a slow process and an expensive one, but they will try to attack it the best way that is feasible for the city to manage the traffic that exists thru there and at the same time maintain their operation that exists with Mexico north and south bound. They have an active operation life saver program to present in 1996 and plans for more upgrading as far as the crossings.

Cm. Bruni spoke in reference to blockage on the railroad crossings that presents a serious problem to the industrial parks.

Cm. Cardenas addressed some concerns in west Laredo where his main concern is that Sanchez is blocked most of the time and the street is in terrible condition. He is waiting on some answers on Gonzalez Street from staff because he does not recall approving Gonzalez Street for the use of the railroad. People are desperate there and say that either we do something or they are going to do something because it has been closed for over 12 to 16 hours. The residents there a planning to hire an attorney to file a suit against the railroad company unless this street is cleared. He said that they either clear the street or work out an agreement with them that it is going to be closed at certain hours. He added that besides blocking the streets they also have

engines running by themselves idly for more than two or three hours after 11:00 p.m. annoying the residents of the area.

Mr. Rodriguez stated they have met the commitment that they will commence opening the crossing at Gonzalez as much as they can. He continued by saying that Sanchez Street has been completely refurbish the plan is to do the existing tracks on the west side, but what they have done is directed the renovation towards the tracks that need the highest priority, for example the truck route which is compeletly done except the west track. He concluded by saying that Sanchez is in the program to be completed and will be done.

#### XI. CITY COUNCIL DISCUSSION AND PRESENTATION

46. Request by Mayor and City Councilmembers for discussion and presentation.

# A. Requests by Councilmember Louis H. Bruni

 Discussion and possible action concerning the development of an ordinance prohibiting persons from riding in the back of open bed pick-up trucks or open flat-bed trucks on public streets or highways.

Cm. Bruni stated that he was in advise by his attorney that as long as the city does not contradict state law that we indeed as a city can create and enact an ordinance to strengthen and tighten this particular state ordinance. He thinks that the city should move in this direction and move in the direction of creating an ordinance.

Mr. Aldo Tatangelo commended Cm. Bruni for bringing this item before the council and requested that council pass an ordinance prohibiting persons riding in the back of open pickup trucks.

Mr. Dan Ramirez, Associate Municipal Court Judge, stated that February 11-17th is Child Passenger Safety Week stipulating that kids aren't cargo and asked that we follow up on this issue and provide an ordinance prohibiting the riding of persons in the back of pickup trucks as has been done in Albuquerque, Arizona.

Fausto Sosa, City Attorney, stated that we must conform with the requisites of the state constitution and we can not contradict a state law by any means. There is no ordinance that can be created that will supersede a state law which was the answer that was given by his predecessor a year ago and still applies today. Under Art. 67.01D was the old statute and has been recodified under the Texas Transportation code and basically you are referring to section 545.414 which is riding on open beds. One of the sections that begin the Transportation code is section

5.42.221 which talks about the general rules of uniformity and there is where we are told that a municipality or local authority may not enact or enforce an ordinance or rule those conflicts with state. Therefore, if the state law has set the parameters under which this conduct will be govern, we cannot change those parameter. The way that we could go above changing it would be by lobbying with our Senator and our local State Representative to get the state law changed.

Motion to instruct staff and Legal Department to draft an ordinance prohibiting the riding on the back of open pickup trucks similar to the one enacted in Albuquerque and add it to our Traffic Code of Ordinance right now and make it a section of our local traffic laws.

# B. Requests by Councilmember Alfonso I. "Poncho" Casso

 Discussion and possible action concerning Amendment No. 5, UNITEC Contract with the City of Laredo.

Cm. Casso had some reservations on the cost of implementing Amendment No. 5, it is going to cost \$153,000.00 and he was thinking that it would cost more, it seems to him that are some items being left out.

Mr. Tomas Rodiquez, Utilities Director, answered that on the report that Cm. Casso showed, alternate No. 1 says to install an emergency generator at Station No. 2, install a backup fire pump at Station No. 3, install an emergency generator in Station No. 3, and require existing buildings with immediate fire flow in excess of available to provide on-site fire protection capabilities. In addition it further states water system approval for this alternative are estimated to cost \$400,000.00. The requirement for building is there, if they are in excess of "x" number of square feet based on the requirements of the building code. In addition to satisfying the requirement of the generator we have a 1,000 gallon per minute pump. That station 2 is a 1,000 gallon per minute pump diesel operated, if there is a power failure we have the pumping capability. To install a backup fire pump at station 3, an emergency generator is also covered by the 2,000 gallon per minute pump with a diesel generated engine. In addition to that, they asked for a chlorinater and an amoniator and for a telemetry system so that it could be connected to the Jefferson water treatment plant.

Cm. Bruni asked if the NRS report is mirrowing the Foster Engineering report or what they plan on doing out there? Is

Foster Engineering adhering to the NRS report or what they suggest we do out there.

Cm. Bruni asked if they will be addressing additional on site ground storage for that industrial park in the near future.

Mr. Rodriguez stated that a study was made and the amount of consumption by that United Industrial Park is minimum and does not require additional ground storage at this time. If they added another 400 acres or they do to develop it then we would need additional ground storage, but at the present time the problem that they had is that if you have too much storage and not enough fuse then the chlorine residue drops and it drops pass a point which creates a violation of state law.

2. Discussion and possible action concerning the creation of a City/County Government Commission to study and establish a metropolitan government for Laredo and Webb County. (Co-sponsored by Cm. Louis H. Bruni, and Cm. Joe Guerra)

Cm. Casso said that the most important question is how do Laredoans want to govern themselves? He asked that council support the creation of a City/County Government Commission that would lead to a better utilization of resources and avoid the waste from the duplication of efforts. The work from the commission would be (1) to recommend how the city and county can better work together under existing law. (2) To propose state legislation that would allow for structural consolidation of existing governments and (3) to develop and conduct a public education and outreach program to explain the benefits of such consolidation. Commission would be appointed as follows: We would have the City Council appoint ten members, the Commissioners Court to appoint four members, the Mayor and County Judge could jointly appoint five members, the Webb County Clerk could appoint one member, the District Attorney another, the Webb County Attorney appoint one member, Webb County District Clerk, Webb County Sheriff one member, Webb County Tax Assessor/Collector one member. The commission can then create various operating task forces that can be broken into brod functional areas which include Planning, Housing and Community Development, Health and Human Services, Recreation and Cultural Services, Public Safety, Transportation,

Utilities and Infrastructure, Economic Development and Administrative Support Services.

Mayor Ramirez suggested that we first establish a City/County Ad Hoc Committee and start with appointing Cm. Casso, Cm. Bruni and Cm. Guerra as our representatives and get two County Commissioners to the table and start from there to set up the parimeters of who is going to serve and

what the intent is and then move it to the public. And in fact go into having a public discussion of this committee.

Motion to create a City/County Ad Hoc Committee and have the Mayor name Cm. Joe Guerra, Cm. Louis Bruni, Cm. Casso with Cm. Guerra being the chair for the city's end.

 Discussion and possible action regarding international and out of state travel by the City Manager and his assistants.

Cm. Casso asked that in the future when the City Manager and his assistants go on trips, that they be notify what their goals and missions are before they take the trips. He added they want to know the details before hand because they know after the fact and they are put in a bad light with their constituents.

Mayor Ramirez stated that there needs to more involvement in the flow of information in advance so if there is interest from them to participating in greater detail is afforded to them prior to them and not after. And that when they have delegations coming in that they do have representation from the elected officials as well.

4. Discussion and possible action regarding a crosswalk between City Hall and the Justice Center.

Cm. Casso stated he has heard many complaints from the elected officials across the street because we are giving citations to jay walkers and what we are doing is just hurting the elderly people who are going over there to pay their taxes. He said they are not using the side street, that maybe a time could help or wants to know what can be done.

Mr. Vargas stated that they looked at that situation before because there was great sentiment to put the crosswalk in the middle, but that was not as safe as having them on the corners because the motorist are expecting them on the corners. He will look at the possibility of a timer with a push button so that people do not have to wait so long.

5. Discussion and possible action regarding the status of the new Laredo Public Library.

Cm. Casso said for the record there has been some rumors around town that some members of this council are opposed to the library. He said he was not opposed and wants to know what the status is and why they are taking so long because the police facility is almost finished.

Mr. Vargas stated that the reason for the longer time period is that the library was going to be a community facility, council appointed a big committee and they had to give them time to be able to get everyone's input, with the police facility they hired a consultant engineering almost immediately and they started to work on it because it was a security building.

Rogelio Rivera, City Engineer, stated that the plans have been ready for some time, however there has been discussion on the fire protection and they added additional fire protection. The consultant asked for another week extension the latest schedule was received today and it calls that the plans will here for distribution on the 15th, they will be out on bids on the February 10th.

Discussion and possible action regarding the required parking spaces for the Los Rincones condominiums.

Cm. Casso stated that Mr. Delgado has had some problems and wants some solutions to them.

Mr. Richard Delgado, President for Los Rincones condominiums, located at 1404 Musser which has 26 units and 52 parking spaces are required, right now they only have 36 and his question is how did the city ever approved this when they built this.

Marina Sukup, Planning Director, stated that Mr. Rene Solis is the developer he had adequate parking for what he had proposed. Mr. Solis has indicated that he is willing to provide the parking pursuant to the original plan that was submitted. His indications were that the Resident's Association and Mr. Delgado don't want the parking provided as per the original plan. He has indicated that he is more than willing to provide the parking.

Mayor Ramirez stated that this warrants a re-inspection by the City Planning Department.

Mrs. Sukup will set up a meeting with Mr. Delgado, Mr. Solis, the Planning Director, and the Building Inspector to discuss this matter.

Mr. Vargas stated that staff has looked at these areas and the whole area is an "arroyo" that has been filled in illegally, they do not even know what was used to fill it in. That area was a tributary to an arroyo, they don't know what is there and they were not included in the paving districts. What they need to know is see what we are getting into, that we get the technical data from the Engineering Department.

Rogelio Rivera, City Engineer, explained that they have documents in reference to the area. He said there is a 1979 contour map of the area in question which shows it is a creek area, an aerial photo that shows the creek area is still in existence in 1983, 1984 a photo that shows all that area was filled in and is highlighted with yellow marks. They are working on the cost estimate of the water and sewer improvements.

Cm. Bruni stated that the 3200 and 3300 blocks of Rosario are unpaved and that maybe they can add this two to project 59.
