VIII. CITY MANAGER'S REPORT

21. Presentation by the City's Financial Advisor and the City's Bond Counsel concerning the proposed refunding of the outstanding Toll Bridge Revenue Bonds in order to accommodate the financing of International Bridge IV.

Noe Hinojosa and Pete Tart our City's Financial Advisor and the City's Bond Counsel, respectively, presented a proposal of refunding the outstanding Toll Bridge Revenue Bonds in order to accommodate the financing of International Bridge IV. Mr. Hinojosa presented that there are many favorable terms for Laredo. Current bondholders would get paid first and then the state, interest rates would be at four percent making it very favorable. The life of the bond would be over 30 years. The agreement would be between Texas Turnpike Highway, Federal Government, Department of Transportation and City of Laredo due to the Intermodal Surface Efficiency Act.

Mr. Tart stated that the funds will be a written agreement that will be negotiated at a later time. We will repay out of surplus funds and the city will reserve the rights to issue additional parity in the events of additional improvements or stations to their existent group system. We would also have to refund all of our outstanding debts, which goes back to 1976. He also stated that all title to the bridges must belong to City of Laredo. The Department of Transportation is willing to advance the 11.3 million dollars only if the title to the bridge is in the Texas Turnpike Authority until all the money is repaid.

Mr. Carlos Villarreal proceeded to state that these terms are very much in favor of Laredo and many other cities are dying to have this opportunity being offered to us.

Cw. Moreno questioned why the bonds principal was being increased.

Mr. Vargas replied that the bond is being refinanced to benefit the bondholder.

Trinidad Silva spoke briefly against about the proposed new bridge.

Cm. Guerra proposed that there be a workshop for all council members for any questions concerning this matter.

Roberto Murillo, City Traffic Engineer, stated that H.E. Butt Grocery has reached an agreement with the owners of the land where the center turning lane is to be made. H.E. Butt Grocery has written a letter agreeing to continue with the creation of the center turning lane, letting the City of Laredo acquire the land.

IX. COMMUNICATIONS

a. Presentation by Ricardo Santiago concerning the creation of the International Children's Festival of the Arts in Laredo.

Mr. Ricardo Santiago spoke a of proposed project that is starting to become a reality. The project entails the promotion of different nationalities that would target fifth graders. The themes proposed are unity or family. The festival would cover a three week period and would include parades, certificates, scholarships, and direct rewards to the children.

Cm. Guerra proposed that staff look into it.

Marcia Jovel, member of the audience, spoke briefly and commented on the appointment of Chief Martinez. She stated that before the appointment he was not on the top list of candidates until Mr. Edward Perales, Superintendent of U.I.S.D, brought it to Mr. Vargas' attention. She proceeded

to say that there are some tapes in their possession that leads to major corruption.

Robin Roberts briefly advised City Council to capitalize on our assets. She commented that we should clean up what we have and focus on our historical setting and Hispanic heritage.

Robert Gutierrez spoke briefly about his feelings concerning the matters with Chief J.L. Martinez.

X. CITY COUNCIL DISCUSSION AND PRESENTATION

23. Request by Mayor and City Councilmembers for discussion and presentation.

A. Requests by Councilmember Louis H. Bruni

Cm. Bruni asked for a moment of silence for the death of Senator Judith Zaffirini's mother.

1. Discussion and possible action concerning the City's Weather Modification Resolution No. 95-R-086, with a presentation by Don Griffith from TRC/North American Weather Consultants.

Cm. Bruni stated that there are seven counties already involved in cloud seeding projects. The total estimated costs have been one million dollars for a five year contract. Cm. Bruni pleaded with the public to conserve water because it is our most precious assets.

Don Griffith of TRC/North American Water Consultants made a presentation to City Council concerning the steps involved in this project. He stated that two techniques can be used in order for the needed rain to occur. He commented that a permit would take about 45-60 days to acquire from the state.

Cm. Guerra and Cm. Bruni both strongly urged City Council to act quickly.

Charles Martens, a member of the ranching community, spoke briefly on the funding that is willing to be made by ranchers and other party members.

Cm. Valdez asked Council if the Mexican government had been confronted with the proposed plan and asked if they were willing to participate, due to the airplanes needed for the cloud seeding to enter their jurisdiction.

It was said that Mayor Saul N. Ramirez had already spoken to Mexican government officials.

Commissioner David Cortez spoke briefly about our water problem and strongly expressed that he is willing to commit with the City of Laredo, people, and ranchers of this community. He thanked the invitation from Cm. Bruni to

attend the meeting.

For the record, Cm. Bruni stated that he had invited the County Judge and the rest of the Commissioner's Court.

Motion to apply for a permit by the State of Texas for the proposed cloud seeding project and that staff look into bids for the funding needed.

2. Status report on the Santa Isabel Water Well Project with a timeline for its completion.

Fernando Roman spoke briefly about the well being able to produce water. The only problem being that it must be treated due to salinity.

Cm. Bruni questioned when the second well will be drilled.

Mr. Roman replied that he wanted to wait for the results of the first one.

3. Report by Jose Luna from the Texas Natural Resource Conservation Commission (TNRCC) concerning the Falcon reservoir and Amistad reservoir water reserves.

Mr. Jose Luna reported that the week of May 11, 1996, the total water level is 45 below normal. He stated that water available for Laredo will dissipate in about 17 months if precipitation does not occur.

B. Requests by Councilmember Alfonso I. "Poncho" Casso

1. Discussion and possible action regarding placing the Chief of Police on administrative leave with possible Executive Session.

Cm. Casso began by saying that the Laredo Police Department is in shambles. He said he regrets that he is the one that has to do this, but this burden has been on his shoulders for two years. He told Mr. Vargas that the City Manager should stay out of politics. Cm. Casso then accused City Council and Mr. Vargas in developing policies in administrative matters. He then stated that politics influence people, which in turn gives the majority a consensus. He feels that the city manager is a powerful administrative head of taxpayer's funds. He told Mr. Vargas that it only takes one city councilmember to force a manager to resign.

Cm. Casso then directed his speech to Chief Martinez. He stated that <u>Laredo Morning Times</u> protects the Chief of Police for some reason. He exhibited the newspaper from May 18, 1996, and stated that Odie Arambula never mentions Cm. Casso

and what he has to say on civil right violations. On May 20, 1996, under the "Monday Wash", Mr. Arambula once again said that the problems stem from those not suited for the public charge, referring to Cm. Casso. He also stated that Mr. Arambula had stated for the record that the newspaper does not have to be impartial or fair. He stated that the City of Laredo paid a consultant \$170,000 for a job that wasn't needed and didn't produce anything. Cm. Casso also added that nepotism has been involved in other appointments for the Laredo Police Department, such as the attorney for the LPD. Cm. Casso brought it to attention and questioned the Chief of Police appointment because he did not have an impeccable record. Cm. Casso then questioned the illegal appointment of Chief J.L. Martinez case. He then stated that he wanted the illegal appointment of the Chief of Police in writing. then began to state that the recent demotion of Captain Hale is a terrible embarrassment to the City of Laredo. Cm. Casso then questioned the ramifications of the lawsuit and if it is covered under TML. Mr. Vargas proceeded to say that we won't lose because process and procedure was followed. Mr. Fausto Sosa, City Attorney, added that we didn't lose, because we aren't the ones appealing the case. Again, Cm. Casso asked for this in writing. Mr. Vargas stated that he will provide all the information along with Mr. Sosa's report.

Cm. Casso proceeded to say that Lt. Raul Hinojosa, whom is now a constable, had commented in the local newspaper that he had reminded Chief J.L. Martinez during a meeting where he was announcing the promotion of Lt. Hale to departmental captain, that the list in which he was choosing from had expired. Lt. Hinojosa then stated that it was in clear violation of the Collective Bargaining Agreement.

Chief Martinez responded that he had already spoken to the attorney and had advised him that it could be made from the list.

Cm. Casso then stated that everything is an embarrassment on Mr. Vargas and Chief J.L. Martinez. Cm. Casso continued by stating that it was said in a newspaper on Friday, May 17, 1996 that Chief J.L. Martinez had approached Cm. Casso for grievance documents, but that he had refused. Cm. Casso said he had never been approached.

Chief J.L. Martinez initiated his rebuttal by telling Cm. Casso that he had asked for the information.

Cm. Casso then proceeded to question why Chief Martinez had asked him for the documents and not Mr. Vargas.

Cm. Casso then advised Chief J.L Martinez to resign because he doesn't have the support of 90% of his officers and it would just be better for everyone.

Chief J.L. Martinez refused and the discussion was closed.

2. Discussion and possible action regarding the growing crisis of the downtown retail economy.

Cm. Casso confronted Mr. Carlos Villarreal, Asst. City Manager, about a quote that was stated in the <u>Laredo Morning</u> Times.

Mr. Villarreal said that the quote was misunderstood. He explained that what he meant was that Laredo has gone through worse times and has bounced back due to Laredo spirit. He continued to say that Laredo has gone through many economic situations, including the recent peso devaluation. He said he is "compassionate" to the people of Laredo and even though the downtown retail economy is at a low, he feels that Laredo will survive.

Cm. Casso then stated that the difference between himself and Mr. Villarreal is that he was elected and Mr. Villarreal was not.

Motion to table the next two items.

C. Requests by Councilmember Eliseo Valdez

1. Request for a traffic study do be done at the intersection of Taylor Street and McPherson Road.

Cm. Valdez stated that he has had many complaints about accidents reported on that intersection. He requested a report on the number of accidents within the past year.

- Mr. Vargas agreed to have a report for him by the the first meeting of July.
- 2. Discussion and possible action concerning the development of a comprehensive promotional campaign for the downtown area.
 - Mr. Vargas briefly commented that he would like to review the issues before the runoff elections on June 1, 1996. He stated that public improvement has increased. He will give a complete report.

3. Discussion and possible action concerning the City's creek cleaning schedule.

Joe Guerra, Public Works Director, stated that 90% of all creeks have been cleaned.

Cm. Bruni then commented that in District II the creeks are very dirty. He questioned where the water is coming from due to the lack of rainfall the past two or three years.

Cm. Casso stated that District III is filthy also. Fernando Roman, Wastewater Director, stated that the water may come from housewater runoff or shallow groundwater.

Cm. Bruni and Cm. Casso requested that water from their districts be tested in order to see where the water is coming from and what is in it.

Motion to direct staff to furnish a report on cleaning of the creeks.

4. Discussion and possible action concerning re-surfacing of the streets in the Retama I and Retama II subdivisions.

Mr. Vargas briefly reported that the recycling program has been very successful over the years. It has become one-third less the cost than restructuring the streets. He stated that he wants to formulate a plan for next year's budget to get into some of the neighborhoods that are ready for recycling in order to extend their life for about five years without having to do some major reconstruction.

5. Discussion and possible action concerning the replacement of street signs in District V.

Luis Landin, Traffic Manager, stated that 1500 signs have already been ordered.

Cm. Bruni stated that he sent a letter to Mr. Vargas concerning street signs needed for his district, due to damage and theft.

Mr. Jesus Nava, Assistant Manager, commented that if anyone notices something suspicious to please call Laredo Police Department.

6. Discussion and possible action concerning the street lighting program for the San Luis Rey neighborhood.

Luis Landin, Traffic Manager, stated that 141 intersects are already being upgraded. He asked Cm. Valdez for specifics to look into.

Cm. Valdez agreed to get them for him.

7. Status report concerning the City's efforts in policing City parks.

Cm. Valdez asked Chief of Police Martinez on the issue of vandalism at the new park off of McPherson Rd. He stated that vandalism has occurred and has received phone calls concerning the police action, including the whereabouts of the Police Park Blazer.

Chief Martinez stated he thought the problem had been taken care of and will look into it.

City Manager Vargas told Cm. Valdez that he would set up a meeting for any other questions posed.

D. Requests by Councilmember Felipe Cardenas

1. Discussion and possible action concerning citizen problems with their water meter readings.

Cm. Cardenas asked Phyllis Colon, Utility Collector, how meters were being read around the Guadalupe Church area. He stated that people were paying under \$72.00 a month. Ms. Colon stated that some meters were being estimated due to the fact that some meters are broken, houses may have dogs or parked cars that prevent readers from reading meters. She proceeded to say that she is more than willing to answer or teach the public on how to read their meters.

2. Discussion and possible action concerning remarks made by Health Department Director Jerry Robinson on a local television news broadcast regarding the handling of food at local food stores.

Jerry Robinson spoke about the recent news broadcast that was shown on KGNS on May 8, 1996. He was interviewed by Jennapher Lynn concerning the cleanliness of some meat markets in Laredo. When speaking about the food handlers in the work force he stated they were not "sophisticated", but intended to say educated. He apologized for his verbal slip and for any embarrassment it may have caused.
