Cm. Bruni had several concerns on this agreement and added that since the firefighters have an exclusive contract with the city through their collective bargaining he questioned how can we subcontract the firefighters to the county? He added that it seems to him that there is a budget of about \$25 million worth of equipment and manpower that is tied up

for a 12 month period for a small amount of \$400,000.00 and it does not appear to him that it is good business sense. Another concern is the legality of such a contract. He has many concerns about putting our firefighters at an extra risk going out to industrial parks in the county and going out to other places of danger. If it is a state/federal highway situation he feels that the we should be getting federal or state monies to be providing this assistance. He feels were are not getting a fair shake on the agreement.

Cw. Moreno stated that we should look at the overhead expense when figuring the costs and she believes that new residential development was never intended to be included in this agreement.

X. COMMUNICATIONS

Mayor Ramirez presented an Outstanding Citizens Award to Jorge Arturo Landin, a firefighter, who rescued a drowning victim at Lake Casa Blanca on Sunday - September 22nd while off duty.

Cw. Moreno stated that they received the unaudited financial statement for August the 31st and asked why is it that our prior year property taxes are lower yet the penalty for the tax attorney is higher.

Florencio Peña, Interim City Manager, stated that we pay the tax attorney 15% of what is collected. He said they will look at the ratio and estimates and will provide a report.

Cw. Moreno stated we show less money than what we had anticipated having received and yet we are paying them more money than what we had anticipated that we would pay them.

Ms. Colon stated this happens every year because we estimate what we are going to pay them, if we get in more than that then we owe them more.

Cw. Moreno's questioned what if you got less why are we paying them more?

Mr. Peña stated that it appears that the estimate was wrong in the budget, but they will get a report on the ratios and estimates.

Cw. Moreno stated we projected our ending balance to be lower than what was originally projected, yet on the opening balance it does not reflect that projection, we still maintain the old ending balance, why is that?

Mr. Peña responded that he will look at this item and report back to council.

Cm. Valdez stated that since the City of Laredo has done a good job at the federal level, he feels that we need to start concentrating at the State level.

Mr. Gerry Schwebel, Laredo Development Foundation President, made a presentation to the council on the topic of legislative representation for the City of Laredo on critical issues affecting our community and county. He stated that the concerns should be handled through independent lobby assistance. These concerns should address the issues on: water treatment, resource development, and storage; transportation and infrastructure; environmental policy and impact on Webb County; land and property development; and economic development issues.

Cm. Guerra asked if this administration is satisfied with the services provided by the lobbyist in Washington, because he had received a letter from a person in Washington that expressed an interest in providing that same service to the city and wanted the letter that he sent him to be part of the record so that council considers this application.

Fausto Sosa, City Attorney, stated for the record that municipalities cannot hire lobbyists.

Mayor Ramirez stated it is not lobbying, they manage our legislative affairs at our capital, we do not hire lobbyist.

Cm. Casso stated that one of the goals he wants this representative to address is the consolidation with the county and look at the constitutional amendment issues.

Cm. Valdez stated that he feels that one of the goals should be economic development tackling the unemployment rate.
