This option includes appraising those properties abutting the overpass and paying the property owners for damage. The amount cannot be determined until properties are appraised, however, the cost would be less than any of Options I through IV.
- Option VI -Requires the acquisition of approximately 5 feet of additional right-of-way from Main to San Ignacio. This additional right-of-way will allow the paving of a 23 ft. back-to-back paved street which would be sufficient to allow offstreet parking allowing sufficient space for traffic to continue without problems. option includes the acquisition of 3 residences which will require the relocation of 2 tenants and 1 owner-occupant. It is estimated that it will require approximately \$612,480 to complete the project. - b. Provide funding for at least \$10 million in Capital Improvement Program (CIP) projects,
- c. Improve the debt coverage ratio.

Mr. Fernando Roman, Interim Utilities Director, presented the following proposals with his recommendation of proposal I:

61. Presentation on the Texas Department of Community Affairs Neighborhood Partnerships for Texans Programs and DCD Downpayment Assistance Program as applicable to the Concord Hills Development, with possible direction.

Mr. Joe Mann from the Texas Department of Community Affairs made the presentation before the City Council and stated that this morning the board approved \$1.8 million for the Concord Hill Subdivision for downpayment closing cost assistance to be matched by the city. He added that this is a 3 1/2 year program and they are trying to make a commitment to the City of Laredo for affordable housing not just in this project, but to look at other projects also. The Neighborhood Partnership for Texans Programs is a way to leverage their funds, and found that one of the ways to leverage their funds is by downpayment cost assistance which helps people get into houses and if they can provide that for people, the private sector will use their money to build the houses. They found that this is one of the most effective programs that they found and what they are trying to do is leverage their money with the city and the county to provide downpayment closing

cost and buy down reduction of the note (the first lien) to help people get into houses, people that are 80% and below of the area meeting income. He said that for Laredo the area meeting income is approximately \$28,800 according to HUD charts, therefore they are looking at people in the \$22,000 range and below. They looked at this particular project and have received approval this morning for \$3,000 per household for people 80% or below in the Concord Hill Subdivision and want to see if they can partner with the City of Laredo.

Cw. Montalvo asked if the monies are grant monies.

Mr. Mann stated that these are 0% loans, they are due and payable upon sale, refinanced or if the person just decides to start renting the house or in 30 years.

Motion to:

- (1) Modify the city's current city wide downpayment assistance program to increase the city's loan to \$3,000 per family and to commit to allocated portion of city CDBG and HOME funds sufficient to offer 1,200 families downpayment assistance city wide over the next four years, subject to availability of funds in each fiscal year.
- (2) To instruct staff to prepare the resolution and submit it to the Texas Department of Housing and Community Affairs as soon as possible and before the TDHCA has finalized their policy in the Neighborhoods Policy for Texans Program, to request that their criteria for qualification in neighborhoods be expanded to include existing and future single family neighborhoods in Laredo which are providing alternative forms of urban design, home construction systems, and community and immunities to those currently favored by the Texans Department of Housing and Community Affairs staff.

Cm. Casso believes that the project is unfair and unconstitutional because it creates segregation. It is a redistribution of wealth, it's a segregate redistribution of wealth and the project has not gone before P&Z and it needs to go before the Planning & Zoning Commission.

Mayor Ramirez stated that we do need to bring 1,200 homes to the table over 3-1/2 years, this a great idea and we should commit ourselves to build 1,200 homes. We have had other projects available including Fannie Mae that committed \$50 million dollars and had pretty good success with the banks here in town and working for people with low and moderate housing to find long term financing. Here we have 600 homes that are ready to go, that not only are going to be helped with \$3,000 from the city and the county, but are also going to be helped with \$3,000

more from the state and added that they can prioritize them. Let's commit to the 600 homes right now and we have 600 more to go. He added that he has no problem in putting HOME money up over the next five years which is \$5 million with builders having first crack at it for first downpayment assistance and raising it up to \$3,000 but if we can leverage \$9,000 for people in our community and put more people in homes over the next 3 1/2 years then we move with it, but it's entirely up to the City Council.

Motion was made by Cm. Perez and seconded by Cm. Valdez to move ahead with the Mayor's suggestion.

Before a vote was taken, Cindy Collazo, Community Development Director, reported that staff had formulated a financing plan to be utilized in regard to this project and it was staff's proposal to present the following guidelines to be administered to the allocation of funding to Concord Hills:

- 1 The City should adopt a plan which provides a total of \$1.8 million to be used for downpayment assistance with the source of funding to be identified on an annual basis for FY97-FY200.
- 2 Beginning with the second year, funds will be allocated for each specific year. If the total annual allocation is not utilized, the remaining balance will be forfeited. NO balance will be carried over to the following year(s). The amount of funds utilized will be in relation to the number of homes which will be built.
- 3 The award of funds will be based on performance and Concord Hill's ability to construct housing as per the schedule proposed. Termination of the contract will be held as an option by the City if Concord Hills fails to meet the productivity terms of the contract.
- 4 The form of assistance can be provided in the form of a loan or a grant as may be decided by Council. As per guidance provided by Mr. John Maldonado, HUD/CPD Director, the City would need to be consistent in the form of assistance provided in order to promote fair housing and equal opportunity.
- 5 The disbursement of funds by the City will be contingent on the State's and County's award of matching funds.
- 6 It is suggested that the City's 1996 Downpayment Assistance budget be increased by \$150,000 in order to make funds available to other builders and/or individual first-time homebuyers who may seek assistance.

- 3. Status report on the Casa Verde Acres Development to include the entrance Road, with possible action. Cindy Collazo, Community Development Director, gave the following report:
 - 1 On August 19, 1996 Council directed staff to meet with weekly with the residents of Casa Verde Road. Since then, meetings were held August 21 and 30; September 11, 13, 23; and October 30, 1996.
 - 2 In order to determine ownership, a comparison of the tax roll information was done on site with the property owners/residents of the area.
 - 3 In order to request a determination of this project by HUD, income verification was needed. A meeting was scheduled with Marco Garcia to meet with the property owners.
 - 4 On August 21, 1996 staff met with 5 owners during the evening. They agrees to provide family income verification by August 30, 1996.
 - 5 On August 30, 1996 the information was not received.
 - 6 September 11, 1996, staff again met with 4 other residents of the project area requesting their assistance to provide to provide income data.
 - 7 September 13, 1996, staff met with Marco Garcia who indicated that 3 to 4 families residing in the 38 acretract appear to be low/moderate income. An additional 5 to 6 families reside within the remaining 100 acres.
 - 8 On September 13, 1996, by memo to Mr. Florencio Peña, staff reports of a meeting held with Mr. Tom Brown,

Texas Water Development Board (TWD) and Fernando Roman, Acting Utilities Director to discuss possible TWD assistance for the Casa Verde Project. MR. Brown indicated that step 1 would be to de-annex and comply with strict restrictions in order to qualify for a maximum of \$260,000.

- 9 On September 23, 1996, certified letters, and thru personal delivery, were sent to those who had not responded (6). The letters requested income to determine eligibility for HUD assistance. Two (2) weeks were given for the residents to respond.
- 10 September 26, 1996, staff received response from 2 to 6. Traffic count was also requested by Roberto Murillo from TxDOT.
- 11 October 11, 1996, compiled results based on all responses received after October 4, 1996.
- 12 October 16, 1996, five (5) responses were received, however, did not meet low/moderate criteria. OF the 11 families residing at the site, only 2 families met the low/moderate criteria based on income form provided by staff.

Therefore, based on the requirement of 51% low/moderate benefit, this criteria could not be used for qualifying this project. However, staff in an effort to look for possible assistance for the Casa Verde residents, submitted a request to HUD to use the slum and blight national objectives.

On November 25, 1996, Messrs. John Maldonado, CPD Director, Richard Lopez, CPD Manager, and Nathan Ratner, CPD Representative, provided a verbal response to the City's request and informed staff that this project would not qualify.

However, on a positive note, \$500,000 has been projected for appropriation for this program under the Capital Improvement Project for fiscal year 2001. Design and engineering set at \$50,000 while materials and construction estimated at \$450,000.

Cm. Bruni stated that the safety issues, the wastewater issue and the turning lanes in front of the access road are the issues that need to be resolved, the blinking light is a problem and needs to be resolved.

Mr. Luis Landin, Traffic Manager, reported that in reference to turning lane, they are working with TxDOT on this issue, it is a joint effort, they are trying to help them erase those lines, so they can go ahead and place the turning lanes. In reference to the requested flasher they are going to receive the ones that TxDot had on the Jacaman Road that are not being used, to move them to Casa Verde Road, this is in progress already, but he cannot give an exact date on it.

Roberto Murrillo, Traffic Engineer, reported that they did

get the equipment from TxDot, however they do need extra funding to do the installation because they have to use a contractor. He understands they will be placing an item on the agenda for the transfer of funds at a later date, so as soon as they get that they will start the project. They can do the turning lane and the blinking light by the end of the year.

Cm. Bruni stated he was out at the county park and noticed that the county personnel had bladed the road only to the county/city property line and it was not bladed all the way to the back of the property and they had not placed the oil base emulsion and wants to know when that road will be fixed.

Mr. Guerra stated they will fix the road by Friday. He emphasized that they were in agreement with the county that they would do all the road one time and then they city would do all the road the next time, but they did not do our road this time.
