Mr. Rogelio Rivera, Asst. City Engineer, made the presentation before the City Council.

Mrs. Francis Villarreal, State Certified Appraiser, stated that the values were enhanced by at least the assessed

values by the street improvements of all 207 parcels with two exceptions which are the following:

- 1) Parcel 16 was a triangle at the Tex-Mex right-of-way, 50% of the triangle was too narrow to be buildable, therefore this was not enhanced at all.
- 2) Parcel 202 was a triangle adjacent to the Ft. McIntoch Wall, the narrowness of the wall prevented two of the lots from being enhanced by the street improvements.

Each of those parcels were adjusted by 50%, parcel 16 was adjusted from 1,387.50 to \$693.75, parcel 202 was adjusted from \$2,777.60 by 50% for a total of assessment of \$1,388.80. Total adjustments in assessments before the adjustment was \$4,165.10, after the adjustments were reduced to \$2,082.55.
