1. Status report on the City's Creek Cleaning Program.

Joe Guerra, Public Works Director, presented a written status report to the City Council.

NOTE: No copy was given to the City Secretary for the record.

Cm. Bruni stated that a creek water test report showed that it contained fecal bacteria and wanted to know what the city does in this case.

Mr. Vargas stated that when staff is aware, a truck is sent to siphon out the contaminated water. They have found that illegal sewer connections have been located that drain into the creeks, which have been investigated and they will continue to monitor and investigate them.

Cm. Casso stated that besides fecal bacteria, there are contaminants of oils and other chemicals and suggested that the monitoring program be an on going process to clean the creeks.

Mr. Vargas assured him that this is an on going program.

# C. Request by Councilmember Joe A. Guerra

1. Recognizing the heroism of Tomas M. Rodriguez III for thwarting the robbery of his high school students while on an outing at the river banks.

Mayor Ramirez presented him with a paper weight with the Coat of Arms of the City of Laredo for his heroism.

2. Progress report on the Downtown Transit Center.

Mr. Vargas stated that two (2) of the four (4) properties have been acquired and the other two are in negotiations and will be done within a couple of weeks. The design work is in progress and we should be calling for bids in January and awarding the bid on February.

3. Report on the status of the City's efforts in eliminating lead/asbestos pipes in the City's Water System.

Tomas Rodriguez, Water System Director, stated that the report shows that there existed 371 service units in the old downtown area. Since 1991 they started to remove the units and replace them with copper and have replaced 102 units with 271 still pending and will be replacing them with going projects.

On the asbestos pipes, Mr. Rodriguez, stated that they exist only in the Del Mar area with an 8" along Del Mar Blvd., Lindenwood, and another street. He said that the city does not have an asbestos concrete problem and the Del Mar Asbestos pipes will be replaced with on going waterline projects.

4. Recognizing the athletic accomplishments of John Linhart from United High School (pole valt) and Guillermo Heredia from Martin High School (discus throw).

Mayor Ramirez and Councilmember recognized the athletic accomplishments of John Linhart from United High School (pole valt) and Guillermo Heredia from Martin High School (discus throw) for reaching the highest level in high school sports and presented each with the "All American City of Laredo" label pin.

### D. Request by Councilmember Felipe Cardenas

1. Discussion and possible action regarding the entrance to the Laredo Community College located on Hidalgo Street.

Mr. Jesus Longoria, representing 72 signed petitioners of the San Francisco Javier Neighborhood area, spoke in protest to the continued crossing problems at the Hidalgo and Zaragoza street railroad crossings. The problem exists in that the railroad continues to block the crossings for more than 15 minutes and in some instances more than 30 minutes. He added that Hidalgo at times has been closed totally for traffic and pedestrians. He also spoke on a particular incident that occurred to his brother and hopes that the situation does not happen to anybody else in the future.

He continued by citing letters that he has sent to the Texas Railroad Commission, the Department of Civil Rights of the Federal Railroad Administration of the U.S. Department of Transportation, and the U.S. Department of Justice.

Father Manente of San Francisco Javier Church expressed his frustration at the railroad company and its employees as they continue to refuse to cooperate with solving the blockage problem.

Mr. Andres Sandoval spoke in support of the Longoria family and the petitioners as this problem has existed since the era of Mayor J.C. Martin and continues today. He suggested that the city pursue the possibility of what was once proposed to built a road under the first pilar of the Tex-Mex rail bridge which would allow both vehicles and pedestrians to cross safely. He also stressed the point that Union Pacific should use the north switching yards and use this area solely for prepared cars for crossing.

Mrs. Longoria, sister-in-law of Mr. Jesus Longoria, stated that they do not want a pedestrian overwalk, they want either an underpass walkway or open crossings.

Peter Vargas, City Manager, stated that the Union Pacific assured the city that 90% of the railcars will utilize the new proposed rail bridge and thus eliminating the problem. He also stated that the legal issue on citations given to the railroad engineers has produced a tuck of war with Union Pacific, because they refuse to pay the fines stating that they are under federal regulations and not municipal law or mandates.

Mayor Protem Moreno suggested that we challenge the railroad company on the issue of refusal to pay the fines.

Cm. Cardenas requested a report from staff on citations issued and suspended to Union Pacific. He also suggested that a committee be formed to open talks with Union Pacific officials.

Mayor announced that the committee to open talks with Union Pacific officials would consist of himself, Cm. Cardenas, Cm. Jose Perez, Cm. Casso, and Mr. Jesus Longoria. This committee would invite the officials from Omaha, Nebraska to meet with them or the committee would go to Omaha to meet with them to find a solution. He also stated that we would continue to work with the ordinance and issue citations to the railroad engineers.
