COMMUNICATIONS

Presentation of the POW/MIA Colors by Hector Pulido, Commander of the 23rd District.

Mr. Hector Pulido, Commander of the 23rd District of the Veterans of Foreign Wars, made the presentation before the council.

Four Prisoners Of War persons were named and present at the council meeting, Dept. Commander of the State of Texas, William Farmer, Commander Alex Gonzalez presented POW's Commander Armando Jalomo who introduced Andres Arredondo, Max Offerle, Octavio Garcia and Jose Maria Saldana.

Presentation by John Jones concerning funding for Border Air Ambulance.

Mr. John Jones of Border Air Ambulance made the presentation before the council. He informed the council on the background and historical operational performance. They have united with Halo Flight out of Corpus Christi for medical control and assistance in billing. They have been in operation for three years and are a Not-For-Profit operation. He stated that they need financial support to continue to stay in operation and provide the services. They need \$6,400 per month for the next 2 months.

Mayor Ramirez asked that if we looked at \$6,400 a month, if there would be some perimeters or requirements that we would place on them in order to make it a viable third party arrangement for emergency service planning for our community.

Mr. Vargas stated that this would be the only conditions under which the council could proceed, they have to have some standards, that a number of contacts be made to raise resources, a work program established in delineating contact and receive the receivables and uncollectible, that they maintain offices hours, and other things that might be stipulated.

Mayor Ramirez stated that he would like to see this addressed as a policy and weigh it on performance of their duties rather than an ordinance which can be challenged in the courts.

Ex-Mayor Aldo Tatangelo believes that it is still a good idea to provide affordable housing to the low and moderate income families in this community. He stated that this is one of the most important things that he wants this community to do. He would like to see that the Azteca neighborhood be constructed with 300 affordable homes and to construct at the La Ladrillera pit and along the empty lots on Anna Street.

Cindy Collazo, Community Development Director, informed Mr. Tatangelo and the council that a total of 168 units since 1990 have been in the program; 28 units completed in June of 1992 on Anna Street known as Poncho De La Garza Affordable Housing Project; 33 units built on the East Laredo project; 7 units presently on construction; and 68 units are in the process in the George Washington Subdivision area and there are 32 units scheduled in south Laredo.

On the debt service issue, Mr. Tatangelo stated that he was concerned with the fact that the City of Laredo has gone from \$10 million 10 years ago to \$143 million today supported by property taxes.
