Marina Sukup, Planning Director, made a presentation on the analysis of traffic circulation in the Calton Gardens area. She explained that some of the problems are:

- (1) Indequate right-of-way on Calton and Hillside Road to handle existing traffic, especially with increasing amounts of higher intensity uses.
- (2) Lack of coherent internal circulation plan for the area.
- (3) Inadequate access to several of the original tracts which are presently undeveloped.
- (4) Absent additional authorization from the City Council, the city cannot require platting of the original tracts or the dedication of right-of-way for access.
- (4) Protection of intact residential neighborhoods.

She stated that it was staff's recommendation to:

- (1) Adopt a traffic circulation plan for the Calton Garden Addition, including appropriate measures to secure right-of-way.
- (2) Provide authority for the city to secure right-of-way as a condition of building or limit the intensity of use through zoning.

Marina concluded by saying that staff's specific recommendations were:

- (1) Identify Maryland Street as a non-street, conveying to abutting owners as appropriate, and close and convey those portions of Canal Street east of Marcella and reserving an easement for maintenance or drainage channel.
- (2) Secure additional right-of-way at the intersection of Springfield with Hillside and Calton to provide adequate stacking and dedicated turning movements.
- (3) Establish an absolute minimum right-of-way along Canal Street west of Springfield abutting the drainage channel, but not less than 30 feet.

- (4) Require all new developments along Hillside and Calton to dedicate by plat or separate instrument, or to reserve right-of-way, trading for side and rear rights-of-way deemed no longer necessary.
- (5) Require platting of undivided original tracts abutting Gallagher north or Calton, and San Francisco south of Calton.
- (6) Require dedication of right-of-way from blocks 53 and 56 to connect Castañeda Court to Marcella and Springfield, and require dedication along Marcella on the east side of Block 57.
- (7) Terminate Aurora east of Block 50/51 and one block west of Haynes.

Cm. Castañeda raised a concern on acquiring additional rightof-way, he was totally opposed acquiring right-of-way on Hillside and concerned on acquiring right-of-way on Calton. He stated that along Calton many homes are almost at the edge of the street, there are no sidewalks, there are many children crossing the streets and it has very heavy traffic. He added that he does not have a problem on the undeveloped property and that people around the area are all taxpayers too, they are trying do the improvements on their homes that they did after the city did the right-of-way acquisition on Calton and now we are going to come back and affect some of those residents. The city needs to look at opening additional east/west and north/south arteries to balance out the traffic in that area, and that they should consider extending Bustamante across the creek to provide some access. He also recommended that council consider connecting San Francisco where it hits the creek to cross behind the H.E.B area to provide some access relief.

Ms. Sukup spoke in reference to the issues and stated they did not look at the Retama area. They do recommend that San Francisco be opened.

Mayor Ramirez asked that Marina look at the undeveloped land between Calton and Hillside and consider a north-south artery and to approach the landowners for right-of-ways.

Mayor Ramirez asked for a cost estimate on the project if the valley gutter is built and suggested that staff visit with the school superintendent with the cost estimate.
