Marina Sukup, Planning Director, made the presentation before the City Council.

Mr. Richard Smith, a resident of Towne East, spoke against the zone change approval due to health hazards it presents to their area.

Mr. Armando Ramirez, a resident of Towne East, spoke against the zone change approval due to the fiber glass components that are contained in the cement plant and carried over to the residents in the area and which produces a health hazard.

Mrs. Nelda Smith, a nurse and a resident of Towne East, spoke against the zone approval, she pointed out a problem with the fiber particles produced by the cement plant which she attributes to respiratory problems incurred by her daughter and other residents in the area. She stated that they have been cited by the city and the state previously and asked that the zone change be denied.

Mr. Pete Gallegos, owner of the cement plant, stated that he had applied legally with the State. He stated that he took over the plant on June of 1994. He explained that it is not fiber glass but fiber mash to answer Mr. Ramirez's allegations. He presented a report from the Texas Air Control Board to Marina Sukup. He stated that it is a 1993 plant that was manufactured to standards to meet state and nation standards.

Ms. Clarissa Gallegos, Plant Manager and daughter of Mr. Gallegos, stated that the plant is clean and when there are complaints she will take care of the complaints.

Mr. Carlos Gonzalez, a Javalina worker, explained that as an Express Mix worker they did have problems before, but now that the area is paved they is no problems now.

Mr. Albert Moreno, Assistant Plant Manager, stated that the dust may not be coming from the plant, but maybe from their own neighbors who have piles of sand because their yard is clean.

Ms. Lourdes Vela, who takes care of applying for all their permits, stated that they have complied with every regulation that the state requires.

Mr. Refugio Garza, a worker for Pete Gallegos, stated that he is in charge of cleaning the yard and makes sure that the yard is clean and in compliance with state regulations.

Mr. Dave Wyers expressed that Mr. Gallegos has always been

good in his word and spoke in favor of the plant and that a study be made before any action is taken.

Ms. Melissa Cruz, Accountant for the Gallegos, stated that they are up to date with all regulations of the state and federal laws.

Mr. Jose Luis Solis a driver for Javalina stated that not all the loads have the fiber mash, only when it is need.

Marina Sukup, Planning Director, stated that approximately a year ago it was called to their attention that there was a ready mix plant in south Laredo along Zapata Hwg. gentlemen had not begun, it was adjacent to a residential area and they indicated to the owner that he would have to relocate his business, which he did. He pointed out at that time, that there was one similar operation in the Mines Road and this one in U.S. 59. Staff investigated found that Mr. Jaramillo was indeed correct and notified Mr. Fragosa at that time that his property was not platted and was not properly zoned for the use. She added that ordinary procedures in this issues are to notify the landlord in this case, the lessee, that he would have to cease or take corrective action to give him the opportunity to bring his operation into compliance whether through replatting or seeking a zone change. The person operating the plant was Mr. Fragosa and chose to deal directly with the legal department rather than the planning department. There had been a number of problems, the dust, the parking area was unpaved a number of complaints as far as the trucks in addition to the use. She added there was a compliant filed on March 28th with Municipal Court when it became apparent that Mr. Fragosa did not intent to bring the property into compliance. The case has been continued, there was an application finally, made for a rezoning on May 10, 1994. Mr. Gallegos did correct many of the conditions and the problems that existed without a permit. A permit cannot be issued because it is not platted which is one of the problems.

Mr. Vargas stated that legal action has been taken, there is a case pending in Municipal Court, but that the problem is that the applicant or plaintiff asked for a continuance and was granted a continuance. He then sold the business and is no longer interested in pursing that. Mr. Gallegos should have been aware that there was litigation going on at the time, before the other individual closed the business. He was basically no longer involved and our attention shifted to Mr. Gallegos because he was now the owner of the business.
