# IX. CITY MANAGER'S REPORT

29. Presentation by Webb County Appraiser Leta Schlinke of the Webb County Appraisal District's budget for City Council review and recommendation.

Ms. Schlinke, Webb County Chief Appraiser, announced that the appraisal budget hearing is set for July 27th at 6:00 P.M. at the Appraisal District Office. She added in preparation for that hearing she was trying to provide each entity with information about the proposed budget.

She stated that the 1993 budget is \$900,924.00 figured on a parcel count of approximately 86,162 parcels which come to approximately \$10.46 per parcel, for 1994 they are requesting \$1,016,503.00 and are projecting a growth of 9-10,000 more parcels for 1994. This would be a per parcel cost of \$10.59 which would be an increase of only .13 (cents) per parcel. The state average cost per parcel is \$13.08. She added that they are still below the state average.

The comparison sheet that was submitted on the package was based on information received from the State Comptroller's Appraisal District Survey for 1992-93, which shows that they are below either the state average or the average for the Appraisal District in a parcel range or both in car allowance, number of staff, number of field appraisers, salaries for appraisers and salary for chief appraiser. Some of the increase is due to the purchase of new computer and software which was recommended by the State Comptroller's Office in February and which they are paying for these system over a five year period.

The Appraisal District has taken out liability and property insurance which they never had before. It was erroneously believed that the Appraisal District was covered under the county policy, when this was discovered, we took bids and we have been insured under our policy since July 1st.

Ms. Schlinke requested one new appraiser for 1994. This person will be a rural appraiser. She pointed out that they are

mandated to discover all property in the county both real and personal and put this properties on the role and that to her knowledge the rural areas have never be thoroughly worked. There is a large amount of value in house, barns, hunting lodges in the rural areas that have never been on the role. She would like this rural appraiser to get this properties on the role. If she is unable to add a rural appraiser, they will have to take an appraiser that they currently have and this will pull an appraiser away from the city. With the current growth in Laredo we need all the appraisers that we have in the city.

She explained that with the consent of the Board of Directors they have gone to a salary schedule with grades and steps for salaries. Not everyone will be getting a raise in 1994. In the past the percentage across the board increase has been given and she has tried to build these schedules and bring the people up to the level, but that she felt they should be for the degree of responsibility that they have and their job descriptions. The people that she feels that are already at that level will not receive an increase for 1994. Some employees were paid more than their supervisors and they felt this was not justified. The salaries, less the Chief Appraiser's salary, come to an average of increase of four and one-half percent. If you include the Chief Appraiser's salary which is set by the Board of Directors for 1994 the increase would come to 6.3% All appraisers must be certified by the state and this is a five year process which involves many schools and two state exams. The appraisers have to go thru a time limit of five years or they cannot be appraisers. For the ones that are already certified, we require 60 continuing education units every five years, so we do need travel and tuition monies for this.

She continued by saying that 5% of the budget of \$48,405.00 is contingency fund for any unforeseen circumstances such as lawsuits. Any monies not spent will be credited back to the entities.

The budget will automatically go into effect after approval by the board within 30 days if there is no veto by the majority of taxing entities.

The city's estimated contribution for 1994 would be \$163,616.00 based on '92 levies. This will change a little when the three levies come out.

The increase in contributions is due to the increase in the budget as well as the smaller projected fund balance to give back to the entities.

She further pointed out that using current figures, it looks like the city will have a 12% increase in taxable value over last year's. She concluded stating that they should receive their certified roll on the 26th. Motion to excuse Mayor Saul N. Ramirez, Jr., for the rest of the City Council proceedings.

Peter H. Vargas, City Manager, stated that this is a project that goes back a couple of years and it involves the replatting of Mall del Norte. When Mall del Norte came before council for replat of their property to the east of their present buildings to expand the mall, one of the condition that was negotiated was that they in fact would build a perimeter road or ring road that would be built to city specifications in order to facilitate traffic around and thru the mall area. In addition to that the plan, was to extend Calle del Norte from its present location on Springfield to connect to the road that the mall was building. That road has been constructed by the mall and their expansion project is in full swing. Mr. Vargas added that they have contacted the adjoining property owners between the Mall and Springfield to determine when they are going to have a development schedule and they have indicated that the do not have a development schedule as yet, but have no objection to the road being constructed. He stated they are looking at financing mechanisms to be able to accomplish this and that it will be a recommendation in the next fiscal year's budget that the city proceed with the construction of that segment of the road between the Mall and Springfield in order to make that connection.

This project will alleviate some of the congestion that is there currently by providing another east/west corridor. He concluded stating that they have submitted an EDA Grant for the extension of Springfield from that location on Calle del Norte to the north to connect with Spring Road which would make another north/south connector. This will be forthcoming for next fiscal year.

Mr. Vargas recommended to council some form of assessment to the property owners along the route in order to build the road.
