Mr. Murillo added that he is waiting for Mr. Saenz's response as to the funds available.

2. Report on water conservation from Utilities Director.

Cw. Aldridge requested to table this item and bring back for the next regular meeting.

3. Presentation of independent study of the Coopers and Lybrand convention center study by Chuck Owen, President of Laredo Hotel-Motel Association.

Mr. Chuck Owen, President of the Hotel-Motel Association made a presentation before the city council with Mr. Tim Herring, Fernando Cantu, and Dr. Adolfo Kahn against the location of the proposed Special Events Center at the Milo Interchange.

Mr. Jim Whitworth, a local CPA, spoke on the figures presented by the city on the financing of the bonds for this project.

Mr. Tim Herring asked that the Mayor spend more time with them to discuss this matter and asked that the item be tabled for 90 more days.

Dr. A. Kahn spoke against the convention center and question on the financing for this project. He asked that this item be put to the approval of the voters rather than spend \$17 million.

Mr. Edward Dryden spoke before the council in reference to his point that the citizens of this city can not afford to support this event center and favored an election to determine if the voters wanted this facility.

Mr. Ignacio Urrabazo, Chairman of the Chamber of Commerce, spoke before the city council stating that the Chamber was in favor of the concept of a new Special Events Center, but he questioned the study made by Coopers & Lybrand.

Ms. Carmen San Miguel spoke against this project being placed at the Azteca neighborhood.

Mr. Ramiro Ramirez, a local hotel president, proposed that the new center be changed to "Laredo Gateway Arena Center" or "Laredo Gateway Coliseum" and stated that he has no objection to the north site and that any businessman would take the opportunity of 50 free acres for development.

Mr. Simon Villarreal, local citizen, stated that the north site is ideal for this project and that the City Council is on the right track.

Mr. Hilario Cavazos stated that he is in favor of this project and that the opportunity is now for the council to take action.

Mr. David Cortez, former City Councilmember, stated that he had been in favor of this center and that the council should debate no further and go ahead with the project at Milo Interchange.

Mr. Carlos Mejia, of Mejia Engineering, spoke against a convention center close to Bridge I or II due to the traffic congestion problems that would occur.

Mr. Adolfo Puig, representing the Alexander property, stated that the family is willing to put 50 acres across the proposed new LSU/A&M College, south of the Del Mar Blvd. for city negotiation for the new center.

Mr. Peter Vargas, City Manager, made a presentation on six possible site locations that staff has looked at. Those locations are: Central Business District; Azteca; Dye Property; Civic Center Location; Airport; and Milo Interchange & IH35.

Motion that the Azteca neighborhood be left out as any possible location for the new event center.

Moved: Cw. Montalvo Second: Cm. Castaneda

Cw. Aldridge stated that she wanted to go on record as opposing this project the way it stands right now. She stated that she prefers that our funds and obligations be used to upgrade our public services than to build infrastructure for private development. Cw. Aldridge added that the voters should decide what their interests are and what they need.

- E. Request from Councilmembers Blas Castaneda and Eduardo Perales:
  - 1. Status report on police cars.

Chief Granados stated that a report was submitted to Cm. Castaneda.

Cm. Castaneda stated that his concern is making sure that police officers have their cars back in service when they come for minor modifications or service. He added that people are asking that they have the patrol cars out in the community.

Chief Granados stated that they have an average of 15 to 18 vehicles per shift patrolling and that there is an average of 3 to 5 cars that are being serviced on a daily basis. He added that they go in for minor repairs and are usually out the same day. He stated when parts need to be ordered for some vehicles they might have to spend there a couple of days to have them serviced.

Cm. Perales's concern was the availability of extra police cars in case of emergencies. He emphasized that more patrolmen are being welcomed to the force and that additional police cars will be needed.

Chief Granados stated we have 25 new vehicles coming in marked "Police Units." He added we do have 19 new police officers that are still in training and that he does not foresee any problems when we get those new vehicles. Chief Granados stated that four cars are being assigned for the police substations.

- F. Request from Councilmember Eduardo Perales:
  - 1. Discussion on the illumination at Lindenwood and McPherson Drive.

Mr. Vargas stated that these two streets will be included in a study already in progress on illumination needs.

2. Discussion and possible action on median at Del Mar Boulevard and San Dario Avenue (Cm. Liendo)

Motion to send back to P&Z to reconsider the construction of this median by Plannning & Zoning under the plat.

Moved: Cm. Perales Second: Cw. Montalvo

For: 6 Against: 0 Abstain: 0

3. Discussion and possible adjustment for bus route to Riverside Subdivision.

Motion to have EL Metro look at the possibility of changing the bus route from 8:00 to 7:30 because the residents in Riverside Subdivision are having trouble getting to work or school on time. Also that El Metro look into this and report to the effect as the Mass

Transit Board. Cm. Perales turned in a list of signatures requesting the service to the City Secretary.

Moved: Cm. Perales Second: Cm. Liendo

4. Discussion on the need for additional recreational facilities.

Mr. Perales stated that a property on Colorado Street would make a good area for a tennis court and the property next to Mission Viejo Condominiums. He recommended that this ideas be considered and included in the comprehensive master plan.

Jesus Oliveros, Parks and Recreation Director, stated that the proposal have come in for the comprehensive master plan. He added they will select a committee to review these proposals and that they should have a recommendation before council by Feb. 3rd to select a consulting firm to develop the comprehensive master plan.

5. Discussion and possible action on the installation of a traffic signal at Calton Road and Gallagher.

Mr. Perales stated that he knew that a traffic light could not be placed because it was not paved and asked what was its paving status.

Mr. Escudero stated the right-of way map is being prepared between Calton, Hillside and Gallager so that they can obtain the right-of-way and then continue with the paving. Mr. Escudero stated that streets in Calton Gardens that are not paved included San Francisco, Marcella, and Peach. He added these streets are included in one of the paving projects.

- G. Request from Councilmember Blas Castaneda:
  - 1. Discussion on the curtailing of services at the U.S. Consulate in Nuevo Laredo and possible action by the City.

Motion directing staff to write a letter to Washington indicating to the State Dept. that the office in Nvo. Laredo not be curtailed of its services and directing staff to draft a resolution to that effect.
