Mr. Hank Domeracki, Finance Director, made presentation of the area proposed to be leased by the Unicorn Restaurant. He recommended that second floor of the Mercado not be part of the contract. The City will have first choice of occupying or renting the second floor area.

Councilman Castaneda requested an opinion from the attorney as to the legality of leasing the Mercado space, without going out on bids. Martha Martinez, Assistant City Attorney, explained that such lease should not go out for bids, unless it is up for sale or exchange of property.

Councilman Juarez requested that staff return with an overview report of the fair market value.

Councilmember Montalvo expressed her concern regarding the issue of the 3 months free rent, due to the fact that other prospective tenants may request the same consideration.

At this time, City Council proceeded to tour the outside area proposed to be fenced-in by the tenant (Unicorn Restaurant).

Upon their return, Councilmember Ramirez, Jr., stated that a monthly rent of \$10.00 be charged for the use of the outside area.

Motion to approve lease with the following amendments: that the tenant provide insurance, maintenance, and construct fence and that the City has the right to use the outside area; (2) that the City be given a 5-day notice by the tenant to rent the second floor; (3) that the tenant not sub-lease the second floor area of the Mercado: Montaivo
