II. DISCUSSION AND POSSIBLE ACTION ON MERCADO STATUS AND PROSPECTIVE TENANTS.

The following information was provided. The Mercado's first floor consists of $4.756~\rm kg$. ft. and the second (upstairs) floor consists of $3.862~\rm kg$. ft. for a total floor space of $8.818~\rm kg$. ft.

Proposal rent for one of the proposed tenants (Mr. Wong) would be \$1,174 monthly with \$40,000 improvements with a 5 year amortization.

Proposal rent for the other tenant (Unicern) would be \$1,500 monthly with \$48,000 improvements to be paid in 5 years.

Rent for the second floor (upstairs) would be \$1,370 with rental to the Unicors.

Mr. Perales of the Unicorn recommended that each tenant be charged with care of their premises.
