Mr. Sandy Gibson, President of the Laredo Firefighters Assn., and Chairman of the Collective Bargaining Committee, spoke of activities which include 6,354 emergency runs. He requested that City Council instruct staff to return to the bargaining table and approve the salary increase that was proposed to be negotiated through the survey of the 10 cities and also to make the amendments to the contract that was agreed on during the collective bargaining.

City Manager Peter H. Vargas explained the following points in the offer to the Fire-fighters Association:

- 1. On 10/1/89 firefighters will receive a 6% increase in salary.
- 2. On 4/1/90 firefighters will receive an additional 6% increase in salary for a

total of 12% in one fiscal year.

- 3. On 10/1/89, Paramedics will receive an 8% differential increase over base pay (this is a 2% increase over the current amount differential of 6%).
- 4. On 10/1/90 Paramedics will receive a 9% increase over base pay.
- 5. On 10/1/91 Paramedics will receive a 10% differential over base pay.
- 6. The City has agreed to a comparable wage survey of 12 Texas cities and agreed to pay the median wage for firefighters. This is a significant benefit, in that firefighters will be assured of getting an equitable pay plan that pays them the prevailing wage for firefighters.
- 7. The salary, fringe benefits, and working conditions for the positions of District Chiefs and above will be set by the City. In no event will District Chiefs receive less than 5% more than a Captain with over 26 months.
- 8. Education Differential the City will pay 6% of base salary per month for Intermediat certificates. The City will pay 8% of base salary per month for Advanced certificates. The City will pay 10% of base salary per month for Masters Certificates.
- 9. Clothing Allowance \$350 per year.
- 10. Longevity Pay \$5.00 per month for every year of service.
- 11. Leave and sick Leave employees hired after October 1, 1989 will earn 5 days per year for the first two years. After two years they will earn the current rate.
- 12. Association Business Leave each member of the Association will contribute 5 hours of sick Leave per year for a pool of time to be used by the officers of the Association to attend union functions.
- 13. Creation of a Trust fund to provide Health Insurance for retirees and dependents. Each member to pay \$10.00 per month for the Trust.
- 14. Suspensions of three (3) days or less shall be appealed only to the Civil Service Commission. All other can go to Arbitration.
- 15. The offer is for a three year contract.
- 16. Proposal includes a mediation process to assist in getting agreement on future negotiations.
