The budget is high in relation to the services the City obtains. As an example, the City receives over 3,000 pieces of mail annually which averages to about 1.5% of the tax levy. The Appraisal District has the responsibility to verify and correct all addresses and forward a workable tax roll to the City Tax Office. The cost to appraise one piece of property in Webb County is \$10.40 - the State wide average is \$8.60.

BLAS CASTANEDA: "I don't have the exact figures with me here, but I want to make a couple of points in this one. Within the budget itself even though the recommendation would be to reject the budget. We looked at some of the things that I think are important to all of us. Like we did with the City employees. We worked on a package for salary adjustments and benefits and so on, which I think were long over due. I looked at their plan and they are asking for a 6% increase in salaries for the employees in the Appraisal District, which I have no problems with. As a matter of fact, if you look at what we are recommending on the City, we have a 3% plus a 5% adjustment which comes out to an 8%. If the wishes of the Council is to reject it, I strongly ask you to consider that we add some notes to the rejection of this budget. That we have no problems with the adjustments that are being asked for the employees, because I think you all understand the conditions that we had and I think they are entitled to that adjustment. Secondly, there was some mention in there about the employees pension plan, which I also would like for Council to consider that. In making the rejection that we also mention something about spreading the pension for over a two year period of time, so that as they re-work their budget, if that's what needs to be done, that they strongly consider mainting those particular provisions in there.
