## III. CONTINUED CONSIDERATION OF THE 1989-90 BUDGET

Mr. Hank Domeracki, Assistant City Manager, explained the budget in general.

City Manager Peter H. Vargas stated that in 1988-89 the City started with a fund balance of \$2.2 million and is estimated that by the end of this year the ending balance would be \$276,000.

Mr. Alfredo Castillo, Tax Assessor Collector,

projected that the City will have \$6.5 in delinquent taxes. He further stated that he is of the opinion that the City should seek legislative/judicial relief for possible write-off of the \$2.5 in delincuencies, which consist mostly of personal properties.

Councilman Cortez stated that he does not favor a tax increase at this time.

Motion to instruct the City Manager to prepare information that would increase the sales tax revenue from the projected 4% to 6% and that it be included in the budget: Cortez
