This City initiated zoning change was originally scheduled at a Special Planning and Zoning Commission meeting on November 22, 1988. It was recessed to November 28, 1988 and then further recessed to November 30, 1988. At this last meeting, at which six neighborhood residents attended, three persons spoke against the change and 22 petition signatures were received. (Some 1,300 notices were sent).

Following the Commission's discussion for and against the merits of changing all or a portion of the zoning, The Commission voted 4-2 to recommend against any change.

Mr. Ron Whitehawk, City Planner, described the proposed zone change.

Mr. Hector Hernandez and Mr. Cande Gonzalez, area residents, spoke against the zone change.

Councilman Blas Castaneda, stated that most of these blocks are in his district and some of his constituents do not write or speak the English language. Thus, there was no response given regarding the zone change. He further recommended that this area should remain R-3.

Councilman Liendo also spoke to the issue by stating that if there were affordable housing, the problem of the mobile homes would not be so great.

Mayor Tatangelo stated that he is not against mobile homes, but will continue to work for affordable housing.

D. Consideration of the facility plan and environmental
(1517.1) impact of the North Laredo Wastewater Expansion Project
(Del Mar Plant). This public hearing is required
to be eligible for a \$1.5 million loan from the Texas

Water Development /Boards' State Revolving Loan Program. The project consists of expanding the plant from 426,000 to 1 million gallons per day and construction of an 8" effluent line from the plant to the Casa Blanca Golf Course for irrigation.

Mr. Doug Eckmann, S. A. Garza Engineers, explained the project and stated that one of the problems that presently exists is that the north Laredo Treatment Plant is overloaded at this time. The plant has a capacity of 426,000 gallons per day. The effluent from this treatment plant is currently being used to irrigate the Laredo Country Club golf course. Also, in the past, some of the effluent was transported to the Killam ranch land. The cost of the project is approximately \$1.5 million. Mr. Eckmannfurther indicated that the City has a 40 year contract with the Country Club, but no other entity. Most of the effluent will be used for irrigation.

Mr. J. R. Mathis, Laredo Waterworks Director, concurs with the Engineer's proposal.

E. To consider establishing a 25 ft. building line on (2585.1) Mann Road west of Santa Maria. The set-back line is needed to insure the building's are built back from the 60 ft. right-of-way. On November 7, 1988, the Planning Commission recommended approval.

ESTABLISHING A 55 FT. BUILDING SETBACK LINE TO THE NORTH AND THE SOUTH OF THE CENTERLINE OF MANN ROAD (PORCION AVENUE) BETWEEN SANTA MARIA AVENUE AND ORILLA STREET; PROVIDING FOR FUBLICATION AND EFFECTIVE DATE. Property owners along this section of Mann Road have been notified.

Staff presented a brief explanation of the area involved.

Mr. Jorge Trevino, property owner, spoke against the issue on behalf of his family that also own property on Mann Rd., between the two railroad tracks.

Mr. Efren Gutierrez and Mrs. Amparo Gutierrez, property owners, spoke against the proposed set-back requirements.

City Manager Marvin Townsend explained that "when we say a building set back, we are only talking about a place where a new building should not be built. Now, the set back is not part of the street, and the City does not have a right to put a street on a set back. We are only talking about a public right-of-way being 60 ft. wide, 30 ft. on both sides of the center line. But throughout the entire City there is a requirement that a building be set back from the street, so that all new construction sets back 25 ft. from the public right-of-way."

Councilman Cortez stated that property owners prefer street pavement to be as narrow as possible, and that they would agree to the fact that either on the north or the south side of the first block, that it be "no parking". Thus there will be no need to take additional properties that would be used for parking. He further requested that the first block (railroad to railroad) be treated separately from the rest of the properties.

This public hearing was called as a result of the City Councils' motion on November 7, 1988 and duly advertised. On November 21, 1988 the City Council declined to set the date for the second public hearing by a vote of 4 to 3. The Planning Commission at its meeting on December 1, 1988 voted to recommend no action. A new elementary school being built by the United Independent School being built by the United Independent School District and the Rio Bravo and El Cenizo Subdivisions will be within 5 miles of the City and thus within the City platting review jurisdiction, if the area is annexed. The land involved is unplatted agricultural

land. The new school will cause more development of sub standard areas without sewer service, with inadequate water for fire protection and inadequate streets and drainage.

Mr. Richard Haynes, property owner, spoke against the proposed annexation.

Mr. Victor Oliveros, Health Department, stated that there is a sewer plant operating in El Cenizo Subdivision. Another sewer plant is being built next to Rio Bravo. The owner of said property stated that it was not a sewer plant, but a swimming pool. It was also estimated that the sewer plant would hold 450 to 600 gallons, compared to El Cenizo sewer plant which holds 375 to 400 gallons.

Mr. Richard Haynes, also informed City Council that a platted subdivision existed in that area know as "One River Place". The subdivision is situated on Highway 83, about 1-1/2 miles from the present City Limits.

He also stated that citizens do not use or walk through the Tatangelo Park because most of the time people are sleeping there, and area merchants use the Park and sidewalks to receive and sell their merchandise.

City Manager Townsend stated that it is frustrating for a Policeman to tell somebody to move a bundle of clothes or merchandise from the sidewalk or street and that person simply moves a couple of steps and drops the merchandise again. The Policeman cannot take these violators to jail. Mr. Townsend further

stated that there needs to be a full time Municipal Judge and that kind of a person needs to be brought directly to the Judge and impose justice right there.

- X. REPORTS. It is recommended that:
- (2330.3)A. A contract amendment be approved with Automatic Toll Systems, Inc. to close out the original contract dated September 1, 1981 and subsequently amended on November 25, 1985. The amended contract was for \$779,113 and included installation of an automated toll collection system for Bridge II and I. A substantial portion of the contract, including automatic toll gates, toll booths, counters, automatic coin machines, and treadle frames has been installed at Bridge II and has been in use since 1983 for which the City has paid \$654,441.39. The computerized toll reporting system, however, has never worked satisfactorily.

On November 25, 1985 a contract amendment was approved postponing any future work on Bridge I and providing Automatic Toll System with additional time to satisfactorily complete the work at Bridge II. Automatic Toll Systems and city staff agree that the computerized toll reporting system cannot be placed in operation satisfactorily and that this contract should be terminated with the following stipulations:

- 1. Final payment of \$94,699.61 of retainage for work completed on Bridge II be approved for a total payment of \$749,141.00.
- 2. Automatic Toll Systems, Inc. remove the computer hardware system from Bridge II and establish a City credit of \$39,050. This credit would be available for a period of 2 years and may be used by the Bridge system to purchase based on 1986 prices. These parts are needed for maintenance of the automatic toll system at Bridge II.
- 3. Automatic Toll System provide a warranty for parts and tabor for one year.

Mr. Florencio Pena, Assistant City Manager, stated that the grant is still available, and the city had obtained EDA's agreement to to apply it to Tracor's second request, for a 100,000 square feet building. He further stated that the city would again write EDA, seeking approval to apply it to the third plan but expects no problems.

Staff further stated that the remainder of the project would

be backed by airport special facility revenue bonds, or a combination airport revenue and tax-supported certificates of obligation.

Councilman Cortez requested clarification to the matter of sub-leasing by the tenant.

Acting Chairman Jacinto Juarez explained that council needs to evaluate the various ways to finance the new construction, but, "if we really want them to stay, we will find a way to finance it."

Mayor Aldo Tatangelo reiterated his sentiments that the City should be willing to take a risk to keep Tracor in Laredo, no matter what their stipulations.

The only two ways that the City can finance this project

- 1. Airport Special Facility Revenue Bonds, and
- 2. Combination Airport Revenue and Tax Supported Certificates of Obligation

In both cases the City will have to have the public purpose of these bonds validated, either by the State legislature or the Courts. In both cases the bonds or certificates of obligation will be taxable.

Airport Special Facility Revenue Bonds seem to be only practical if local bankers agree to purchase the bonds based on the 20 year Tracor lease and Airport Revenue. Since the City will own the building, the only collateral that the banks will have for this building is the security from the Tracor lease and the pledge of the Airport revenues.

Combination Airport Revenue and Tax Supported Certificates of Obligation (C.O.s) seem to be the best alternative for financing this project. The security that the bond buyers would have if C.O.s would be the full faith and credit of the City, (i.e., City taxes). Again, C.O.s can only be sold if it is determined that the use of the proceeds will be for a public purpose.

Assuming that the City can get the proceeds from these certificates to be declared for a public purpose, the following C_*O_* sale schedule would need to be implemented:

- 1. December 19, 1988 Public Hearing Inquiry
- 2. January 3, 1989 Notice of Intention to sell C.O.s needs to be adopted.
- 3. February 6, 1989 Introductory Ordinance to seil C.O.s needs to be adopted.
- 4. February 20, 1989 Final reading and passage of Ordinance to sell C.O.s.
- 5. February 21, 1989 Bond Attorney files Validation Suit to have the bonds declared valid for public purpose.
- 6. About April 1, 1989 Court rules in City's favor. Bids are taken on the C.O.s. and
- 7. April 3, 1989 C.O.s are sold.
