ADOPTING THE BUDGET FOR FISCAL YEAR 1987/1988; APPROPRIATING THE ESTIMATED REVENUES AND BALANCES REPORTED THEREIN FOR THE YEAR BEGINNING OCTOBER 1, 1986 AND ENDING SEPTEMBER 30, 1987, CONSISTENT WITH THE FINANCIAL PLAN DESCRIBED IN SAID BUDGET; AND AUTHORIZING THE CITY MANAGER TO IMPLEMENT SAID BUDGET.

B. APPROVING THE 1987 TAX ROLL AND PROVIDING FOR THE LEVY AND COLLECTION OF GENERAL AND SPECIAL AD VALOREM AND OCCUPATION TAXES FOR THE CITY OF LAREDO FOR THE TAX YEAR 1987 AND FISCAL YEAR 1987-88.

Regarding a property tax increase of 7.9% over the effective tax rate of \$.3985 to \$.4303. The 1986 tax rate was \$.3851. Revaluations decreased the 1987 tax roll by \$53,118,925. The effective tax rate of \$.3895 represents the rate that when applied to these reduced values will generate tax revenues equal to those generated the previous year.

- (2433.1) CM. SANTOS BENAVIDES: "Do you think we can go with it, even if we go with the tax increase?"
 - CM. JUAREZ: "On the issue of deleting the \$130,000 for the computer: and this is my opinion and only my opinion, that it would be moving us backwards and next time around we won't have information and we we'll be in the same position that we are in right now, where we cannot control our expenditures, where we cannot evaluate our performance. I really believe that if our City Manager had the right tools he would be more efficient and more effective even though he is a brilliant person he is only one individual and if he tries to do everything without the proper tools I think that it is only defeating everything that we are trying to do. And I have one question for Mr. Townsend, "Have you looked into consolidations of departments in your proposal that's coming before us?"

MARVIN TOWNSEND: "Yes Sir?"

CM. JUAREZ: "What departments are we consolidating?"

MARVIN TOWNSEND: "It is not our recommendation that departments be consolidated. The organization of any governmental or private entity has to be built around people. As people gain in their capacity to handle their jobs, some end up with a capacity to take new tasks, other don't.
