 2 would only apply to the Union National Bank expansion and  
 3 parking facility. Approximate cost of the acquisition  
 4 of Block 59 is \$100,000. The deadline for submitting  
 5 the UDAG application is March 31, 1985.

6 Motion to close the Public Hearing was made by
