ANNEXATION HEARING

A Public Hearing on proposed annexation of areas comprising approximately 957 acres along Highway 83 was conducted on June 14. 1983 at 7:30 P.M. at Riverside Mobile Home Park, with the following members thereof present, to wit:

(NOTE: Preceding the Hearing, a bus tour of the area including the new sewage treatment plant was taken).

Mayor Pro-Tem, Carlos A. Zunida opened the hearing by stating that the purpose was to allow area citizens to voice their ideas or opinions regarding the proposed annexation.

Mr. Carlos Villarreal, Director of Community Development

Department, and Mr. Larry Vetter, City Planner, made a presentation
elaborating on the areas involved and services which would become
available after annexation. A map designating the boundaries to
which the annexation would be extended was available for inspection.
Several departments were represented and were ready to answer
questions from those attending.

Mrs. Zulema Miller, an area resident, asked whether response time from Police Department would be as prompt as was now available from the Sheriff's Office. She further expressed concerns regarding the rising burglaries and prowler activities coupled

with alien crossings thru that area. Another resident, Mr. Aguirre, also expressed similar concerns, and asked whether additional police officers were to be hired.

Manager Townsend explained that the Sheriff could continue providing services as well as the Police Department, Mr. Joel Newman also voiced his concerns regarding trash collection.

Mayor Pro-Tem Zuniga told those present that zoning was presently being considered and that the residents could have input at the hearing to be announced in the near future,

Manager Townsend gave a lengthy explanation on the annexation, further stating that citizens had the right to ask to be deannexed if in the future they were not satisfied.

Mayor Pro-Tem Zuñiga thanked those in attendance and reminded them of another similar hearing on this proposed annexation to be held during the Regular City Council Meeting of June 21, 1983.

Motion for closing of the hearing was made by Councilman Montalvo with the second by Councilman Benavides. Those councilman members present voted in favor,
