With a quorum present, the Mayor called the meeting to order and the following proceedings were carried out.

A REQUEST

FOR EXECUTIVE SESSION AND POSSIBLE COUNCIL ACTION ON THE SELECTION OF A CITY MANAGER FOR THE CITY OF LAREDO WITH POSSIBLE RECESS.

Councilman Zuniga asked if the three manager candidates were still available, and which method the Council was to use in selecting the new manager. It was decided that:

three (3) points be given to their first choice;
two (2) points be given to their second choice;
one (1) point be given to their third choice;

The Personnel Director was asked to contact Mr. Townsend to see when he could be available. Miss Solis proceeded to reach him by phone, but was unsuccessful. She will attempt to reach him the following day.

Councilman Zuniga then made the motion for adjournment and was seconded by Councilman Cortez. All being in favor meeting adjourned, at 6:05 P.M.
