With a quorum present, the Mayor called the meeting to order and the following proceedings were carried out:

The first item was an ordinance amending the budget for fiscal year 1980-1981 to reflect an increase in sales taxes from \$4,350,000.00 to \$4,650,000.00, account #01-0130-0000-0000.

Alderman Zuniga made a motion to adopt the ordinance. Alderman Sanchez seconded the motion and all were in favor.

AN ORDINANCE

AMENDING THE BUDGET FOR FISCAL YEAR 1980-1981 TO REFLECT AN INCREASE IN SALES TAXES FROM \$4,350,000.00 TO \$4,650,000.00, ACCOUNT #01-0130-0000-0000.

The Mayor declared in open meeting that the ordinance had passed.

Next was an ordinance approving the proposed construction of a third neighborhood health center to be known as the Farias Neighborhood Center at a projected cost of \$130,000.00; authorizing the Mayor to enter into contract with Leyendecker-Cavazos to provide architectural services for the same.

Alderman Zuniga made a motion to adopt the ordinance. Alderman Sanchez seconded the motion and all were in favor.

AN ORDINANCE

APPROVING THE PROPOSED CONSTRUCTION OF A THIRD NEIGHBOR-

HOOD HEALTH CENTER TO BE KNOWN AS THE FARIAS NEIGHBORHOOD CENTER AT A PROJECTED COST OF \$130,000.00; AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT WITH LEYENDECKER-CAVAZOS TO PROVIDE ARCHITECTURAL SERVICES FOR THE SAME.

The Mayor declared in open meeting that the ordinance had passed.

The following was an ordinance authorizing the removal of parking meters, numbers ES 22, ES 24 and ES 26 from the 900 block of Farragut Street.

Maria Elena Quintanilla, Assistant City Attorney, stated that the LNB would pay for the loss in revenues on the parking meters.

Alderman Sanchez made a motion to adopt the ordinance subject to payment from the Laredo National Bank to the City of Laredo for the loss of revenues. Alderman Benavides seconded the motion and all were in favor.

AN ORDINANCE

AUTHORIZING THE REMOVAL OF PARKING METERS, NUMBERS ES 22, ES 24, AND ES 26 FROM THE 900 BLOCK OF FARRAGUT STREET.

The Mayor declared in open meeting that the ordinance had passed.

The last item was an ordinance authorizing the Mayor of the City of Laredo to negotiate and enter the necessary agreements with the Laredo National Bank for the use of certain City sidewalks and streets.

Alderman Zuniga made a motion to adopt the ordinance. Alderman Sanchez seconded the motion and all were in favor.

AN ORDINANCE

AUTHORIZING THE MAYOR OF THE CITY OF LAREDO TO NEGOTIATE AND ENTER INTO THE NECESSARY AGREEMENTS WITH THE LAREDO NATIONAL BANK FOR THE USE OF CERTAIN CITY SIDEWALKS AND STREETS.

The Mayor declared in open meeting that the ordinance had passed.

With no further business to discuss, Alderman Sanchez made a motion to adjourn.

Alderman Trevino seconded the motion and all were in favor. The meeting was ajourned
