With a quorum present, the Mayor called the meeting to order and the following proceedings were carried out:

\*

The minutes of the Regular City Council Meeting of September 15, 1981 were presented for City Council approval.

Alderman Trevino made a motion to approve the minutes as read. Alderman Flores seconded the motion and all were in favor.

\*

Under Communications, a letter from Ernst & Whinney was read by Gustavo Guevara, Jr., City Secretary.

In summary, the letter stated that on October 12, 1981 they had submitted a progress report related to the computer, computer system, implementation of the 1981 EDP Plan and what has been accomplished to date. The purpose of this letter was to report the status of the audit of the City's June 30, 1981 financial statements.

The letter stated they had met with the Mayor and City Comptroller to review the final draft of the City's June 30, 1981 audit report and were requested to present the results of their examination on November 17, 1981. After such presentation, they will hold a workshop to discuss in detail the results of their examination.

The next item was a request by the Laredo Federation of Teachers to appear before the City Council to make a presentation on their request for middle income housing.

Mrs. Ernestina Pulido, President of the Laredo Federation of Teachers, made the presentation before the Council. Mrs. Pulido requested and urged the governing body of Laredo, Texas to direct its attention, efforts and powers and whatever monetary resources shall be available to solicit, procure, or encourage the construction of new housing that will be within the income level of the middle income citizens of Laredo.

Alderman Cantu pointed out that the Laredo Housing Finance Corporation which was approved by the City Council in a past meeting was created for the purpose of helping in the interest rate area for financing to middle income housing. He requested that anyone interested should attend the corporation meetings.

Following was a request by Incarnacion Guerra to appear before the City Council for discussion on Civic Center rental procedures.

Mr. Incarnacion Guerra was not present.

Alderman Cantu made a motion to remove the item from the meeting. Alderman Flores seconded the motion and all were in favor. He stated that this item is in litigation.

Next was an ordinance approving and adopting the Districting Plan by the Districting Commission. Said plan providing for eight (8) districts and showing the voting precinct for said Districts, providing for publication and providing for effective date.

Alderman Sanchez made a motion to adopt the ordinance approving and adopting the Districting Plan. Alderman Cantu seconded the motion and all were in favor.

The Mayor declared in open meeting that the ordinance had passed.

Following was an ordinance setting the tax rate on all taxable property subject to taxation by the City of Laredo for each hundred dollars (\$100) of assessed value for the tax year beginning January 1, 1981.

Mr. Ruben Cortez, City Tax Assessor, explained to the Council that they can adopt a 37¢ per \$100 valuation or 38¢ per \$100 valuation.

Alderman Sanchez made a motion to adopt the ordinance setting the tax rate on all taxable property subject to taxation by the City of Laredo at Thirty-seven Cents (.37) for each one hundred dollars (\$100) of assessed value for the tax year beginning January 1, 1981. Alderman Guerra seconded the motion and all were in favor.

AN ORDINANCE

SETTING THE TAX RATE ON ALL TAXABLE PROPERTY SUBJECT TO TAXATION BY THE CITY OF LAREDO AT THIRTY-SEVEN CENTS (.37) FOR EACH ONE HUNDRED DOLLARS (\$100) OF ASSESSED VALUE FOR THE TAX YEAR BEGINNING JANUARY 1, 1981.

Alderman Cantu seconded the motion and all were in favor.

The Mayor declared in open meeting that the ordinance had passed.

Following was a public hearing and City Council action on certain described areas of the City of Laredo as "blighted areas" (The "Redevelopment Areas") for the purpose and under the provisions of Article 5190.6, as amended, Vernon's Texas Civil Statutes and the regulations of the Texas Industrial Commission.

Mr. Polo Botello appeared before the City Council on behalf of the Laredo Industrial Development Foundation.

The areas described in the "blighted areas" are:

(1) Re-Development Area One: All of the property located within the boundaries of the Laredo International Airport excluding residential areas and beginning at the intersection of Zacate Creek and the Rio Grande on the East side of Zacate Creek going Northwest along the Zacate Creek to Monterrey. Proceed North on Monterrey to East Frost. Proceed West on East Frost to Barcelona. Proceed North on Barcelona to Canal Street West. Proceed West on Canal Street West to IH-35. Proceed West across IH-35 to San Bernardo. Proceed North on San Bernardo to Los Isauros. Proceed West on Los Isauros to Santa Maria. Proceed South on Santa Maria to Pace. Proceed East on Pace to San Agustin. Proceed South on San Agustin to Frankfort. Proceed West on Frankfort to Santa Maria. Proceed South on Santa Maria to Washington. Proceed West on Washington to Santa Isabel. Proceed South on Santa Isabel to the Rio Grande River. Proceed East along the Rio Grande to the original starting point.

(2) Re-Development Area Two: Beginning at the intersection of Jarvis and Blaine go East on Blaine to Milmo. Proceed South on Milmo to Pecan. Go West on Pecan to Martin. Proceed South on Martin to Saltillo. Go West on Saltillo to Bartlett. Proceed South on Bartlett to Palo Blanco. Go West on Palo Blanco to Urbahn. Proceed South on Urbahn to Thurman. Go West on Thurman to Buena Vista. Proceed South on Buena Vista to the city limits. Proceed West along the city limits to the West side of Highway 83. Go North along the West side of Highway 83 to Hall. Proceed West on Hall to Meadow.

Go North on Meadow to Bayart. Proceed East on Bayart to the West side of Highway 83. Go Northeast along the West side of Highway 83 to Meadow. Proceed North on Meadow to San Salvador. Go East on San Salvador to Bartlett. Go North on Bartlett to Bismark. Proceed from Bismark across Chacon Creek to the intersection of Boulanger and Jarvis. Proceed on Jarvis to Blaine.

Alderman Cantu made a motion to adopt additional area on the South side on resolution designating the "blighted area" zones for commercial use of Industrial Revenue Bonds passed on October 14, 1981.

Next was an ordinance adopting the budget for the expenditure of Federal Revenue Sharing Funds received by the City of Laredo for the Thirteenth XIII Entitlement Period and appropriating the amount of \$1,767,440.

Alderman Flores made a motion to adopt the ordinance. Alderman Cantu seconded the motion and all were in favor.

Abraham Rodriguez, Director of the Laredo Housing Authority, made the request before the City Council.

Alderman Zuniga made a motion to adopt the resolution designating blocks 771 and 840 on the Eastern Division for the use of such as a site for public housing. Alderman Guerra seconded the motion and all were in favor.

Following was the Mayor's veto of the Land Development Ordinance amendment to Chapter 6, Section 6-3 (c) (1) reducing the minimum number of mobile home spaces in Mobile Home Parks from 25 to 12.

The Mayor stated that he was vetoing the ordinance passed on October 20, 1981 in view of the fact that the Land Development Ordinance which this City Council passed September 2, 1980 was a carefully considered enactment designed to provide for the orderly development of the land for land use planning in our City in the absence of, then as now, a comprehensive plan for the City and a zoning ordinance for the City. He stated that the Land Development Ordinance is guided by long-term, not short-term, objectives for the development of our City. Also, he stated that an important aspect of the Land Development Ordinance was, and is, the regulation of mobile home parks and mobile home use in our City. The Mayor stated that in his view, the result was a reasonable accommodation between the public welfare and the rights of private property. He stated that in his opinion the Council action of October 20, 1981, would effectively vitiate that effort as expressed in our Land Development Ordinance. He said it would eviscerate the definition of mobile home parks which was so carefully arrived at in the Land Development Ordinance.

Alderman Ramos made a motion to override the Mayor's veto. Alderman Guerra seconded the motion and it was prevailed by the following vote:

YEAS: Aldermen Flores, Zuniga, Ramos, Trevino, Guerra and Sanchez.

NAYS: Aldermen Cantu and Benavides.

#### AN ORDINANCE


