Resolution approval of the City Council on the endorsement for the Residential Education and Training Center to be established in Laredo.

Sharon Trigo to present to the City Council a petition to modify a Municipal Ordinance of May 17, 1966 which prohibits sale of beer for on-premises consumption within three hundred (300) feet of any church, school or hospital to change to say "any Alcoholic Beverages." Request authorization by C.D.A. for City to contract with Turner-Hickey Architects for drawing specifications for the Santo Nino Park Development.


Request authorization by C.D.A. for plan change to install sewer line adjacent to Santo Nino Neighborhood Facility and Park Development.


