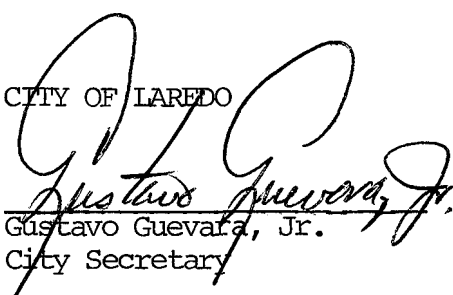
APPROPRIATION ORDINANCES:

- II. Second reading of the proposed rate increase, amendment to Ordinance by the Vumore Co. of Laredo, said increase will have second voting action by City Council.

- III. Mayor to name Committee for the purpose of establishing guidelines and meeting with agencies that request funding from the City as authorized to him by Council approval on 9/5/78.
- IV. Action by City Council approving a selection of 25 proposed Charter revision Commissioners to be submitted to voters of the City of Laredo at a Special Election of November 1, 1978.
- V. Request by Ruben O. Garcia to present a petition from the residents of Springfield Avenue in Hillside requesting the City of Laredo to place a speed control device.
- VI. Request from the Citizens for Progress of ward four seeking relief from public thoroughfares blockage by railroad companies doing business within the City of Laredo in violation of Vernon's Civil Statutes 6701D-5, 1977-1978.
