- II. REQUEST BY MR. LUIS CRUZ OF 214 DAVIS TO APPEAR BEFORE THE CITY COUNCIL TO SEEK PAYMENT OF \$310.00 FOR DAMAGES DONE TO HIS CAR WHEN IT FELL INTO A HOLE AT THE CORNER OF ZARAGOZA & DAVIS.
