
APPROPRIATION ORDINANCES:

- I. REQUEST BY MR. LUIS CRUZ OF 214 DAVIS TO APPEAR BEFORE THE CITY COUNCIL TO SEEK PAYMENT OF \$310.00 FOR DAMAGES DONE TO HIS CAR WHEN IT FELL INTO A HOLE AT THE CORNER OF ZARAGOZA AND DAVIS.
- II. REQUEST BY THE FIRE CHIEF FOR AN ORDINANCE APPROVAL BY CITY COUNCIL ON THE PURCHASE OF TWO (2) 549 INTERNATIONAL ENGINES AND RELATED EQUIPMENT FROM INTERNATIONAL HARVESTER COMPANY OF SAN ANTONIO, TEXAS AND AUTHORIZING THE MAYOR TO ENTER INTO NECESSARY PURCHASE ORDER CONTRACT FOR THE ACQUISITION OF SAID EQUIPMENT.
