Pursuant to resolution of the City Council of the City of Laredo, Texas adopted on the 4th day of June, 1973, a call for bids is hereby made.

Sealed bids addressed to J.C. Martin, Jr., Mayor, at the office of the City Secretary of the City of Laredo, will be received until 10:30 A.M., on the 19th day of June, 1973, and at that time publicly opened and read at a meeting of the City Council at the Council Chameber in the City hall, on the furnishing of the follwoign gasoline requrments for the City of Laredo as needed, for a period of six months, beginning on the 1st day of July, 1973, and ending on the 31st day of December, 1973.

REGULAR GRADE GASOLINE

ITEM NO. 1:

Octane Number, Research, Min. 100.0 Premium

Bids will be submitted in sealed envelopes with the name of bidder and the items being bid plainly endorsed thereon.

It is understood that this bid and the Contract made by reason thereof if nay, shall be subject to all laws, rules and regulations made by the United States Government, or any of its departments, which shall be prior and superior to any contract made between this bidder and the City of Laredo, Texas, based on the prices herein quoted.

Approximate Quantity to be used:

160,000 gallons (Regular – Item 1)

70, 000 gallons (premium -- Item 2)

Quote a firm price, excluding federal tax, but including state tax for delivery.

All gasoline purchase will be paid within thirty (30) days after receipt of invoice. Invoice shall have attached the necessary federal Tax Certificates to be executed by City.

All gasoline furnished by successful bidder shall be of a grade not lower than the specifications set forth above.

The City of Laredo reserves the right, agreed to by the bidder herein, to cancel the contract if it is found that any delivery to the City of Laredo of gasoline is of lower grade than is set out in the specifications set forth above or if at any time service is not satisfactory.

The City may purchase gasoline in "Split-Loads" dividing the quantities needed between Premium grade and Regular Gasoline, and the Successful bidder will be required to deliver such quantities as ordered.

Premium gasoline must be delivered to the City Shop located at Ft. McIntosh in Laredo, Texas, and the Regular gasoline must be delivered to the City Street Department at 402 Moctezuma Street in Laredo, Texas.

Gasoline deliveries may be made by transport truck delivery with maximum loads not to exceed 6200 gallons with deliveries to be made within three (30) days after receipt of order.

If successful bidder fails to deliver an order for three (3) days after receipt of verbal or written order, the City reserves the right to purchase said order locally at any price and charge the contractor of successful bidder the difference between the contract price and purchase price.

Each Bid shall be accompanied by a certified check in the amount of \$500.00 payable to "J.C. Martin, Jr., Mayor of the CITY OF LAREDO", as a gurantee that the bidder, if successful, will enter into a contract in accordance with the terms and conditions of accepting bid, said check to be returned promptly to unsuccessful bidders.

A RESOLUTION APPROVING THE POSITION OF THE "MAYOR'S SPECIAL COMMITTEE" OF THE CITY OF LAREDO AND COUNTY OF WEBB IN CONNECTION WITH THE ANNOUNCED CLOSING OF LAREDO AIR FORCE BASE, AND ADOPTING ON BEHALF OF THE CITY COUNCIL THE RECOMMENDATIONS IN THE RESOLUTION OF THE MAYOR'S COMMITTEE ATTACHED TO THIS RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO.

WHEREAS, the announced closing of the Laredo Air Force Base was with-

Out warning to this community and the closing of said facility will create a severe economic impact on many facets of the community life including increasing the chronic unemployment rate of this area; and

WHEREAS, the Mayor's Special Committee of the City of Laredo, and County of Webb, in the State of Texas, has by Resolution, a copy of which is attached hereto and incorporated herein, urged the President and the Secretary of Defense to reconsider with almost urgency the proposed closing of the Laredo Air Force Base to the end that such decision should by modified to one of the alternatives set out in said Resolution of the Mayor's Special Committee whereby the Base could either by continued in operation or as a last resort the closing of said facility be extended for a sufficient time to enable the community to make affective plans to convert the Base assets to the most productive utilization, and granting immediate assistance to the several thousand families adversely affected though loss of employment resulting from said closure; and

WHEREAS, the City Council is of the opinion after due consideration, That the recommendations in the attached Resolution of the Mayor's Special Committee by presented to the appropriate federal authorities in an effort to reverse or in the alternative to ameliorate the effect of said closing on the City of Laredo and County of Webb:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY LAREDO:

- 1. That the attached Resolution of the Mayor's Special Committee of the City of Laredo and Councy of Webb in connection with the closing of Laredo Air Force Base in Laredo, Texas, be hereby approved and adopted by the City Council evidence its unanimous support of the position stated in the Resolution of the Mayor's Special Committee.
- 2. The City Council further supports all efforts necessary to carry out the recommendation in the attached Resolution of the Mayor's Special Committee and to bring said recommendation to the attention of the appropriate federal authorities in Washington.
