IV. AGENCY PRESENTATIONS

A. Application Process

Janice Weber, Library Director, gave a brief description of the application process for third party funding from the City of Laredo. Mrs. Weber stated that a letter had been mailed out on Wednesday, April 29, 1998, which notified each agency that applications were ready to be picked up and that the deadline for the application would be Monday, June 1st, most of the agencies met the deadline.
