

CITY OF LAREDO RESOLUTION No. 93-R-048

A RESOLUTION CONFIRMING APPOINTMENT AND REAPPOINTMENT BY THE MAYOR OF THE MEMBERS OF THE FOLLOWING BOARDS AND COMMISSIONS: FIVE MEMBERS TO THE HISTORIC DISTRICT/LANDMARK BOARD; ONE MEMBER TO THE BUILDING STANDARDS BOARD; THREE MEMBERS TO THE LAREDO URBAN TRANSPORTATION STUDY; AND THREE MEMBERS TO THE ELECTRICAL EXAMINING BOARD.

WHEREAS, persons serving as a member of many Boards and Commissions of the City of Laredo are appointed by the Mayor subject to confirmation by the City Council; and

WHEREAS, the members of the City's Boards and Commissions render a valuable service to the citizens of the City of Laredo; and

WHEREAS, the appointment and reappointment of the members of certain Boards and Committees is presently required;

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Laredo that the following appointments may by the Mayor are confirmed and ratified, and that the term of the appointment shall be as resolved herein.


Section 1. The following persons are appointed to the Historic District/Landmark Board for terms ending on the first Tuesday in July, (July 4, 1995). Mrs. Rose Trevino; Mr. Jose Diaz de Leon; Mrs. Elia Pruneda; Mr. Larry Friedman; and Mr. Fernando Salinas. One member Ms. Sharon Jordan is appointed to serve until July 7, 1994.

Section 2. On August 24th, 1992 five members and two alternates were appointed to the Building Standards Board pursuant to resolution No. 92-R-090. One member has resigned from the Building Standards Board. Mr. Eleuterio Garza is appointed for a term ending April 7th, 1996.


Section 3. The Mayor and three council members represent the City on the Laredo Urban Transportation Study (LUTS), with the Mayor serving as chairman. The State Representative, State Senator, District Engineer and two representatives of the County of Webb constitute the remainder of the LUTS. The following three members are appointed or reappointed: Cm. Felipe Cardenas, Cm. Jose Perez and Cm. Cecilia Moreno.

Section 4. The Electrical Examining Board consists of three voting members appointed by the Mayor subject to confirmation by the Council for two year terms and two ex-officio members, the Senior Electrical Inspector and Central Power & Light.. The following persons are members are appointed for terms expiring the first Tuesday in April 1995: Mr. Ricardo Alonzo, Mr. Ricardo Guerra and Mr. Ruben Cantu.



**APPOINTING OR REAPPOINTING THE MEMBERSHIP OF

Section 4. The following persons are designated as alternates who shall serve in the absence or disability of any member, and who shall be entitled to vote when serving in such capacity:


