Speakers may not pass their minutes to any other speaker. Comments should be relevant to Advisory Committee business and delivered in a professional manner. No derogatory remarks will be permitted.

  - C. CONSIDER THE RECOMMENDATION NOT TO PLACE UNSTERILIZED ANIMALS FOR ADOPTION, ESPECIALLY CATS, WHO CAN GO INTO HEAT AS EARLY AS THREE MONTHS OF AGE. RELYING ON THE ADOPTER TO BRING BACK THE ANIMAL IS UNRELIABLE AND RISKY. WE LIVE IN A COMMUNITY WHERE STERILIZATION IS NOT A PRIORITY. DOGS ARE MORE ACCESSIBLE TO CONSTRAIN, BUT NOT CATS.
  - D. RECOMMEND THAT LACS ASSIGN PERSONNEL TO FOLLOW UP ON ADOPTED ANIMALS AND ANIMALS THAT RESCUE ORGANIZATIONS CAN TAG. HAVING ASSIGNED INDIVIDUALS FOR THESE DUTIES CAN HELP THE EMPLOYEES CONCENTRATE THEIR EFFORTS ON ACCOMPLISHING THESE TASKS AND FACILITATE COMMUNICATION BETWEEN RESCUE ORGANIZATIONS AND LACS.
  - E. RECOMMEND THAT THE DIRECTOR MEET WITH THE LPD TO DISCUSS HOW THEY CAN WORK TOGETHER TO ENFORCE THE ANIMAL CODE ORDINANCES. (HAVE PRESENT AT THE MEETING THE POLICE DEPARTMENT OFFICER WHO HAS THE AUTHORITY TO ENFORCE POLICIES AND WHO WORKS DIRECTLY WITH LACS)

## Angie Ancira Agenda Items

Things I would like to be discussed in the meeting.

- A) paperwork of animals leaving shelter needs to be checked for updated vetting (past due tick/ flea, no rabies, missing microchips, etc)
- B) All employees (especially the ones at the window) need to provide friendly guest service, greet visitors, and acknowledge their presence
- C) proper friendly greetings need to be used when answering phones
- D) Rescuers picking up animals to leave shelter need to be advised if animals are not ready. It's a waste of rescuer's valuable time to get there and be told animals are not ready. COMMUNICATION!
- E) Emails need to be read DAILY and answered promptly to rescues wanting to tag. Rescues are getting discouraged to tag for rescue because their emails are being ignored.
- F) Employees at shelter need to be properly trained in regards to what is the process to release animals. They want respect, but Rescuers deserve the same respect. Rescuers SHOULD NOT have to be telling employees what and how paperwork needs to be done for release. Rescuers are there to help. Not to make their task harder.
- G) How come animals that are sick (not available for rescue and possible euthanasia) are showing up available for rescue?
- H) How come employees to release and provide info go to lunch at the same time? An informed and capable employee should be available at all times to handle shelter issues. No visitor can be helped when they are gone.
