As an inducement to cause Aerus to enter into this Agreement and maintain a schedule of at least five days scheduled MTY-LRD-MTY (Monterrey, México Laredo, TX Monterrey, México) Flights, the City hereby guarantees to Aerus that each Departure in each Market in a calendar month will produce no less than a specified level of Total Departure Revenue for each Departure as set forth in Schedule A, attached hereto.
