CITY OF LAREDO PARKS & RECREATION VIETNAM VETERANS PLAZA FOOD TRUCK SERVICES

INTRODUCTION

The City of Laredo Parks & Recreation Department is accepting applications from qualified entrepreneurs and businesses owners that operate a Food Truck to provide services at Vietnam Veterans Park located at 120 E. Calton Rd., Laredo, TX 78041 for the Parks and Recreation Department. Food Truck operators are not permitted to sell alcohol.

The objective of the Food Truck program is to support new small business opportunity, attract activity to Vietnam Veterans Plaza, and to enhance the visitor and resident experience.

PROPOSAL CONTENT

Interested businesses shall submit proposals that include (Attachment A):

- A. A completed application package by the due date.
- B. <u>Business Background & Qualifications</u>: Summarize your business background and qualifications to own and operate a Food Truck.

- C. <u>Food Truck Design & Equipment</u>: Provide photographs, brochure, menu or schematics of proposed Food Truck, including Food Truck dimensions (length, width and height), materials, equipment, visual displays and signage. No mobile food truck or equipment shall be used for advertising of any kind, except for the name and logo of the Permittee's company and small generic illustrations of the products that are sold. The design and placement of all signs must be approved in writing in advance by the City of Laredo.
- D. <u>Customer Service</u>: Briefly describe your approach to customer service and how you plan to meet the regulations on a consistent basis.
- E. <u>Hours of Operation & Staffing Plan</u>: Identify the hours of operation and staffing plan for your Food Truck. City of Laredo preferred hours of operation are: Thursday Sunday 12:00 p.m. 11:00 p.m. Applicants may propose their own schedule. Please note park business hours are 6am to 11pm.
- F. References: Provide at least two (2) business references. This information will be used to evaluate each proposer's history. The following information for each reference shall be included:
 - a Contact Name
 - b Phone #
 - c Brief Description of Relationship
- G. **Proposed Lease Fee:** Total monthly fee applicant would like to propose for one (1) food truck space.

H. Proof of Insurance:

- Commercial General Liability insurance will be required at minimum combined single limits of \$500,000 per-occurrence and \$1,000,000 general aggregate for bodily injury and property damage, which coverage shall include products/completed operations (\$500,000 products/completed operations aggregate).
- Business Automobile Liability Insurance with limits not less than \$1,000,000 each occurrence Combined Single Limit for Bodily Injury and Property Damage, including Owned and Nonowned and hired auto coverage, as applicable.
- Permittee will be required to meet the City's additional insurance and indemnity requirements, which are set forth in the Permit and have the City of Laredo as a named additional insured.
- I. <u>Menu & Prices:</u> A priced menu and description of the Proposer's food(s), food service(s), and/or soft drinks (s) to be sold.

SELECTION PROCESS & EVALUATON CRITERIA

The Selection Committee will review all proposals received. Proposals will be evaluated according to a combination of the criteria listed below. The City of Laredo reserves the right to weigh its evaluation criteria in any manner it deems appropriate.

Evaluation Criteria:

- 1. **RFP Package 15 Points:** Thoroughness, clarity and completeness of proposal; responsiveness to RFP requirements.
- 2. **Experience 10 Points:** Applicability and quality of proposer's experience and references, including a reputation for professionalism and quality of service.
- 3. **Menu/Pricing 50 Points:** The foods/beverages being offered and the competitive pricing in light of the location, potential clientele and visitor.
- 4. **Proposed Monthly Lease 10 Points** Proposed monthly fee for the use of one (1) food truck space.

5. **Food Truck Design/Equipment 15:** Attractiveness and appearance of fixtures and equipment.

Required Submittals

The City of Laredo will be utilizing best value evaluation criteria to select the contract vendor (s). You are asked to respond to the following questions and provide concise responses to these questions. Do include boilerplate marketing brochures or informational documents with your responses.

Termination

This RFP may be canceled at any time and any and all proposals may be rejected in whole or in part when the City determines such action to be in the best interest of the City of Laredo.

Right to Waive Minor Irregularities

The Evaluation Committee reserves the right to waive minor irregularities. The Evaluation Committee also reserves the right to waive mandatory requirements provided that all of the otherwise responsive proposals failed to meet the same mandatory requirements and the failure to do so does not otherwise materially affect the procurement. This right is at the sole discretion of the Evaluation Committee.

Evaluation Process

An evaluation committee will review all proposals utilizing the evaluation criteria noted below. A final recommendation will be submitted to City Council for future consideration by the full body. In evaluating and determining the **best value** for the City of Laredo the following factors shall be considered in accordance with the corresponding weights, in evaluating the proposals:

The Selection Committee will give preference to:

- 1. Local business license holders who currently operate a food truck business in a commercial, physical location open to the public.
- 2. Proposals which offer creative, imaginative and unique food items and merchandise that enhance the experience of visitors and residents.
- 3. At least one (1) years' experience in operating a Food Truck or comparable enterprise.

In order to maintain a program consisting of distinct and diverse food or merchandise, the City of Laredo will endeavor to limit the number of vendors that carry the same or similar types of food.

This RFP does not commit the City of Laredo to award a permit, nor for the City of Laredo to pay any costs incurred, in the preparation and submission of proposals in the anticipation of a permit. The Selection Committee intends to select proposers that, in the Selection Committee's sole opinion, are the most highly qualified under the requirements of this RFP and which provide the best value to the Vietnam Veterans Plaza.

Proposers are solely responsible for all costs of preparing his/her proposal and participation in this RFP and the City of Laredo does not assume responsibility for payment of any expenses incurred by a respondent as part of this process.

PROPOSED SCHEDULE

The City of Laredo will accept proposals on a rolling announcement basis throughout the year until the City of Laredo deems that an adequate number of Food Truck Permits have been awarded.

Award of Contract

The contract will be awarded based on (best value criteria) as follow and in accordance with the provisions of Chapter 252 and 271 of the Texas Local Government Code.

Definition of best value criteria as per The Institute for Public Procurement is:

"Best Value": 1. A procurement method that emphasizes value over price. 2. An assessment of the return that can be achieved over the useful life of the item, e.g., the best combination of quality, service, time, price."

Term of Contract

The term of this contract shall be for a period of six (6) months beginning as of the date of its execution.
