AMENDING SECTION 108.3 OF THE INTERNATIONAL BUILDING CODE [ADOPTED AS THE BUILDING CODE OF THE CITY UNDER SECTION 7-1 OF CHAPTER 7 OF THE CODE OF ORDINANCES] IN ORDER TO

- 1. CORRECT A PRINTING ERROR; AND
- 2. REDUCE THE BUILDING PERMIT VALUATION FOR UTILITY BUILDINGS FROM \$20.40 PER SQUARE FEET TO \$11.00 PER SQUARE FEET; AND PROVIDING FOR PUBLICATION AND FOR EFFECTIVE DATE.

WHEREAS, on October 16, 2006, by Ordinance No. 2006-0-234 the City Council adopted the 2006 Edition of the International Building Code as the Building Code of the City of Laredo under Chapter 7-1 of Chapter 7 of the Code of Ordinances and

WHEREAS, Ordinance No. 2005-0-228 of September 19, 2005, set forth a new Section 108.3 of the Building Code (through Section 7-2: Amendments) in order to specify the building permit valuations for the various kinds of structures, on which valuation is based the building permit fee; and; and

WHEREAS, the Building Official recommends that there be an amendment to Section 108.3 of the Building Code (through Section 7-2: Amendments) in order to correct a printing error made in said Ordinance No. 2005-0-228 as to building permit valuations for libraries, museums and arena [A-4] to reflect that the valuation should be \$58.80 per square foot and not \$588.80 per square foot; and

WHEREAS, the Building Official further recommends that Section 108.3 of the Building Code [through Section 7-2 [Amendments] be amended to reduce the building permit valuation for utility buildings from \$20.40 to \$11.00;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: Section 108.3 of the 2006 Edition of the International Building Code, adopted under Section 7-1 of Chapter 7 of the Code of Ordinances, as the Building Code of the City of Laredo, is amended to read as follows:
