CITY OF LAREDO ORDINANCE NO. 2018-O-031

AMENDING CHAPTER 28, ARTICLE IX PUBLIC RIGHT OF WAY MANAGEMENT; AMENDING SECTION 28-165, DEFINITIONS; AMENDING SECTION 28-174, PERMIT REQUIRED; CLARIFYING SECTION 28-215, FEES; PROVIDING FOR A REPEALING CLAUSE; PROVIDING FOR PUBLICATION, SEVERABILITY AND EFFECTIVE DATE.

WHEREAS, the City is charged with maintaining control of and access to the Right of Way in order to protect the health, safety and welfare of its citizens and;

WHEREAS, it is desirable to adopt regulations that will provide the City greater control over the Right of Way in City streets; and

WHEREAS, substantial public funds have been invested to build, maintain and repair the City Streets that are held as an asset on trust for its citizens, it is necessary to protect the structural integrity of the streets and safeguard the value of this public investment for the benefit of City residents; and

WHEREAS, entities making and benefiting from an excavation in a City street also should comply with standards and requirements for compaction, backfill and pavement restoration and resurfacing that ensures the best possible restoration of the paved surface over and adjacent to the trench; and

WHEREAS, the amendments proposed herein provide for the orderly and healthful development of the City of Laredo; and,

WHEREAS, the City Council finds it difficult for existing homeowners to hire a registered contractor to construct a driveway or sidewalk on a residential local streets with low traffic volumes; and,

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

ARTICLE IX PUBLIC RIGHT OF WAY MANAGEMENT

Section 1: Amending SEC. 28-165 DEFINITIONS

- (c) APPLICANT means an owner, authorized agent of an owner, or a homestead owner, who submits an application for a Permit under these provisions of the City Code.
- (h) PERMITEE means any Person, homestead owner (for the purpose of driveway and sidewalk permits of existing homes located on residential local streets with low traffic volumes only) or Right of Way User (including its authorized agents and representative) to whom a Permit is issued to Excavate a Right of Way.

(cc) RIGHT OF WAY-(ROW) USER means a Person, its successors and assignees, that uses the Right of for purposes of work, Excavation, provision of Services, or to install, construct, maintain and repair Facilities thereon, including, but not limited to, landowner and Services providers or a homestead owner (for the purpose of driveway and sidewalk permits of existing homes located on residential local streets with low traffic volumes only).

Section 2: Amending SEC. 28-174 PERMIT REQUIRED

It is unlawful for any Person, its agents, servants, employees or a homestead owner (for the purpose of driveway and sidewalk permits of existing homes located on residential local streets with low traffic volumes only) to dig, plow, blast, make cuts, openings, bore, excavate or use the Right of Way for any purpose without first having made application and obtained a Permit. It is unlawful for any Person, its agents, servants, employees or a homestead owner (for the purpose of driveway and sidewalk permits of existing homes located on residential local streets with low traffic volumes only) to make or cause to be made any Excavation in or under the surface of any Right of Way for the installation, repair or removal of any Facilities or for any other purpose without first obtaining from the Director a Permit in compliance with this Chapter.

B) At the time of the Permit is issued the Applicant shall pay a non-refundable Application Fee in an amount as provided for in this Chapter, except franchise or access fee payee of the City shall be exempt from the payment of such application fee. Homestead owners (for the purpose of driveway and sidewalk permits of existing homes located on residential local streets with low traffic volumes only) shall provide a legal document to hold the City of Laredo harmless from accidents, death or any incident thereto.

Section 3: Amending SEC. 28-215 FEES

- A) PERMIT APPLICATION FEE There is a non-refundable Permit application fee of (\$50.00) fifty dollars. Permits shall be issued or denied within five (5) days. There is an Expedited Application Fee of (\$250.00) Two-Hundred Fifty dollars for Permits which shall be issued or denied within two (2) days. The fees are paid by an Applicant when a permit is issued. The fees are charged for administration and input of Permit data. An expedited permit may be requested upon a showing good cause, including but not limited to a pending order for service that cannot be met by means of existing Facilities of the ROW User. In such event an expedited Permit may be requested and shall be issued or denied within two (2) days of application.
- B) INSPECTION FEE The work allowed by each Permit shall be subject to inspection and approved by the Director. There is a non-refundable Inspection fee of two hundred dollars (\$200.00) for the first connection and fifty dollars (\$50.00) for each additional connection (water, sewer,

drainage/storm sewer, street, etc.). The Department shall conduct a minimum of three inspections during regular working hours. The fee shall be paid at the time of application for a Permit. Inspections may be performed on any and all Excavations, at the discretion of the Director, based on previous performance of the Utility Owner, location of Excavation, type of work and/or construction methodology. Overtime inspection fees are incurred at a rate of \$40.00 per hour Monday thru Friday and \$70.00 per hour on Saturday, Sundays and holidays. Residential driveways and sidewalks are exempt from the two hundred dollars (\$200.00) inspection fee.

<u>Section 4</u>: This ordinance shall be published in a manner provided by Section 2.09 (D) of the Charter of the City of Laredo.

<u>Section 5</u>: This ordinance shall become effective as and from the date of publication specified in Section 4.

Section 6: Severability

If any provision, section subsection, sentence, clause, or phrase of this ordinance, or the application of the same to any person or set of circumstances is for any reason held to be unconstitutional, void or invalid, the validity of the remaining portions of this ordinance or their application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council in adopting this ordinance that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness or invalidity or another portion hereof, and all provisions of this ordinance are declared to be severable for that purpose.

Section 7: Open Meeting

The City Council officially finds, determines, recites and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the city hall of the City for the time required by law preceding this meeting as required by the Open Meeting Law, Article 6252-17, Texas Revised Civil Statutes Annotated; and that this meeting has been open to the public as required by law at all times during which this ordinance and the subject matter approves and confirms such written notice and the contents and posting hereof.
