15. **2022-0-059** Amending the City of Laredo Land Development Code Section 24.1.3.1 to adjust the rules governing the Zoning Board of Adjustment in order to identify that: quorum is formed by no less than seven (7) members, and that seven (7) concurring votes of the members of the board are required to reverse an administrative order or grant a variance, as required by the Texas Local Government Code Sections 211.00S(d) and 211.009(c) respectively. On April 7th, 2022, the Planning and Zoning Commission voted to recommend approval of the proposed ordinance amendment to the City Council. On April 13th, 2022, Board of Adjustment was called to consider this item, but did not achieve quorum and no action was taken. (correction) On May 11th, 2022, the Board of Adjustment voted to recommend denial of the proposed ordinance amendment. The Board stated that the ordinance should require a concurring vote of 75% of the members present to grant a variance or reverse an administrative order, rather than requiring a concurring vote of 75% of the membersto grant a variance or reverse and administrative order as stipulated in Texas Local Government Code Section 211.009(c). The Board also expressed their support for the appointment of alternates, if the Council approved the ordinance as proposed.

- 16. **2022-0-073** Ratifying the execution of a Memorandum of Agreement between the City of Laredo Health Department and Methodist Healthcare Ministries amending the FY21-22 budget by appropriating revenues and expenditures in the amount of \$220,621.00 and amending the FY21-22 Full-Time Equivalent Position Listing by adding two (2) Health Educators, R29 positions, for the Juntos for Better Health Program for the term period of March 1, 2022, through February 28, 2023.

- 34. **2022-R-090** Authorizing the Interim City Manager to submit a grant application in the amount of \$98,400.00 to the U.S. Department of Justice Programs for the purpose of funding the Patrick Leahy Bulletproof Vest Partnership Grant for FY 2023. The funds will be utilized to replace approximately 120 vests that have exceeded the recommended life expectancy. If awarded the Bulletproof Vest Partnership Program will provide funding in the amount of \$49,200.00 with the other 50% of the project being provided by city match. Funding will be accounted for in the Special Police Fund.
- 35. **2022-R-091** Authorizing the Interim City Manager to accept a grant in the amount of \$78,840.00 from the Office of the Governor, Criminal Justice Division, to fund the FY2022 Body-Worn Camera Program for the period of March 01, 2022, through February 28, 2023. - tables, seating and related furniture for the new Laredo Texas Anti-Gang Center. The purchase will be through Kimball Office; OMNIA Partners Contract # R191814. Funding is available in the Special Police Fund-Texas Anti-Gang Center Grant.

Consideration to reject sole bid submittal received for bid solicitation FY22-055 for the purchase of a storage tank to hold leachate water for the Solid Waste Department, and requesting authorization to let out a new formal bid solicitation with updated/revised scope of services. The City received one bid submission, but price is considered high and not competitive compared to previous informal quotes received by the Solid Waste Department. There is no financial impact for action taken on this motion.
- 40. Consideration to award contract FY22-054 to sole responsive, responsible bidder UTW Tire Collection Services, Donna, TX in the annual amount of \$225,000.00 for processing, recycling, beneficial use, or disposal of used tires collected by the City of Laredo Landfill. This service is to comply with the Texas Commission on Environmental Quality (TCEQ) regulations and guidelines to properly dispose of tires by certified transporters. The term of this contract is for two (2) years with the option to renew one (1) additional two (2) year term upon mutual agreement; contract is contingent upon the availability of appropriated funds.
