#### I. STAFF REPORTS

1. Discussion with possible action and presentation by the Laredo Film Society and local filmmaker Isaac Garza on the project The Son Who Can't Play the Trumpet, and any other matters incident thereto.

Health Director Dr. Chamberlain, explained several resources that the Health Department has for children and adults with Autism Spectrum Disorder.

Silvestre Rodriguez Jr. Assistant Fire Chief, gave an update regarding the Autism project that was started.
