41. Status update on current COVID-19 information as presented by Local Health Authority, Health Director and Emergency Management Coordinator (EMC); and any other matters incident thereto.

Dr. Victor Treviño, Laredo Health Authority, noted that while COVID-19 infections continue throughout the country, local spread appears to be stabilized. The community is still observing deaths due to the virus at over 838 to-date. Data

shows that Hispanics have the highest rates of infection, hospitalization, and deaths due to the virus in the country. Vaccinations continue to be administered and encouraged and will utilize specific outreach to combat misinformation and traditional health inequities.

Guillermo Heard, Laredo Fire Chief and Emergency Management Coordinator, noted that staff will soon implement a vaccination drive at high schools to vaccinate individuals aged 16 and over. The National Guard will also vaccinate at businesses in coordination with business owners.

Richard Chamberlain, Health Director, explained that the Buena Vida program has been offered to City employees for years to provide laboratory services; it will be amended to also provide vaccinations as well.

Dr. Marte Martinez noted that the recent jump is because of the demobilization of hospital staff. Cm. Torres voiced his unease at the hospitalization rate being almost 14%, close to the 15% threshold as established by the State of Texas.

No action taken.

Rosario Cabello, Deputy City Manager, reported that all City social media has advertised the survey; partners from TAMIU and Laredo College have also assisted the City. As of today, over 800 individuals have responded to the survey. She offered that staff can go to any Council events and administer manual surveys to attendees. City employees have been emailed notifying them of the survey's availability.

Cm. Cigarroa suggested that the survey be sent to the Chamber of Commerce and Rotary Clubs; Mayor Saenz added that the school districts can be contacted and encouraged Council to promote the survey to their constituents.

46. GENERAL COUNCIL DISCUSSIONS AND PRESENTATIONS

A. Request by Mayor Pete Saenz

1. Discussion with possible action on directing the Internal Auditor to conduct an investigation regarding the construction, ownership and public use of the "Los Martinez Basketball Court" in District VII, and any other matters incident thereto. (Co-Sponsored by Council Member Vanessa Perez)

Mayor Saenz voiced his understanding that the City has expensed over \$70,000 on this basketball court, which is on private land and has caused the landowner to claim that the basketball court is his property. He asked who authorized this work and for staff opinion on any legal consequences. Rene Benavides, City Attorney, noted that staff is working on a lawsuit which has not yet been filed.

Cm. Perez noted that this court is the only greenspace in the area. Residents who utilize the basketball court assume that the space is a public park and want lighting and improvements to be done; however, the court is on private party despite improvements being made to it from the City. She voiced her understanding of a leasing arrangement in which the City paid the owner for use of the land for this

basketball court. There is no contract on file with the landowner nor any apparent trail of how the City entered into this arrangement.

Mr. Benavides confirmed that the City sent a letter to the property owner for possible resolution, but the individual has not responded. If the City continues to not hear from the property owner, they will file a lawsuit. He noted that staff is also preparing for Council's direction to conduct an audit, which may provide more information. He confirmed that this basketball court was constructed in 1992.

Robert Eads, City Manager, explained that his office and the City Secretary's Office performed a thorough search of the minutes and contracts on file; this basketball court appears in Council minutes in Capital Improvement Plan presentations for funding and project updates. However, nothing has been found in terms of Council direction or an agreement between the City and the property owner(s). The City should have never built this court without owning the property or having an agreement on file with the property owner.

Cm. Cigarroa reported that the City has also spent money on a sculpture for Don Tomas Sanchez, but there is not a contract in place for that work, either. The City has spent more than \$500,000 to-date, which is more than what Council approved. Mr. Eads noted that staff has a purchase order on file for that work but not a contract with the artist.

Cm. Torres noted that about \$300,000 of District IV funds were diverted from his district for this statue; that money could have been better put to use for street and sidewalk repairs and infrastructure.

Motion to instruct the Internal Auditor to work alongside the City Manager's Office and the City Attorney's Office to conduct an audit or investigation with regards to the pending Don Tomas Sanchez statue and the Los Martinez Basketball Court to include the exploration of any applicable contract, purchase orders, funding sources, and the status of work with the vendors, as amended.

Ideally, this assessment would be utilized during the 2021 budgeting process.

Cm. Perez noted that while much of Laredo is closed, District VII has traffic coming and going all day long with no amenities for shopping or spending money. She initiated a motion to direct management to assess the competitiveness of Laredo's economic model.

Dr. Marte Martinez cautioned Council from saddling this large research project on

the Economic Development Director at this time given his workload at this time, to which City Manager Robert Eads agreed and added that Mr. Garcia is a victim of his own success and now has many projects in the works. He noted that management can secure the help of other departments on this project but reminded Council that it will require more staff. The City has an economic plan embedded in its Comprehensive Plan. He confirmed that the Economic Development Department's additional staff members will be prioritized at the next budget meeting.

Teclo Garcia, Economic Development Director, noted that in many municipalities the Economic Development Corporation or Foundation is the leader in terms of job recruitment or other economic areas; they operate through partnerships to recruit corporations from around the world to their area.

Cm. Cigarroa suggested that the Economic Development Recovery Committee be revived and included this assessment.

Motion to direct management to assess the competitiveness of the City's economic development model and to include the Economic Development Recovery Committee, as amended.

Ramon Chavez, City Engineer, noted that some improvements must be completed in terms of drainage, connectivity, and other matters between the two neighborhoods. Robert Eads, City Manager, added that this project has two technicalities that include design and construction that would require contracting out the service. Connecting two neighborhoods by removing the cul-de-sacs may improve traffic in the area, but he noted that many property owners in cul-de-sacs do not want them to be removed and purchased their homes in the expectation that the cul-de-sacs would remain.

Cm. Perez noted her opposition to connecting the two cul-de-sacs due to resident complaints at this time. Residents want signage noting that these streets do not

have an outlet or thoroughfare.

They are expected to present their final recommendations to Council in November 2021. The group intends to gather community and public input in May and June as a part of their work.
