Citizen comments

Rafael Benavides, Public Information Officer, read the public comments into the record as follows:

Juan Avila thanked the City Manager for his hard work in managing the City of Laredo during this pandemic.

Melissa Cruz noted that law enforcement should be on the same page with the City, stating that her daughter works for an essential business that has been open until 12:00 a.m. On Friday, a constable told them that they have to close or risk getting a ticket, despite the business fulfilling curbside and telephone orders for snacks and groceries. When they asked the Laredo Police Department about the regulation or citation, LPD told them that they were not out of compliance and did not have to close their business

Joaquin Fernandez asked if mariachis would be allowed for Mother's Day if they will be at least six feet from each and their clients as well as complying with all other preventative measure recommendations.

Justin Hundsnurscher voiced his opinion that Item 49. B2 goes against Governor Abbott's order that municipalities cannot fine or penalize an individual for choosing not to wear a mask, noting that a citation-even without a fine-is a form of penalty. He suggested that the City simply require the use of masks when entering government buildings and let businesses make their own decisions about requiring masks in their establishments. He noted his opinion that the City's resources would be better applied elsewhere than on this topic.

Michelle Marie Romani spoke in regards to Item 49. B2, noting that while all citizens have rights and responsibilities that must be struck in a healthy balance, an opinion

from the Attorney General on the rights of the City to continue enforcing the use of face masks should be requested. The Emergency Management Coordinator's response to this issue was not sufficient, let alone satisfactory. She urged Council to seek a logical solution to the mask question rather than pursuing a loophole to the Governor's order.

Dr. Marcela Uribe addressed Item 49. C2 on behalf of the Laredo Center for Urban Agriculture and Sustainability, noting the organization's excitement to receive the requested funding from the City; LCUAS has worked to address food security, health, wellness, and sustainability in the community. During the COVID-19 pandemic, a small group of volunteers has continued to cultivate the community gardens through the program; these vegetables are being donated to needy families in the communities to ease hunger. She asked Council to consider the expenses of their program and lease the Carriage House to LCUAS at the rate of \$1 per year to house their soon-to-be-hired staff, a walk-in refrigerator, and storage of their tools and materials. She also asked that the grounds remain a City park and be maintained by the Parks & Recreation Department since the property will be used for education and community outreach for the entire City. She requested legal and financial assistance from the City Attorney's Office and Finance Department regarding legal and accounting issues with timely advice to facilitate and continue operations.

Cynthia Rios voiced her favor for Item 49. E1, as did Mr. Izaguirre (no first name provided), Briana Salas, Samantha Treviño, Gloria Lopez, and many others.

Rita Diaz spoke in favor of Item 49. E1, noting her pride at the WIC building being named for her dear friends who have always given to their community. Melicio Molina, Jr., spoke in favor of Item 49. E1 but asked that the building be named after the Ramirez Family. Veronica Molina spoke in favor of Item 49. E1, adding that the naming suggestion is appropriate given the Ramirez's giving nature and positive example in the community.

Yahaira Velazco of Laredo's Cosmetology, Barbers, and Aestheticians Confederation voiced her support of Item 49. E2, as did Perla Hilton, Linda Martinez, Mayra Sanchez, Alfredo Hernandez, Jr., Karen Boone, and Karina De Leon. He read a public comment stating that barbers, aestheticians, and cosmetologists are an essential service to the community. This service can be performed safely as these professionals are trained and required to regularly clean and disinfect their equipment and facilities. The comment noted that this profession can sometimes help save lives by recognizing serious skin or scalp cancers or maladies and refer the client to the appropriate physician or dermatologist for treatment. The cosmetology, barber, and aesthetician industry also helps maintain hygiene and grooming among community members, particularly the elderly population who can no longer wash their own hair at times.

Christian Hernandez of The Vanity Bar Beauty Salon voiced his support of 49. E2 as did Devany Lozano of Theo's Barbershop, Linda Martinez of Jazmin's Fade Shop, and Ivette Diaz of Barbero Man's Salon LLC. Norma Rodriguez voiced her neutrality on Item 49. E2.

Remy Salinas noted his neutrality on Items #12 and 16.

Armando Cisneros asked if the City can cite individuals for endangering the public by any means including exposing others to their coughs, sneezes, or breaths if the City cannot cite someone for refusing to wear a mask.

He noted his understanding that the developer of this land was required to put the buffer in place, but he could not speak directly to this issue. The applicant submitted a legal document speaking to the buffer with their application; the lawsuit between the developer and residents does not affect this zoning and vice versa. The zone change should not impact the buffer because only the land in question can be developed; the buffer cannot.

Cm. Vielma noted that a new Department of Defense specialized office has recently opened in San Antonio; while the City may have enough masks or personal protective equipment (PPE) now, there may be spikes of COVID-19 and flu cases closer to the fall. She suggested that the City consider this when coordinating emergency services to see if more equipment can be obtained at that time. N95 masks can be sanitized for free, which may save the City on costs and resources.

18. 2020-O-045 Approving the most recently amended COVID-19 Emergency Ordinance of the City of Laredo, Texas, that incorporates Governor Abbot's Executive Order No. GA-18 and GA-19 that pertain to essential services, re-opened services, and essential daily activities; and additional control measures deemed necessary by Local Health Authority for the protection of the health, safety, and general welfare of the public in accordance with Chapter 121 of the Texas Health & Safety Code, Chapter 85 of the Texas Administrative Code, and 2.11 of the City Charter.

Kristina L. Hale, City Attorney, noted that this ordinance includes only what was amended in the Governor's executive order. Those amendments include the opening of businesses at 25% occupancy, opening indoor retail stores and shopping malls, movie theaters, and dining restaurants. This ordinance has additional services and activities added in response to GA-18 and GA-19. The Governor's order also prohibited cities from imposing a fine or penalty on citizens refusing to wear a mask or face covering. Nothing else has changed regarding the City's emergency ordinance. Mrs. Hale noted that the health authority has recommended additional requirements regarding COVID-19 reporting in which and the Health Department would be notified every time an additional positive case of COVID-19 is confirmed. As long as Council does not add a requirement that has been specifically prohibited or preempted by the Governor, the City of Laredo is able to add additional measures to the emergency ordinance.

Dr. Marte Martinez asked if a citation without any penalty would conflict with the Governor's order. Mrs. Hale noted that a citation

without a penalty would not conflict, but a citation is a notice of a violation with instruction to appear at a particular court to account for the charges. This would normally impose some type of penalty. Regarding mask requirements, she recommended that Council not continue to cite offenders even without a penalty because that is not in the spirit of the Governor's directive. Businesses are welcome to impose a mask requirement in their establishments for service. She recommended that the City keep the use of face coverings as a mandate but not to issue citations as they would serve no purpose and could be challenged.

Dr. Victor Treviño, health authority for the City of Laredo, recommended that the City continue to encourage businesses and citizens to use face masks as part of the "new normal" that the community is experiencing. Even though it is not a mandate, it is highly recommended as all of the city-wide measures have been highly effective in mitigating the spread of infection.

Mrs. Hale confirmed that City officials can mandate the use of masks or face coverings in City buildings. Cm. Rodriguez initiated a motion to this effect, to which Dr. Treviño agreed.

Mrs. Hale confirmed that the stay-at-home order was not cancelled by the Governor; he repealed a previous stay-at-home order and then replaced it with new language in GA-18 and -19. The stay-at-home order has not changed either in the Governor's order or the City ordinance; citizens are required to stay at home except when engaging in essential services or activities or the physical activities as allowed by the Governor. The public is still not allowed to gather except for those specific purposes. Non-essential travel is still prohibited. Therefore, the curfew is another provision that does not conflict with the Governor's order.

Cm. Vielma reported receiving inquiries about curfew in light of the reopening of additional establishments, such as movie theaters. If a movie theater's last showing is over during curfew hours or a restaurant is open 24 hours, then employees or customers leaving those establishments might be cited for curfew violations. Mrs. Hale explained that this was a common misconception since the implementation of the curfew; the curfew did not prohibit any

individual from engaging in any allowable activity, such as eating or working. Similarly, now that residents are allowed to go to the movie theater or dine in a restaurant, they are still allowed to do so even during curfew hours; this has not been affected in any way.

MPT Torres recalled that the curfew was a means to help curtail public and social gatherings, such as carne asadas and parties. This makes it easier for law enforcement to determine if people are gathering out of compliance with the preventative measures that were implemented.

Dr. Treviño observed that most citizens understand the intention of these measures as well as the potential danger of the virus. Robert Eads, City Manager, voiced his understanding that City parks close at 10:00 p.m.

Mrs. Hale reminded Council that the City has the right to close their parks at any time that they wish. Private park closure times are the discretion of those subdivisions. Mr. Eads added that the City has always instituted evening closures of parks.

Cm. Vielma initiated a motion to change the curfew hours to 12:00 a.m. to 5:00 a.m. to give residents two additional hours before curfew begins. Cm. Mercurio Martinez seconded the motion for discussion purposes only.

Cm. Altgelt noted that many community members have been struggling with the delicate balances of their civil liberties versus public safety. Unfortunately, the City has minimal data on hand due to the high demand for testing supplies. He voiced his concern over the state government implying that they know Laredo's circumstances and needs better than local officials do.

Cm. Balli noted his surprise that the City opened its parks, voicing his understanding that the Governor did not require that of municipalities. State parks were being reopened, but the Governor did not mandate that local parks be reopened. Residents are concerned about gatherings at parks and playgrounds; he recalled an advertisement for the Max Mandel Golf Course for a Mother's Day lunch, which might compromise social distancing requirements. The City is not required to open City parks and would not be in violation of the Governor's order if they had kept these facilities closed. He voiced his opinion that Council should take a step back and noted his opposition to Cm. Vielma's amendment to push back curfew from 10:00 p.m. to midnight. Instead of extending the curfew, he suggested that instead alcohol not be sold during curfew hours.

Dr. Treviño noted that officials err on the side of caution and suggested that Council do the same. The road is still dark, so it is necessary to move slowly and gradually. He voiced his concerns with many of the Governor's orders because they were quick and reactionary from one day to the next; in particular, the removal of mask requirements caused him concerns because of the amount of space through which sneeze or cough droplets can travel. If Council errs on the side of caution, they will very likely not fail.

Dr. Martinez noted that if someone is out for an essential service, then they are allowed to do so during curfew hours; the City must still do whatever it can to decrease the amount of gatherings at this point. He encouraged Council to maintain the status quo in regards to curfew because the City is not out of the woods yet. Changing the curfew hours may cause an increase in positive cases at too rapid a rate that will overwhelm the City's medical resources.

MPT Torres confirmed that Dr. Treviño recommended Council to leave curfew as it is.

Cm. Altgelt initiated a motion to direct law enforcement to still issue citations for failure to wear masks or face coverings even though there will be no requirement of the offender to appear in court, pay a fine, or face any consequence otherwise.

Mrs. Hale noted that if there is no requirement to appear in court, law enforcement could instead give the offender a mask as is being done in other cities at this time. While this motion may not be in direct conflict with the Governor's order, it could be challenged; she did not recommend issuing citations unless Cm. Altgelt could clarify the motion with more information.

Cm. Balli voiced his understanding that the only stipulation is that

the City cannot issue any monetary fine; it would be in the City's authority to issue a citation without a fine. He voiced his support of this motion in order to encourage cooperation from grocery stores and other businesses where people may gather to continue requiring the use of masks or face coverings.

Steve Landin, Fire Chief and Emergency Management Coordinator, agreed that chain stores need the City ordinance to continue mandating the use of face masks in order to facilitate their requirement of the masks, as well. When stores put up signs requiring masks, having a City ordinance to refer to helps ensure that the public will respect the requirement. The mask requirement also protects businesses' employees, and they are deeply concerned with their employees being put at risk when customers stop wearing masks. He doubted whether the City can mandate stores or businesses to have masks to hand out to the public.

Robert Eads, City Manager, reminded Council that businesses can make the decision not to service customers who fail to cover their nose and mouth. They already have that ability, but it is helpful to them to refer to the City's actions, as well.

Dr. Martinez noted that it is too easy to believe that things are back to normal if people are seen without masks or gathering in public, which is counterproductive to the measures taken to decrease the prevalence and incidents of this virus. Walking backwards too soon is going to damage the community.

Dr. Hector Gonzalez, Health Director, reported that most restaurants have told Health staff that they do not intend to allow patrons to enter the establishments without face coverings. He agreed that having the City as a role model will help support business owners enforce the requirement in their own operations.

Cm. Altgelt stated that this amendment to the emergency ordinance will not give officers license or discretion to stop someone in their motor vehicle if they are not wearing their mask; it is specific to enclosed spaces and buildings.

Cm. Rodriguez asked if Council could send resolutions to businesses stating that the City still requires masks and encouraging those businesses to do the same. Mrs. Hale confirmed that staff could issue such a resolution; she reminded Council that community members were allowed to not wear masks in their private vehicles. Police officers never had the discretion to stop someone in their personal vehicle for not wearing a mask. She voiced her opinion that issuing citations without penalties would not be effective as there would be no consequence or

following action.

Cm. Vielma suggested an amendment to the motion that provides some follow-up action from those citations, such as an online educational class, noting that if there is no follow-up to the citation then it is meaningless. Mrs. Hale countered that if the individual were to not take that educational class or follow-up action, the consequence is unclear.

MPT Torres voiced his opinion that requiring an offender to attend a class after they get a citation is a penalty, which is counter to the Governor's intention and a violation of his order. The public shame of getting the citation itself can be construed as a penalty. As much as Council wants to do something, he urged Council to respect the orders of the Governor who has exercised his executive power. It is to the City's advantage to follow with what the Governor has already provided. While MPT Torres agreed that the use of masks should continue, he supported Cm. Rodriguez's suggestion of issuing a resolution to back up businesses with the right to refuse service to anyone not wearing their face mask. If someone receives a citation with no penalty associated with it, they will simply throw it away and the City will be stuck with the spent manpower to no effect. He strongly suggested that Council not support this motion but to instead support a resolution as suggested by Cm. Rodriguez. Cm. Vielma agreed with MPT Torres's argument.

Dr. Treviño noted that rather than punish people for failure to wear masks, the City and businesses can look for incentives to *encourage* the use of masks, such as a tax break or discount. People react better to incentives than punishments. MPT Torres noted that being refused service at a grocery store or business is punishment in and of itself if someone does not wear their face covering.

Cm. Altgelt voiced his understanding that the Governor's executive order says that masks are still required, but no municipality can issue fines for failure to wear them. The requirement has not been removed. While the citation would be symbolic, the masks themselves are also symbolic of one's care for their community.

Chief Treviño noted that the Police Department would need this ordinance to have the appropriate language to issue officers authority to detain an individual for the purposes of issuing a written warning or citation. This way, police will not be accused of stopping and harassing the public, which is a concern of his. He stated that if the motion is not going to have that language, then

he would not recommend supporting the motion as it will put officers in a position of liability of creating confrontations if a violator refuses to stop for an officer. The motion also subjects officers to unnecessary contact with the public if they are to issue citations that will have no penalties. Officers will be able to provide assistance to businesses that refuse service for people not wearing masks and charge them with criminal trespass if the violators are not leaving a business to which they have been denied service.

Cm. Balli noted that the point of issuing a citation is not to give a slap on the wrist but to back up local businesses who are trying to put food on their tables. They are trying to provide for themselves and their families and need a safe environment to operate their businesses. If Council does not back up these businesses with this ordinance, then a lot of workers will be subjected to virus transmission. He noted that he has elected not to dine in restaurants because it creates an unnecessarily unsafe condition for the employees. The Governor's order specifically prohibits penalties, and a ticket is not a penalty by definition, either civil or criminal. A penalty is the requirement to pay a monetary amount or perform an action as repayment. He encouraged Council to support this motion and not cast a vote against restaurant workers, business owners, teachers, or grocery employees.

MPT Torres countered that the Governor's order says that individuals are *encouraged* to wear masks, not *required*. Mrs. Hale added that the definition of a citation is subject to interpretation because it is a punishment, begging the question of whether a citation in and of itself is a punishment. She voiced her opinion that citations are not in the spirit of the Governor's order. Permitting businesses to require masks and refuse service to individuals not wearing a mask can be enacted through this ordinance or a separate resolution.

Dr. Martinez stated that the argument that police officers issuing citations that have no penalty are a waste of time, but he reiterated that this communicable disease is very serious. A reminder can sometimes go a long way to helping people understand that they have to perform this function (wearing a mask) for their neighbor and community. He voiced his opinion that having officers approach violators for this purpose would be very meaningful. Dr. Martinez noted his willingness to challenge the Governor as a physician; as a policymaker, he noted the need to find a middle ground. This motion is that middle ground, and he asked Council to support it as there are many reasons why it should be supported.

Teclo Garcia, Economic Development Director, noted that many small businesses want to open but also think that they can implement the necessary measures to protect customers and employees. They feel secure in their abilities and want to take those measures so that they can open.

Mr. Eads confirmed that staff can push out information to the public through social media or text message subscribers.

Gomez, Jr., Parks & Recreation Director, explained that since the Governor's order was issued, staff has opened the parks as required but certain facilities have not been made available such as skate parks, basketball courts, or anything that could form a congregation. These prohibited facilities were blocked off with yellow tape, and staff and law enforcement have coordinated efforts to monitor those prohibited areas to ensure compliance. Fields have been accessible as long as any activities involve four people or less; he observed a good response from the community over the weekend. People seemed to utilize the trails and walking areas, but groups of four or less were not seen much. Masks have also been encouraged.

Cm. Balli clarified that he received a text message regarding his comments on the Max Mandel Golf Course's Mother's Day lunch informing him that the lunch is takeout or to-go only.

49. GENERAL COUNCIL DISCUSSIONS AND PRESENTATIONS

A. Request by Council Member Nelly Vielma

1. Discussion with possible action authorizing City Manager to establish COVID-19 protocols to allow the re-opening of golf courses in the City of Laredo and any other matters incident thereto.

Robert Eads, City Manager, confirmed that the City has reopened the Max Mandel Golf Course in accordance with the Governor's order and have set up a system to facilitate the separation of individuals to one person per golf cart. The Governor allows for family members to ride together, but Max Mandel, as well as other golf courses in the state, is limiting golf carts to one person per cart.

Juan J. Gomez, Jr., Parks & Recreation Director, explained that the golf course is only allowing four people per golfing group and have spread out tee times to ensure more social distancing between groups. Staff has been given disinfectant to thoroughly clean the golf carts between riders. Touching of surfaces in the driving range and throughout the holes has been limited or discouraged. He voiced his opinion that these changes have been well received by the golfers.

Cm. Rodriguez noted that he received a phone call that highlighted the efforts of staff to limit contact between people and among surfaces.

Cm. Vielma commended staff on their efforts and initiated a motion to approve these protocols with any amendments as needed. MPT Torres noted that these protocols are already being done. She clarified that she has been in communication with the Country Club and wanted to officialize these protocols so that the other golf courses could standardize their practices to match the City. She also clarified that the motion is to reopen all golf courses in the City of Laredo, not just the City-owned golf course.

Cm. Rodriguez asked how the City could force a private or non-City-owned golf course to do something that is not required. Casa Blanca golf course belongs to the County, and the Country Club is managed by its HOA. Council can only decide what is required at the City; he voiced his opinion that the intention of this motion is overreaching.

Mr. Eads clarified that all golf courses are doing the same thing; the difference is that the City's golf course is taking one person per cart while the other golf courses use the Governor's language which allows two family members to ride together. Staff decided to only allow for one person per cart

unless one of the members is a child as an extra precaution. Mr. Gomez agreed, noting that the Country Club is trying to perform the same procedures as the City's course.

Cm. Balli noted that if the Governor has specific guidelines, then the City cannot be more restrictive than those guidelines on other entities. He voiced his opposition to Council making rules for how the County should operate their own golf course. In light of the discussion, Cm. Vielma withdrew her motion.

C. Request by Council Member George Altgelt

Discussion with possible action to direct staff to track and digitally model the number and whereabouts of those that have been infected with COVID-19 (in strict compliance with HIPAA) throughout the city and to message the public accordingly in order that they can make informed decisions about their health and to prevent the spread of COVID-19; and any other matters incident thereto including but not limited to fully disclosing to the public the full and accurate numbers of citizens infected with COVID-19 from Laredo Medical Center.

Cm. Altgelt noted that the Comprehensive Plan has a section dedicated to identifying clusters of disease such as diabetes, cardiovascular issues, or in

this case, a global pandemic like COVID-19. The COVID-19 dashboard on the City's website is very thorough and informative, but he suggested that the City track the virus in the form of clusters rather than ZIP codes. ZIP code data is too macro-detailed and doesn't identify clusters in a meaningful way that communicates to the public where transmission may actually be occurring. A significant portion of the City's cases came from a single cluster; he commended Dr. Treviño for unraveling the circumstances to make this determination. If the City tracks the virus data on a microscale, officials and the public will be better informed of places to avoid or places that are safe. Cm. Altgelt stated that when he first brought this information to Dr. Hector Gonzalez's attention, he was told that the City cannot do this as that information is HIPAA-protected. He disagreed with that statement based upon his understanding of HIPAA because there is nothing regarding identifiable information in a COVID cluster. He initiated a motion to direct staff to track and digitally model the number and whereabouts of those that have been infected with COVID-19 and the general parts of town where they have been.

Cm. Vielma asked for an amendment to include all hospitals, medical clinics, and the Health Department testing facilities. Cm. Altgelt accepted the amendment.

Dr. Hector Gonzalez, Health Director, informed Council that the Health Department already has the information as described by Cm. Altgelt but cannot share it because it does in fact have identifiable information about the patients. This information is private, confidential, and protected by HIPAA. The protected measures that the City upholds for any communicable disease cannot be disclosed even with the minutest detail if it can be linked back to a person. Having said that, he noted that he has talked to the IST staff, the State, and the Center for Disease Control and Prevention (CDC) about any other models that could be used for public projections. He reminded Council that ZIP codes are very informative and definitive; within bubbles shown are multiple cases that provide information about clusters. Hot zones are found throughout the City. If the City gets more specific about any areas, the risk of exposing any streets or individuals gets greater and cannot be done. Dr. Gonzalez noted that he and Dr. Treviño have the specific information because they need to perform investigations to prevent secondary spread; they share this information with the appropriate state authorities and were told that there is not any more specific information to share other than ZIP codes. As of right now, the ZIP code information is the best microscale detail that can be shared with the community.

Cm. Altgelt agreed that street names and other identifying information like that is not his intention. However, the City needs more useful cluster data to make better policy. Dr. Gonzalez confirmed that officials will continue to look for those opportunities for different models but no disclosure or linkage that can be used to extrapolate to identify a patient can be entertained. He reminded Council that the first couple of COVID-19 patients were shunned

by their community when they were released from quarantine, which is not acceptable.

Dr. Victor Treviño, health authority for the City of Laredo, noted that he and his advisory team treat the virus in real time by making clinical observations and decisions. They rely heavily on epidemiological information that they receive from the hospitals. He conceded that the team could do a better job as the issue revolves around transparency and timeliness. On many COVID-19 cases, the team responded very conservatively and were ahead of the CDC guidelines to mitigate the spread of the virus. As the fall approaches, the City will have to face a second round of COVID-19 in addition to seasonal flu; he reiterated the need to prioritize transparency and timeliness.

Cm. Mercurio Martinez asked if officials are collecting data on where these patients are being exposed; Dr. Gonzalez confirmed that this is part of officials' investigations, but the transmission has seemed to occur throughout the city. One of the few places where the City has not seen high transmission of the virus has been in retirement and nursing homes because those facilities were on lockdown. The current data shows that the clusters are through close contacts among family members who have had varied symptoms or gathering activities. Dr. Treviño suggested that this matter be discussed in executive session if Council wishes to discuss this matter further as there are identifiable components involved.

At Dr. Treviño's suggestion, Council went into executive session. Following executive session, MPT Torres reported that no action was taken.

Cm. Altgelt amended his motion to direct staff to track and digitally model the number and whereabouts of COVID-19 clusters in compliance with HIPAA throughout the City in a way that is consistent with the Comprehensive Plan and to message the public accordingly regarding those cluster findings and initiate an investigation regarding the number of people infected with COVID-19 from the Laredo Medical Center.

Motion to direct staff to track and digitally model the number and whereabouts of COVID-19 clusters in compliance with HIPAA throughout the City in a way that is consistent with the Comprehensive Plan and to message the public accordingly regarding those cluster findings and initiate an investigation regarding the number of people infected with COVID-19 from the Laredo Medical Center, as amended.

He initiated a motion to direct staff to proceed and coordinate with these entities for this purpose. If there are any gaps in funding, District VII priority funds can be allocated.

Kristina L. Hale, City Attorney, cautioned Council that staff would need to check with bond counsel to see if District VII priority funds qualify for this project. Cm. Altgelt amended his motion to allow for the approval of bond counsel and reminded Council that the Texas Procurement Act will be followed throughout this project.

He referenced the outpouring of endorsements and praise from the community at the dedication suggestion, thanking the Ramirez family for their contributions to Laredo. He initiated a motion to approve this item.

MPT Torres noted that the Ramirez family has been very involved in the community and in the Catholic Church, including their children who are following in their parents' footsteps. Cm. Vielma thanked Cm. Rodriguez for bringing this item forward in honor of two pillars of the community such as the Ramirezes.

Cm. Mercurio Martinez agreed, noting that this family has endured much adversity and have a uniquely positive and inspiring effect on citizens of Laredo. Throughout Raquel's diagnosis and battle with cancer, she kept a smile on her face and would encourage others to remain positive in their own lives.

Rafael Benavides, Public Information Officer, read public comments into the record as follows:

Elsa Cavazos noted that the suggested naming or dedication is perfect. Vanessa Garcia stated that the Ramirez family has put a smile on many Laredoans' faces, noting her approval of the item.

Khrystal Saenz noted that the Ramirez family have been an influential part of her life for as long as she could remember as well as District II families.

Lydia Vazquez voiced her favor for the name dedication, as did Javier Salinas, Jose Alfaro, Celina Ramirez, Isabel Becerra, Daniela Gaytan, Maria

Elena Cantu, Arminda Gonzalez, Maria Villarreal, Francisco Xavier Treviño, Nora Gamboa, Anita Treviño, Nancy D. Landa, Gabriela Morales, Diana V. Garcia, Francisco J. Garcia, and others.

Cindy Hernandez stated that the Ramirez family have been an instrument of hope and love in the community and have been positive role models in her life since she was 12 years old. Charmain Heimes noted her 20-year relationship with the Ramirez family and her pleasure in coaching their daughters at Cigarroa Middle School; while the community was devastated by the passing of Mrs. Raquel Ramirez, her legacy will live on.

Salome Gaytan, Jr., noted that this building's naming would be a great dedication for both namesakes. Juan Villalpando stated his belief that the Ramirez family is very deserving of this honor.

Marlene Palomares, niece of the namesakes, noted that the Ramirez family have always been willing to give away their last piece of food if someone needed it. Raquel Ibarra noted that this family has been instrumental of helping the community and are true examples of the kind of selfless service deserving of such recognition.

Nelly Garza stated that these two individuals are wonderful human beings and the best teachers with amazing hearts. Tanya Alfaro noted that they have spent their entire lives serving others and have worked with diligence and care to touch the hearts of many.

Elizabeth Jimenez noted that the selfless giving of the Ramirez family has left a lasting impact on the community. Pati Guajardo stated that the renaming of the center is a beautiful and fitting tribute to a couple who served as a role model to others during times of challenge; Elsa Reynaga stated that the recognition is well-deserved.

Rosa Saldivar noted that the family is well known for working together and helping out in any way that they could. Lizeth Cuellar stated the Ramirez family's impact on their community through education, service, and through church ministry. Sandra Peña noted that the family is very caring and helpful.

Rita Ramirez thanked the City for the gesture of naming the WIC building after her parents, voicing her support of the item.
