Citizen comments

MPT Alberto Torres asked if Mr. Ricardo Quijano should be sworn in as a witness. The MPT decided to allow Mr. Quijano three minutes for public comment and then an additional three minutes if city council has any questions.

Mr. Ricardo Quijano, stated that he had a concern with food distribution and politics comingling. He stated that a family member was given food in exchange for placing a political sign of a candidate. He also stated that he wanted to presented some affidavits of unnamed citizens; he had collected, referencing the agenda item. Mr. Quijano was asked to submit the affidavits to the City Secretary for the record or the City Attorney so he can look into these allegations. He refused to, stating that he need to redact the documents and that he would submit them at a later date.

Mr. Ricardo Quijano read sections of an affidavit and then mentioned that food banks where providing list of people that needed help to the fire fighters union. At that point, MPT Torres asked Mr. Quijano to clarify which food banks were the ones he was talking about he clarified that it was the Laredo Regional Food Bank.

MPT Alberto Torres asked City Attorney Rene Benavides if this was an open investigation and if it is, did Mr. Ricardo Quijano need to be sworn-in. Mr. Benavides stated that the City Council has the right to call witnesses but he had a concern that the item may not have been noticed correctly.

Cm. George Altgelt asked the City Attorney to classify if the investigation was done and what were the results. The City Attorney stated the investigation has reached it's conclusion based on the limited information and tools at hand. He had spoken to the executive directors of the Laredo Regional and the South Texas Food Banks. He also read a report from the Laredo Morning Time; spoke to the Fire Chief and the Chief Financial Officer of the fire department. Cm. Altgelt also brought up the issue of the Fire Union PAC using association business leave and the issue of backfilling by the City of Laredo during their leave.

City Attorney Rene Benavides stated that with his initial investigation, he did not see any conclusive evidence that there was a violation at this point with reference to the CARES Act monies.

Cm. Rodriguez stated the August was the last food drive donation by the city and made a motion to start another food drive donation by the city and to utilizing city employees, as to avoid any problems, under the discretion of the City Manager.

Cm. George Altgelt offered up an amendment that was rejected by Cm. Rodriguez. Then Cm. Norma Nelly Vielma offered up an amendment that was rejected by Cm. Rodriguez. Mayor Pete Saenz expressed concerns with the city employees being involved. City Manager Robert Eads also expressed concerns with the use of city employees for the distribution of food for fear of them catching the COVID-19 virus. He also stated that the city does not have enough employees to help.

Cm. Roberto Balli agreed with management and he wants to avoid the politics of the whole thing. He shared a couple of items with the city council. First, an online newspaper article by an individual that made the complaint and was featured in the newspaper. Secondly, the campaign finance report of one of his opponents showing that the same person referenced in the article was an employee of his opponent at the time of the complaint. He encouraged management to distance themselves from any food distribution involvement as much as possible.

City Manager Eads stated that there is only \$125,000.00 left that can only be used for food distribution up until December 31, 2020.

Motion to help the both food banks and the pantry with \$125,000 equally distributed between the three organizations (only for food purchase). The organizations must also sign off that they are going comply with no political activity with any of the funds provided by the City of Laredo. If the organizations request the use of a forklift and forklift operator, the approval will be at the City Manager's discretion.

Cm. Altgelt expressed concerns as to how the city management was going to control

Fire Pac association business leave.

Fire Chief Guillermo Heard explained the Fire PAC association business leave process as to the collective bargaining contract. City Manager Robert Eads explained his concerns and how he wanted to establish clear-cut definitions for approval of the association business leave process.

Cm. George Altgelt questioned whether the fire department had to backfill positions due to the Food drive distributions and if so, how much did it cost? Chief Heard said yes, the department had to backfill but he did not have the cost available at this time. He will provide that information as soon as possible.

Cm. Roberto Balli expressed concerns that City Council should allow management to their job and that the City Council should remove themselves from this in the future for political reasons.

Motion to have City Management, Fire Chief and the City Attorney continue with their investigation as it relates to the actual cost to the city to backfill these shifts as well as to the allegations that Mr. Quijano brought up to see if there is any merit to that information and whether there is any misappropriation of CARES Act funds through the monetary contributions to the food banks that then outsourced the food distribution through the Fire Pac. In the interim, that the City Charter be enforced by all city employees and that City Management and the Fire Chief enforce the City Charter to make sure that no politicking is done by any fire union employee consistent with no politicking by any other city employee.
