#### Citizen comments

Joe Arciniega of the Alzheimers Association recognized Melissa Guerra, the recent recipient of the Jefferson Award for Volunteerism in the fight for an end to Alzheimer's disease. He noted that Patty Bruni chairs the walk to end Alzheimer's, which takes place this year on September 28, 2019, at Texas A&M International University. He reported that every 65 seconds, someone in the United States develops Alzheimer's disease; more than 5.8 million Americans currently live with the disease, and the number is expected to increase to 14 million by 2050. It is the sixth leading cause of death in the United States and the only one in the top 10 with no way to treat symptoms, slow progression, or cure the disease. Mr. Arciniega informed Council that Alzheimer's disease occurs in Hispanics at 1.5 times the rate of non-Hispanic white people and 35% more in women than men.

Patty Bruni stated that the Walk to End Alzheimer's is the largest event to raise awareness and funds for research and care support programs. In 2018, more than 65,000 teams participated in more than 600 walks across the country, raising more than \$95 million. In Laredo, more than 400 teams raised \$50,000 at the 2018 walk. She noted this year's goal to raise \$60,000 and more than 600 participants. The emcees for the Laredo walk will be Sean Elliott and his wife, Claudia Zapata Elliot. The money raised supports research to find a cure as well as programs in Laredo. She invited Council and the public to attend the walk, which will begin at 9:30 a.m. on Saturday,

September 28, 2019, at TAMIU. She encouraged the public to visit the group's Facebook page.

Mike Reeves of Heil of Texas thanked the City for past business with Heil; he noted that the organization is available to help the City with any future body-related needs.

Gabriel Lopez, veterans advocate, presented a letter to the Co-Interim City Managers regarding four main problems facing Laredo veterans: (1) homelessness; (2) poverty and hunger; (3) mental health issues; and (4) female veterans' issues. He asked for Council to work with the veterans to present a picture of Laredo veterans' circumstances on their legislative trips.

Orlando Navarro spoke in regards to the executive session item [#74] and explained that it is an imminent domain case in which land is being taken. The project has been extended for so long, it could be considered abusive to the landowner. He explained that the City presented an initial deal to the landowner, who honored it but has not received any money for two years. After discussion to mediate the issue, a price was negotiated; when the taxpayer agreed to the price, he was told that the offer was no longer available. The City reneged on its deal, and the landowner stands to lose his land and will have to close his business of selling tractors for tractor-trailers. He will have to plat the property. Mr. Navarro noted that the landowner is older with health issues and does not speak English; he asked Council to consider his circumstance while they are in executive session.

Roxanne Peña of LearnThink Media explained that the organization was designed to expand the Viva Laredo Comprehensive Plan. Over the last eight months, LearnThink Media has been working on using filmmaking to enhance arts and culture in the community. She also voiced her support of CultivArte, the Fine Arts & Culture Commission, and all arts/culture programs growing in Laredo.

#### VI. VETERAN RECOGNITION

a. Honoring Veteran of the Month Benigno G. Cepeda as a member of the United States Marine Corps and recognizing his distinguished service to our country.

Arturo Garcia, Community Development Director, introduced Benigno Cepeda, who joined the U.S. Marine Corps when he was 18 years old and underwent training at Marine Corps Recruiting Depot in San Diego, California. He served a total of four years from 1996-2000, including one overseas deployment to Okinawa, Japan. Mr. Cepeda's awards and decorations include the Navy Commendation Medal and Good Conduct Medal for his honorable service. He is currently employed with the U.S. Border Patrol for 13 years at the Laredo South Station. Mr. Garcia played a video presentation featuring Mr. Cepeda's family and military life.

Cm. Torres suggested that, without justification for STDC, the City split this money between Ruthe B. Cowl and El Metro. Mrs. San Miguel reminded Council that if they do not approve this recommendation, then the item must go back to

the Third Party Advisory Committee. Mr. Garcia clarified that Council can override the committee.

#### 76. GENERAL COUNCIL DISCUSSIONS AND PRESENTATIONS

#### A. Request by Mayor Pete Saenz

1. Requesting the status of the Traffic Light Synchronization Project with possible action.

Danny Magee, Traffic Director, reported that seven sections were identified as affordable roadway projects: FM 1472 (Mines Rd.), US Hwy. 83 (Zapata Hwy.), Bob Bullock Loop (Loop 20), McPherson Rd. State Hwy. 359, Business Interstate Hwy. 35, and I-35 frontage roads. The first five projects, with the exception of Hwy. 83, have been completed. The Hwy. 83 project is halfway

done and has not been completed because the consultant wanted to change the signals in that area. That is being completed this week.

Mayor Saenz asked if another 80 intersections could be planned for in the next fiscal year. Robert Eads, Co-Interim City Manager, noted that TxDOT received the bulk of the synchronization projects because most of the roadways completed are TxDOT roadways. There are 260 total intersections, but new projects would have to again come from Metropolitan Planning Organization (MPO) dollars or similar mechanism or through the General Fund, which staff would have to budget.

Cm. Altgelt requested an item on the next MPO agenda for this matter.

Mr. Magee reported that staff should be able to perform some of this work inhouse, but that will take a longer time to complete than what the consultant has been able to do. He noted that the intersection along Saunders was performed in-house and is beautifully-timed.

# D. Request by Council Member Dr. Marte A. Martinez

1. Discussion with possible action to incorporate 2% of net proceeds of any bonds or debt obligations from any city construction project to fund Laredo public arts and culture programs and any matters incident thereto.

Rosario Cabello, Co-Interim City Manager, asked for clarification on the bonds as worded on this item. She explained that bonds are strictly for brick-and-mortar projects, not programs.

Alyssa Cigarroa of CultivArte, a group of local artists, asked for Council's support in earmarking 2% of bonds or debt obligations to fund Laredo public arts and culture programs. She displayed photographs of the mural placed on Zaragoza Street and its warm receipt and improvement on impressions of Laredo. The mural is in line with the Viva Laredo Comprehensive Plan, which aims to make Laredo a destination celebrated for its contribution to the arts and culture. The Comprehensive Plan also recommends a public art ordinance to establish a set aside 2% from every Capital Improvement Project budget for the acquisition of art for municipal property. She displayed visual representations of public arts in other cities through a 2% earmark from capital improvement projects and/or bonds and obligations. One in 15 jobs in Texas are part of the creative sector, and Texas made \$350 million in 2017 state sales tax revenue from the arts and culture industry. While the average Texas city is making \$1.55 return on investment per capita, Laredo is only receiving an average of 23 cents

through the arts and culture industry. Ms. Cigarroa asked Council to approve this item and supports the local art industry in Laredo.

Regina Portillo of CultivArte confirmed that Ms. Cigarroa's reported facts are from a report of the Texas Cultural Trust compiled by the Texas Comptroller of Public Accounts and the Texas Demographic Center. Dedicating this 2% to public art is a significant opportunity for growth and increased sales tax revenue. Most of the metropolitan areas that have more dollars returned to local sales than Laredo dedicate some percentage of their budget to the arts. She explained that some cities have an ordinance that allow small projects, like a small parking lot, to save the earmarked funds for a larger installation.

Cm. Mercurio Martinez noted that this proposal is a great idea for the Canseco House project, which is very important to the community.

Cm. Altgelt confirmed that capital improvement funds are specific to brick-andmortar projects. Dr. Marte Martinez clarified his intention to model this plan after other municipalities in which a portion of the proceeds from any bond sale be dedicated to brick-and-mortar public arts. He noted that each individual construction project would carve out 2% for public art. He iterated the need for art in order to instill the "flair" that makes destination cities vibrant and attractive. The City must be showcased and window-dressed.

Cm. Torres stated his satisfaction with the idea, adding that he and Cm. Vielma initiated the Fine Arts & Culture Commission when they were first elected to Council. However, he asked if this matter wouldn't be better discussed next week during the budget workshop, as there is a long list of capital improvement projects that are pending funding. He reminded Council that most of his District Priority Funds are used for sidewalks; he asked how he is to incorporate 2% of art in sidewalks. Cm. Altgelt suggested painting the sidewalks. Cm. Torres countered that most, if not all, of the sidewalks he is improving or constructing are in residential areas. He would rather dedicate that 2% on each project for more improvements as that amount of money could improve multiple blocks of sidewalks. While he supported the idea and commends its merit, he voiced his concern over how to incorporate the idea into all of the City's projects where art installation may be difficult.

Mrs. Cabello agreed with the suggestion to discuss this matter during the budget workshop; she also suggested designating a percentage of the total amount of the bond rather than each individual project. Cm. Torres noted that Laredo is lagging behind the rest of the state in terms of infrastructure and other things that take priority, despite the fact that the arts are very important and needed in the community. He reminded Council to prioritize its needs, and the infrastructure in his district is needed and requested by his constituents. He voiced his concern of facing a 2% burden on his budget.

Cm. Vielma voiced her agreement with designating a percentage of the total bond that can be distributed to installing art throughout the entire City.

Ms. Portillo reported that the City of El Paso's public arts ordinances states: "Projects in the capital improvements program shall include an amount for works of art equal to 2% of the total funding available for the project, whether funded by general obligation bonds, revenue bonds, or certificates of obligation." Dr. Martinez noted his intention that the City of Laredo follow the same model.

Cm. Rodriguez noted that sidewalks can be imprinted artistically. He asked if Council could ensure that the artists are local in order to properly showcase Laredo's arts and culture. Kristina L. Hale, City Attorney, clarified that Council could not pass any action to that effect during this discussion. Cm. Altgelt noted that the City would still need to go through the procurement process.

Cm. Altgelt noted that when cities invest in art, they see dividends on their investments. Mayor Saenz asked staff and Council to think about where the City will see the most value in art installations in terms of visitors and visibility.

A member of CultivArte informed Council that shade installations could also be considered for art. Ms. Portillo reported that during the budget workshop, there will be an item under the Library Department for a public arts master plan. This plan will help the City determine its greatest potential for return on investment.

Mrs. Cabello reiterated staff's request to discuss this item at the budget workshop before taking any action.

Robert Eads, Co-Interim City Manager, reminded Council that if they are bonding for \$2 million and allocate \$400,000 to public art, then the City is actually only bonding out \$1.96 million for actual construction. He and Mrs. Cabello reminded Council that committing percentages of all projects means that there will be fewer repairs that can be made because less money is actually allocated to the construction.

Riazul Mia, Utilities Director, informed Council that the Manadas Creek treatment plant money is from TCEQ, who will not give the City money for art. He stated that installing vegetation is not art; Cm. Altgelt countered that landscaping can indeed be utilized artistically. He reminded Council that many of these cities allocating percentages for public arts do not own their own utilities.

Shellee Laurent, local artist, stated that art is vital to human existence. She encouraged Council to take this opportunity to beautify all of Laredo, not just a few districts. As a mother, she noted that her children play outside; by giving them something inspiring to see when they are engaged outside, children will be motivated to do more.

Steve Landin, Fire Chief and Emergency Management Coordinator, informed Council that some Departments' budgets depend on bond monies for equipment. The Fire Department alone will need \$2 million for ambulances and ladder trucks at the beginning of the fiscal year.

Cm. Torres asked staff to consider funding fine arts and culture through the Parks & Recreation Department during the budget workshop.

Motion to appropriate 2% from any eligible bond or debt obligation from any construction project to be used for public art projects, as amended.

Those cities' Fine Arts and Culture Commissions select a Poet Laureate, someone who captures the spirit of a city and is available for a certain time period for invocations, ribbon cuttings, and other ways to tell the story of the community through poetry. He noted that the distinguished poets in Laredo are through the Laredo Border Slam, and perhaps the most distinguished poet in town is Armando Lopez.

Armando Lopez stated that the Laredo Border Slam team has taken Laredo's voice to other areas of the country. Many local poets are well-known in the poetry community throughout Texas. He read from one of his own poem about leaving Laredo for a brief period of time and then returning with life lessons accumulated along the way. Mr. Lopez reminded Council that when Yo Yo Ma visited the border, he brought the spirit of Laredo out to the rest of the world.
