II. GENERAL COUNCIL DISCUSSIONS AND PRESENTATIONS

A. Request by Mayor Pro-Tempore Roberto Balli

 Discussion with possible action to host the Texas World Series Tournament to be held in Laredo with expected attendance of over twenty thousand people from ten different countries over the course of eight events; and any other matters incident thereto. (Co-Sponsored by Council Member Rudy Gonzalez, Jr.)

Jose Luis Maldonado, Texas World Series President, reported that the 2019 Texas World Series will be held in Laredo from February 20-24, 2020, after several qualifying tournaments from summer to winter 2019. The Texas World Series expects over 20,000 teams and guests from the Dominican Republic, Colombia, Ecuador, Japan, Venezuela, Panama, Mexico, Guatemala, Puerto Rico, and the United States. He estimated that the World Series will utilize 120 hotel rooms for five nights and requested \$51,000 to cover costs such as the hotel rooms, 250 rings, 40 baseball boxes, City of Laredo baseball fields, Marshal Parade costs, and a parade after-party. He reported the following qualifying events and their dates:

Aileen Ramos, Convention & Visitors Bureau Director, reported that this is the first time staff has seen Mr. Maldonado's presentation. She asked for time so that staff may meet with him and calculate the true financial need of the organization and what the City can provide. She noted that CVB staff worked with Mr. Maldonado earlier this year for a smaller event during the Washington's Birthday Celebration.

Graciela Briones, Assistant Parks & Leisure Services Director, confirmed that at the last World Series, the City utilized Slaughter Park, Cruz, Taylor, and Uni-Trade Stadium baseball fields for their events and ceremonies.

Cm. Gonzalez noted that there will not be another Council meeting before the June 28-30, 2019 event. MPT Balli asked what is needed for this first event. Mr. Maldonado answered that just the fields would be needed.

Dr. Marte Martinez initiated a motion to waive the fees for use of the City's fields during the District Baseball Tournament. Anita Stanley, Assistant Parks & Leisure Services Director, reminded Council that there are currently other leagues going on. She asked Council for time so that staff may review the schedule and identify the City's availability to accommodate Mr. Maldonado's schedule of events.

Dr. Martinez voiced his understanding that this schedule of events would be treated like separate events and asked if the funding would come from hotel/motel occupancy tax. MPT Balli clarified that some funding would come from this source, but some would come from Parks' budget. Ms. Ramos agreed that there are often multiple components to these events, which staff needs to analyze in order to determine appropriate funding or assistance. She confirmed that this schedule of events will encompass the next budget cycle as well.

Cm. Rodriguez added that the City already has dates set aside for events at Uni-Trade Stadium, so Mr. Maldonado's events cannot conflict with those already scheduled at the venue.

Robert Eads, Co-Interim City Manager, agreed that staff can meet with Mr. Maldonado and make sure that there are no scheduling conflicts with Mr. Maldonado's request. He reminded Council that rescheduling or not having a baseball game would result in a cost to the City.

Motion to waive the fees for use of the City baseball fields for the June 28-30, 2019, District Baseball Tournament and direct staff to meet with the Texas World Series and bring a proposal with scheduling and funding back to Council.
