SUPPLEMENTAL

I. RESOLUTIONS

1. 2018-R-58 Authorizing the City Manager to submit for technical assistance to the State Energy Conservation Office to determine the feasibility of developing a landfill gas to energy project. The goal is to determine whether or not it is economically feasible, and if the project is economically feasible, which would be the best alternative for the derived landfill gas, such as production of electricity or other possible uses.

Stephen Geiss, Solid Waste Services Director, explained that this item relates to a request being submitted to the State Energy Conservation Office for technical assistance. The SECO does not charge for the accessory and technical assistance services. The City has a small landfill gas collection system, but it is only for mitigation use and not for beneficial use.

CY Benavides III stated that the City is currently struggling with air quality in Laredo and fumigating the citizens. The current practice is not consistent and reactive. He voiced his opinion that this item is not a sufficient solution and needs more review. He invited Council to a public meeting at TAMIU on May 1, 2018, to discuss the Pescadito landfill.

Mr. Geiss argued that the City is not fumigating the City with natural gas. The gas output is monitored at all times via computer systems with warnings and remediation in place, which results in no gas escaping into the atmosphere. He noted that Mr. Benavides' comment to the contrary is a mischaracterization of the landfill.

Horacio De Leon, City Manager, explained that this resolution is to determine the feasibility of selling the City's landfill gas for energy conversion.

Diaz, Original Grantee, Abstract 546, Webb, County, Texas. Funding is available under Community Development Block Grant funds.

Arturo Garcia, Community Development Director, explained that this is a designated CDBG project and entails the acquisition of a property. The property has been federally appraised.
