Juan Avila noted that signs were previously brought into Council Chambers, but recently he was prevented from bringing them in.

Kristina L. Hale, Acting City Secretary, clarified that there is no ordinance prohibiting signs from Council Chambers and that the chair has the discretion to determine whether signs are a distraction. Mayor Pro-Tempore Perez allowed signs to be displayed during the relevant agenda discussion.

Mr. Avila noted that Senate Bill 4 is crucial to the people of Laredo. Council should strongly consider the best interest of the citizens of Laredo. He asked Council to make the right choice during their vote and claimed that Mayor Saenz was absent in order to avoid this topic.

Jesus Flores recalled past incidents in which U.S. Customs & Border Protection or Homeland Security arrested individuals crossing the border illegally who had been charged with violent crimes or had ties to the Mexican mafia. He read a portion of the Laredo Code of Ethics prohibiting City officials or employees from inducing others to engage in activity relating to a particular party. However, a Democratic Chair and a former Democratic Chair sit on Council currently. Cm. Vielma is an immigration attorney. These Council Members have a conflict of interest regarding the Senate Bill on today's agenda.

Orlando Navarro of the Laredo PONY League invited the public to attend the PONY League World Series starting Tuesday, July 18, 2017. Over 90 teams will participate in the World Series event. He thanked City staff for their support and collaboration for this event.

Leticia Lamar Botello of Our Laredo played a video presentation from Our Laredo inviting the public to a presentation on July 22, 2017, at the Holding Institute at 5:30 p.m.

Francisco Castillo stated that the water park proposal is impressive and long overdue. He also voiced his support of Council joining the lawsuit related to Senate Bill 4. He asked Council to put politics aside and join the people in fighting SB-4. Mr. Castillo also promoted the apprenticeship program and reminded Council that this week is Probation and Parole Week, commending the work of probation and parole officers.

The FY2017-2018 proposed budget document reflects the City's priorities and commitment to its citizens to ensure that essential City programs and services are efficiently and effectively maintained and that opportunities for growth and development are duly The FY2017-2018 proposed consolidated annual budget \$647,565,137.00, an increase of 4.4% from last year. The total net operating budget, excluding operating transfers, is \$501,177,099.00, with a closing fund balance projecting at \$196,056,309.00. The City's property tax rate, for the 14th year in a row, remains unchanged. City management will strive to implement a new work ideology that promotes greater efficiency through the use and sharing of data and technology and the development of partnerships. Employees will be expected to become more productive by working smarter. Also, emphasis will be placed on promoting transparency and accountability. The City will implement a results-driven management philosophy that takes on the challenge to effectively utilize data and technology to evaluate performance and programs and ultimately improve services and a culture of transparency and accountability. Similarly, maintaining fiscal responsibility will be critical. The proposed FY2017-2018 budget includes adjustments to user fees and bridge tolls, and efforts to leverage resources will be implemented.

Mr. De Leon confirmed that the budget workshops will take place August 14-16, 2017.

There was no change in scope of the service. The contractor filled out all paperwork as required. The recommended low bidder did visit the site. There was a lot of local competition. Mr. Pescador noted that all bids seemed to be in order and recommended Romo Contractors. Romo was at the pre-bid and visited the site to ensure they could perform the work. He voiced his opinion that it is a proper bid.

Mr. Benavides clarified that the bidders visited the site after the bid was opened, which is not in line with the procurement process.

Cm. Balli asked if the City is not going to follow its procurement process, then why have a process in place. It makes the City look bad to award bids to vendors who did not follow the procurement policy.

Mr. Pescador clarified that all matters were addressed and that staff is comfortable recommending Romo Contractors. The addendum issued was only issued as a deadline extension; the scope of the work was not changed. A. Request by Council Member Roberto Balli

 Discussion with possible action for the City of Laredo to intervene in the lawsuit involving Senate Bill 4 as a plaintiff joining the City of El Cenizo and LULAC vs. the State of Texas. (Co-Sponsored by Mayor Pro-Tempore Alejandro "Alex" Perez, Council Member Alberto Torres, Jr. and Council Member Nelly Vielma)

Cm. Balli noted that he has tried repeatedly for the past month to bring this item before Council. The Mayor has been traveling to New York and Cancun and has refused to be a part of a Special Council Meeting.

Cm. Altgelt noted that while the Mayor is out of town, he has made efforts to partake in this discussion. He also iterated that the Mayor is traveling on behalf of the City and not for leisure. While the Mayor does not have a vote, he has made efforts to make comments on the record at this meeting, and Council should extend the professional courtesy to allow for them rather than criticizing his absence.

Raul Reyes, Mayor of the City of El Cenizo, Texas, and President of LULAC #12, noted that hatred and division is prominent in the nation, trickling down to communities in Texas. Senate Bill 4 is a reckless and dangerous bill, and larger Texas municipalities with more federal and state funding to lose have joined the lawsuit as plaintiffs. No dollar amount is more important than standing up for the rights of the people. He reminded Council that if SB-4 goes into effect and Laredo police officers engage in immigration operations, the Police Chief will no longer have control in reprimanding the officers. City Council will no longer be allowed to speak out against this law. He asked Council Members opposed to joining the lawsuit to reexamine the stakes. Council should consider that this bill will disrupt families of mixed citizenship, particularly separating parents from their children.

Cm. Balli stated that Laredo has never been a sanctuary city, but Laredo law enforcement has never been instructed to target illegal immigrants. He noted the potential for Laredoans, who do not experience much racial discrimination in town, to experience it when they travel out of town.

Ricardo De Anda informed Council that if the City joins El Cenizo in this lawsuit,

the City will not be charged any legal fees or expenses. He confirmed that there is no deadline or population size limit for the City to join the lawsuit. However, the City should take action as soon as possible. He could not confirm whether the City of Laredo could be negatively affected by joining the lawsuit. There are multiple avenues in which the City could join the lawsuit, and the attorneys on the suit can advise the City on the best option. The rights at issue are: the first amendment right to speak, the right of the police chief or sheriff to direct his or her officers without risking fines or imprisonment, the fourth amendment protection of unlawful search or seizure or detainment for not carrying identification, the sovereignty of the state and freedom of interference. He confirmed that the thrust of the lawsuit is to overturn as much of this law as possible, if not completely.

Mayor Betty Flores, former Laredo Mayor, voiced her personal opinion that Senate Bill 4 is premature as the United States should fix its broken immigration laws. As the Economic Vitality Committee Chair, Mayor Flores has been instructed by the Laredo Main Street Board of Directors to specify the economic concerns of Laredo's Downtown sector as a vibrant part of the community. Business owners are concerned that the discriminatory nature of SB-4 and its targeting of Laredo's Mexican shoppers will bring disrepute to Texas and dissuade Mexican consumers from visiting Laredo. Municipalities in the Valley are taking action via Mexican shoppers boycotting Texas vendors and businesses unless they litigate against SB-4. Mayor Flores voiced her opinion that this bill is the worst economic threat to Laredo. She asked Council to consider the economic effects on the City by SB-4 and to take a stand that welcomes Mexican shoppers and protects the financial interests of the City.

Cm. Altgelt noted that an additional problem with this bill is that it forces the City of Laredo to perform unfunded immigration investigations.

Mr. De Anda continued that the City would be a client of the attorneys of the ACLU, much like any other attorney-client relationship. If the client has a cause of action with a particular intention, the attorneys would pursue that claim or intention.

Mayor Pete Saenz, via teleconference from New York, apologized for his absence as he was needed in other engagements out of town. He voiced his opinion that the City must consider the lasting impact of this bill on Laredo. His interpretation of this lawsuit would turn Laredo into a sanctuary city. While the bill has issues, there are many risks to being considered a sanctuary city. He recommended an approach in the middle of the road, such as a resolution.

Cm. Altgelt confirmed that Laredo is not a sanctuary city; SB-4 is merely a symptom of the larger problem of Congress not confronting immigration reform. The unfunded mandate of cities to perform immigration patrol is another issue. He recalled an incident in court in which an opposing attorney knew that a witness was not a United States citizen and attempted to have him detained and delivered to immigration officers. That attorney was told that the federal courthouse is a sanctuary for victims and witnesses to come forward and provide truthful testimony without fear of punishment or detainment. Cm. Altgelt encouraged Council to listen to conscience and vote to join the lawsuit.

Cm. Torres stated that he has no conflict of interest on this issue even though he is the Democratic Party Chair because he has a duty to the rights of his constituents. He will not vote to become a sanctuary city, and while he hopes that this lawsuit is successful against SB-4, if it fails then Laredo has no choice but to be a law-abiding city. This law will affect Laredo more than Texas cities farther north. Critics of this lawsuit condemned Council for using taxpayer dollars to fund a lawsuit, but Council was informed by Mr. De Anda that the City will not have to pay for their participation in the suit.

Kristina L. Hale, Acting City Attorney, noted that the City contacted the Mexican American Legal Defense and Education Fund as well as the ACLU of Texas, both of which informed Mrs. Hale that they could not represent the City of Laredo at the preliminary injunction stage and recommended that the City file an amicus brief, which is a brief in support of the plaintiff's position.

Cm. San Miguel stated that when the Senate bill first came out of legislative session, no Council Member attempted to put it on the Council agenda. Now that it has passed, there are criticisms of delays in discussion due to the Mayor's schedule. Sanctuary cities essentially are ones that do not enforce the law; no member of Council agrees to become a sanctuary city.

Mr. De Anda clarified that this bill makes it legal for law enforcement officers to detain a witness or victim of a crime and ask them for proof of their immigration status. This bill does not protect victims of crime but places them at greater risks. He also clarified that a sanctuary city does mean that the city will not enforce the law. The term is a political expression meant to demonize localities that care about the sanctuary of courts, hospitals, and political agencies. There is no legal definition of a sanctuary city; it is a political term meant to be whatever the political figure wants it to be.

Cm. Vielma noted that she also does not have a conflict of interest as staying out of this issue could prove more advantageous to her business. She has witnessed terrible instances in which victims of crimes lose trust in law enforcement because of their immigration status. The bill exempts churches that employ off-duty officers, schools, hospitals, federal health and community centers, and mental health centers. Women and children are particularly at risk of further victimization due to this bill. Cm. Vielma voiced her concern about racial profiling and discrimination and safety risks as minorities reach for identification. Wrongful deportation is also a major problem. For local law enforcement to enforce federal immigration law is equivalent to commandeering.

Cm. Gonzalez stated that as a law enforcement officer, he is in opposition to the bill.

Cm. Rodriguez emphasized that he will vote to protect families and residents in Laredo.

Sister Rosemary Welch of Sisters of Mercy noted that the organization works very closely with law enforcement. However, since the introduction of SB-4, the shelter has seen a dramatic decrease in the number of individuals who want a police escort to the shelter. The shelter has received a significant number of calls from victims saying that they are in danger and need help but can not call police

because the police will call immigration. Once they arrive at the shelter, they feel safer talking to law enforcement. Sister Rosemary confirmed that the bill does not protect shelters for victims of domestic abuse.

Israel Reyna stated that SB-4 is one in which he would practice civil disobedience should it pass. He voiced his opinion that it should not be the duty of a police officer stopping someone for jaywalking to ask them for proof of their citizenship. This law is divisive and will encourage further criminalization or discrimination against undocumented residents and workers. He discouraged Council from watching the developments from the sidelines.

Graciela Villarreal voiced her gratitude that Council would not have to be convinced to join the lawsuit. She noted that she was once an illegal immigrant at the Sisters of Mercy shelter and fears the same or worse conditions for other women in Laredo if SB-4 passes.

Seven Flores reiterated that Council should join the lawsuit and oppose the bill. He noted that Cm. San Miguel showed his ignorance of the bill's ramifications or basic terminology.

Pablo Castillo stated that if Council opposes SB-4, then they are helping criminals. He recalled an incident where he was struck by a vehicle while walking to his car. The driver of that vehicle did not have identification, insurance, or vehicle registration. Mr. Castillo was taken to the hospital via ambulance and was disappointed that law enforcement did not call Border Patrol. If SB-4 had existed, his issue would have been handled differently. Laws exist for our protection, and he asked Council not to join the lawsuit against Senate Bill 4.

Mellie Hereford asked why this discussion is taking place, especially since Laredo is not a sanctuary city. She encouraged Council to host an educational workshop about this bill as many Council Members clearly do not understand the bill or know what a sanctuary city is.

Oscar Lopez noted his disappointed that state government would consider Senate Bill 4 a solution to the nation's immigration problems. He knows many people who, while they are in the process of renewing visas, are at risk of being deported or having their families separated. He urged Council to join the lawsuit.

Jesus Ochoa stated that SB-4 equates to hate and racism. Hispanics are not the only residents of Texas that are undocumented. Undocumented Canadians, Europeans, Asians, Africans, and people of other nationalities all live in Texas currently; however, those nationalities were not in mind when Senate Bill 4 was drafted, approved, and signed. This bill is rooted in racism and discrimination. Thousands of families will be affected by this bill, including innocent young people brought to this country by parents and not through their own decision. Mr. Ochoa asked why Laredo, a border city, has not taken action until now.

Karina Alvarez, a teacher in low-income communities, noted that she is already seeing detrimental effects of this bill before it is even enacted. Children are having conversations with their parents about their fears of deportation or school absences. Ms. Alvarez noted that children are being taught to fear law enforcement officers, which is a shame. This bill threatens families of mixed

status.

C. Request by Council Member Alberto Torres, Jr.

Cm. Torres noted that he was shocked to learn about over \$8.4 million of outstanding citations, equivalent to 31,000 outstanding warrants Laredo. This money is revenue for the City which has gone unrecovered. Judge Rosie Cuellar had conveyed to him that she needs warrant officers to help recover citation fees or resolve warrants.

Rosie Cuellar, Municipal Court Judge, asked for Council's support on this item. As of January 2017, the municipal court has only one clerk dedicated to issuing warrants. To-date, that amounts to \$2.7 million. Judge Cuellar noted that Laredo PD had warrant officers assigned to municipal court for this purpose. The court has a bailiff position unfilled for the past four years; Judge Cuellar asked Council to consider assigning an officer to fill that purpose. Assigning current LPD officers to serve as warrant officers on a temporary basis would also be welcome.

Cm. Altgelt suggested funding the bailiff position already posted and providing an armed security guard to handle court security, freeing up the two PD officers for warrant execution. He clarified that the two officers or their positions would be

permanently assigned to warrant execution.

Claudio Treviño, Laredo Police Chief, voiced his agreement with Cm. Altgelt's suggestion, though he noted that the Police Department does not have the manpower to provide more than two warrant officers.

Cm. Torres stated that Council can start with one permanent team of two warrant officers and review funds during the budget process to consider adding another team of two warrant officers.

Cm. Balli cautioned that there would be some complications to consider when hiring non-police officers, like motor vehicles, staffing, and related matters. Chief Treviño agreed that using police officers rather than non-police staff would avoid complications.

Motion to hire a court armed guard for the purposes of court security, a bailiff, and reassign the two police officers currently serving in the Municipal Court to execute warrants, as amended.
