V. COMMUNICATIONS AND RECOGNITIONS

Communiqués

a. Presentation by the Domestic Violence Coalition on the *Human Rights Initiative* and invitation to their upcoming events.

Sister Rosemary Walsh reported that they were known statewide for one of the longest coalitions that had gone on for nineteen years. She added that they sponsored an annual domestic violence conference and explained that on October 1, 2015, they would host their nineteenth conference. She concluded that they were proclaiming October as domestic violence month and invited them to their proclamation this Friday at 10:00 am at the Webb County Courthouse in the central jury room.

b. Presentation by the Texas Department of State Health Services Texas Healthy Communities Program to recognize the City of Laredo with the Silver Medal Award for promoting a Healthier and Active Living City.

Health Department Director Dr. Hector Gonzalez reported that they had representatives from the Texas Department of State Health Services present to give recognition to the City of Laredo.

Nora Martinez and Cecily Brea reported on the assessment and explained that the City of Laredo was graded on access to physical activity, healthy foods, healthy schools, healthy worksites, mother-friendly worksites, tobacco control, cardiac and stroke response, and healthcare quality. She concluded by saying that the City of Laredo had achieved the Silver Medal level and so it had been approved for a continuation of funding for this project through 2016.

Recognitions

a. Recognizing Rudy Flores for repeating as World Champion at the Power Lifting Competition held in Prague, Czech Republic.

Mayor Saenz and City Council congratulated Rudy Flores for repeating as World Champion at the Power Lifting Competition held in Prague, Czech Republic and presented him with a certificate of recognition.

b. Recognizing the Elysian Social Club for being in existence for 75 years.

Mayor Saenz and City Council congratulated Elysian Social Club for being in existence for 75 years and presented them with a certificate of recognition.

Citizen comments

Raul Moreno from GSA reported that the project involved the Juarez-Lincoln port of entry and Convent, although Convent was still unfunded. However, Congressman Cuellar had stated that he would press for that funding. He added that the objective was to make the transport and passage of people, buses, and cars quicker, safer and more comfortable. He further stated that 20% of people who enter the United States by bus do so in Laredo. He explained that in 2014, 3.4 million pedestrians crossed at Convent; 5.2 million automobiles crossed there; and a total of 10.3 million automobile passengers, 41,000 buses and over 1 million bus passengers came into Laredo through these two ports. He said that the general contractor would be starting the mobilization within the next two weeks and working on buildings six and four. He concluded by saying that Phase 2 would begin sometime in December of this year, which was the west canopy.

Armando Cisneros thanked the City of Laredo for its response to his open records request. He also spoke on the poverty rate in Laredo and explained his concerns that water and garbage rates were going up, and also their appraisals.

Mr. Juan Fugua spoke on the issue of minimum wage, which in Laredo is \$7.50.

Viviana Frank and Mario Peña reported that they had been working on an project with TAMIU and AIA of Laredo and invited Council and staff to the November 16, 2015 lecture series at TAMIU by author Jeff Speck. He added that the event is called Walkable City – How downtown can save America one step at a time.

Luis Cisneros stated that at the last city workshop, Solid Waste Director Steve Geiss said that the four months when the city managed the recycling center was the only time when the city made money. He questioned why, if this was the case, the city chose to go out for requests for proposals to find an operator for the center and furthermore did not choose the lowest bidder.

Mr. Vish spoke on the recycling center and asked that Council look at the figures.

He added that they were working together with the Health Department as some of these resources could be provided by the state.

Cm. Balli said that recently, the Department of Justice issued a memorandum saying that cities were criminalizing homelessness and were in violation of the constitution. He added that they needed to be careful. He further stated that there were some facilities in town such as the Barbara Kazen Center for Hope, the Salvation Army, Casa de Misericordia, and Bill Collier at his hotel.
