This tax rate, which has been the same since Tax Year 2004, will have a Maintenance and Operation Rate of \$0.493751 per \$100 value and a Interest and Sinking Fund Rate of \$0.143249 per \$100 value for the levy and the collection of General and Special Ad Valorem taxes for the City of Laredo for Tax Year 2015 and Fiscal Year 2015-2016. (This will be the twelfth year that the City would adopt this same rate.)
