20. Staff report on the extent to which City of Laredo may permit, regulate, police, or ban circuses from using animals as part of their entertainment programs while in Laredo's corporate city limits.

Destiny Lerma stated that she is in support of Laredo Amigos Liberating Animals and banning the use of animals at the circus. She added that out of 14,000 people that attended, the circus only donated \$800 to the Shriners Hospital. She explained that Laredo Amigos Liberating Animals' plan was making an annual fundraiser in which 100% of the proceeds would go to the Shriners' Children's Hospital. She went on to say that in less than one week, they had already collected \$1,000 and donated it to the Shriners' Hospital in Galveston, Texas.

Christine Guajardo stated that she had a letter from a former Shriner in Billings, Montana directed to Russell J. Stoddard. He had resigned from the Shriners based on their involvement in circuses.

City Attorney Raul Casso reported that under state and federal government law, circuses were legal forms of entertainment. He explained that the Federal Animal Welfare Act was passed in the 1960's and the Shriners were regulated under that act. Congress found that these activities substantially affected interstate commerce and so were preempted. He went on to state that if they were to pass a ban that would go further than state or federal law, then they would be in conflict with those laws. Therefore, they could not ban a circus; it was beyond their scope; however, they could police them by enforcing the ordinances already on the books. He mentioned the permit that cost \$200 and the inspections through the health department.

City Manager Carlos Villarreal recommended that they table this item.
