### IV. MOTION

1. Discussion and possible action to approve a Memorandum of Understanding between the City of Laredo and Laredo Baseball Investors, L.L.C., for the transition and transfer of ownership of the Laredo Lemurs; the membership in the American Association of Independent Professional Baseball; and, the assignment of the Operations and Lease Agreement and Development Agreement to Laredo Baseball Holdings, Inc., and authorizing the issuance of a Letter of Credit to the American Association of Independent Professional Baseball to facilitate the transfer and preserve the Lemur's status with the American Association and any matters incident thereto.

Parts of the memorandum of understanding read by Assistant City Manager

Jesus Olivares stated that it was to issue the letter of credit that would preserve the integrity of the Lemurs and their membership in the American Association of Baseball; to assign the operations and the agreement of the stadium to the new investors and work out all those details; and to be able to preserve the status of the professional baseball team that we currently have here in the City of Laredo. He added that Pete Incaviglia had signed a three-year contract to be extended, which was very important. He went on to say it would allow them to develop new marketing techniques to bring back to Mayor and Council and expand the use of the stadium to include other events.

City Manager Carlos Villarreal stated that it gave a lease term, rent, marketing, the City's obligations, operational costs related to the stadium, approval and audit, other city events, and operations and lease agreement and development agreement; he added that it was pretty technical about what they could and could not do and indicated taking into consideration that all the agreements in place right now would be honored. He concluded that they only way they could proceed was to call the letter of credit to be used by a 380 agreement that they would bring back for ratification at Monday's City Council meeting and that by that time, they would have the letter of credit already signed by the people involved with the new investors.
