Mercurio Martinez, III, past president of the Laredo Association of Realtors and member of the Government Affairs Committee, stated that the development group has been meeting with Tricia Cortez and her group for the past several years. Several members of the Association of Realtors were in attendance in support of this project for several reasons. First, the developer is willing to work with the conservation group in order to protect a majority of the area because of its beauty. Second, this development will bring economic growth to this area of the City.

Tricia Cortez spoke on behalf of the Rio Grande International Studies Center the wetlands and the residents of Laredo. She requested that this ordinance be tabled until a happy medium could be reached that would benefit the developers, the City and the members of the community. She also stated that there must be certain safeguards written into the contract of sale that would protect the survival of the wetlands should the property be transferred to other private owners in the future.

Onyx Benavides, chair for the Laredo Association of Political Affairs Committee, appeared in support of this ordinance. He and his group have met with both the developer and the conservation group, they have made suggestions that would maintain the aesthetics of the area and still allow for the economic benefit that will come from the development of this land, and have received a verbal agreement from the developer to meet the goals of the conservation group to the best of his ability.

Armando Cisneros requested that it be tabled because the information presented in the agenda item and on the agenda is incorrect. He also stated that during the March 19, 2007 council meeting this item was tabled, not approved, another discrepancy in the information presented. Mr. Cisneros also pointed out that, according to appraisal information presented, the land in question has not changed in value over the last 9 years, which seems like a discrepancy. For these reasons, he felt that this ordinance should be tabled.

Miguel Conchas, Chamber of Commerce, reported that his group is in favor for this ordinance to proceed. In 2007-2008, the Board of Directors of the Chamber of Commerce passed a resolution in favor of this development and support of which was reaffirmed in the past week at a meeting of the Board of Directors. He urged the Council to support anything that will encourage development and boost jobs, to continue the economic upturn in Laredo.

Elsa Rodriguez Arguindegui hoped that the Council would table this item. She also asked for some clarification on what work will be taking place. There was a misunderstanding as to the extent of the work.

Creston Jackson, of Jackson Real Estate, reported that he was aware of this project back in 2008 when it was first being worked on. He wanted to reassure the environmental group that the developer is willing to work with them on preserving the wetlands and is keeping the door open for continued cooperation between himself and the environmentalists.

Cordelia Casso Flores stated that the City Council will stand with the 13,000 members of the community that signed a petition to preserve the wetlands and table the ordinance. She has lamented the loss of so many historical landmarks that have been destroyed by new development that does nothing to improve the City.

Riazul Mia, Environmental Services Director, reported that the existing retention pond was built in 1997, but never maintained; therefore, this pond serves no purpose for the City or the Airport. The 404 permit protects the wet land area. because of the nature of the lease, the property lessor is allowed to begin construction at any time. Mr. Mia gave a presentation on the relocation of the current retention pond and the extent of the work to be performed. The Army Corps of Engineers has approved the relocation of the retention pond, which will be deeper and will allow for the re-creation of the wetlands.

Definition of Wetland

 As per the Clean Water Act and the City's Storm water Management Ordinance:

" areas that are inundated or saturated by surface or groundwater at a frequency and duration sufficient to support, and that under normal circumstances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions. Wetlands generally include swamps, marshes, bogs and similar areas."

Laredo Town Center Wetlands Fact Sheet

- Laredo Town Center, L.P. obtained a Section 404 permit with the US Army Corps of Engineers on June 23, 2008.
- According to the Mitigation Plan as submitted to the Corps a small portion of the existing intermittent stream (approximately 708 linear feet or 0.24 acres), a 3.2 acre man-made detention pond, and approximately 0.35 acre emergent wetland will be impacted. The total impact to waters of the US is 3.79 acres.
- The development will not impact approximately 650 feet of existing intermittent stream, including approximately 7 acres of upland buffer area.
- The mitigation plan also calls for the conservation of over 44 acres of property just east and north of the 89 acres. An existing wetland and several streams will be preserved in perpetuity.
- Project received the TCEQ-section 401- water quality certification in June 2, 2008

Storm water Filtration System

- Storm water filters is constructed within the development to filter pollutants and trash entering the stream.
- Airport's "stormceptor" at the west side of Loop 20 prevents any spill going to the pond.

The existing pond as been determined to contain:

- Surface area of 2.30 acres
- Volume of 302,250 cubic feet.

The proposed pond has been designed to contain:

- Surface area of 3.00 acres
- Volume of 1,633,608* cubic feet

* This does not include 279,704 cubic feet of constant storage of water in pond.

Steve Whitworth, attorney for Laredo Town Center Ltd., the development company, stated that the developer went to great effort under the scrutiny of the public light to arrive at a plan that is both economically and environmentally responsible. He has waited five to six years to start this project and is willing to continue to listen and work with the environmental groups going forward, provided he does not have to start over again and lose more time and provided that economic considerations enter into the equation. There is some delinquent rent that will be caught up as well in the sale price.

XII. GENERAL COUNCIL DISCUSSIONS AND PRESENTATIONS

- 23. A. Request by Mayor Raul G. Salinas
 - 1. Report from the Drug and Alcohol Committee regarding DWI/DUI arrests, with possible action.

Romero Rodriguez, Chairperson for the Drug and Alcohol Committee, stated that their focus is to create awareness of the policies, programs and services available to serve youth, adults and families in need of alcohol, drug abuse prevention, intervention and treatment enforcement. Their goal is to ensure close cooperation between all of the groups assigned to this Commission; inform City Council when members need to be replaced; create a strategic plan to prioritize initiatives, close gaps and to assist with grant funding; create a forum for the City of Laredo; and to work closely with schools.

Interim Police Chief Navarro presented a comparison between 2011 and 2012 and discussed the increase in DWI arrests by season, month, week, geographic area, age and gender.

2. Status of the committee for the naming of streets and/or buildings after Laredo war and first-responder heroes, with possible action.

Mayor Salinas stated that he wants to emphasize the importance of naming the importance of recognizing war and first-responder heroes.

Carlos Villarreal, City Manager, stated that maybe members of the Veterans Committee can address this issue along with members of Planning and Zoning and Nathan Bratton.

Nathan Bratton reported that a survey of all monuments named after service heroes has been completed and a list has been provided to each Council member, along with a list of service men and women. A letter has also been drafted to development professionals encouraging them to participate with the City initiative when considering the naming of subdivisions and streets, along with the list of Laredo's fallen heroes. He wanted to work with the Veterans Committee to ensure there are no discrepancies on the list of hero's names so no one is left out. Finally, he suggested putting a decal identifying the branch of service on each street sign for streets named after each individual.

B. Request by Council Member Esteban Rangel

1. Recognizing Frank Architects Inc., on their award of second prize on the 2012 GREEN DOT AWARDS for their entry of the City of Laredo James and Maria Luisa Haynes Health and Wellness Center. The architects were selected from thousands of entries from over 25 countries and will be showcased with other winners at the International Design Awards Gala in May in Los Angeles, California.

Cm. Rangel stated that it is sad that there was all the controversy earlier over the wetlands and going green, and yet the architects of the Haynes Health and Wellness Center received an award for going green. He thanked the Mayor, the current Council, prior Council members and the City Manager for working towards building a green facility. He recognized former Council member Tito Garcia, Frank Architects, Inc. and various members of the city staff for making the construction of a green building possible.

2. Status report regarding the request for 100 acres for a sports venue/complex, with possible action.

Carlos Villarreal, City Manager, reported that a sale of the Civic Center must be finalized before action can be taken on a sports venue complex. The City must ensure that there will be capital available to finance the construction of a sports venue complex. It may be possible to come back to Council by mid to late March and discuss the possibility of this complex. He agreed to direct staff to focus on finding land to be donated for a sports complex, the requirements of the owner in exchange for the donation of land, infrastructure and utilities requirements.

City Attorney stated that before you can adopt guidelines, you must first adopt a resolution that must include a number of findings, some of which must be consistent with the tax code. Before the resolution can be adopted, a study must be completed to ensure that the area satisfies the requirements of the tax code.

Carlos Villarreal, City Manager, stated that what is required is that first the area must be considered a blighted area. Staff will have a list of recommendations available in two days and Council needs to ensure that they meet with the Economic Development Committee to proceed.

Cm. Perez asked that staff get going on this. He directed the City Manager to renegotiate the contract of the consultant so that he can begin work on this project as well.

2. Discussion with possible action for City staff with trucks to pick up tires along City right of ways or on streets.

Carlos Villarreal, City Manager, stated that currently the City does not have a program to pick up tires along City right of ways or on streets and that he does not recommend the Council enact such a program. Instead, he recommends that the City enact a program that pays individuals, per tire, to turn in used tires monthly. He will instruct staff to take a look at certain areas to provide a short-term remedy, but, in the long run, he recommends establishing a monthly tire cleanup campaign.

- D. Request by Council Member Roque Vela, Jr.
 - 1. Discussion with possible action on changing the minimum distance requirements from schools when requesting a liquor license to be consistent with those required by TABC guidelines.

Cm. Vela stated that currently the requirement from the City is 300 ft. where TABC requires 1,000 ft. Cm. Vela feels that, as the city

continues to grow, it is important to set the minimum requirements now to provide for the safety of our schools.

Nathan Bratton stated that under the City requirements, the 300ft. requirement is from the boundary line of the residential district, but under TABC, the requirement is door-to-door, in the most direct route.

Jose Botello stated that Citizens for a Better Neighborhood is trying to get information to the City Council to encourage it to support the increase in minimum distance. He also stated that Council has information concerning the minimum distance requirements of TABC, and that establishment and enforcement of the minimum distance rests with the City. He would like this minimum distance of 1,000 ft. to become a City wide requirement.
